Expediente Público looks at one aspect of the crisis of the Honduran penitentiary system, its overpopulation - the 28 prisons are 400% overpopulated - and zooms in on one group of inmates, small-scale drug vendors. According to Expediente Público, the arrests increased by 222% since 2010, but the effect is rather superficial (e.g. the presentation of the arrested men and the seized goods in press photos), while drug trafficking constantly reorganizes itself and "homicides linked to it don't stop".

On Saturday, it was made public that the JOH regime ordered the arrest of 18 human rights defenders in Guapinol, Colón, criminalizing their peaceful resistance to a mining project by Inversiones Los Pinares, a company which belongs to Lenir Pérez. Radio Progreso highlights an important detail of these arrest warrants. They were emitted by a court with national jurisdiction which had initially been created to fight

organized crime. These courts work together with Fusina and rely heavily on the Armed Forces for detentions and investigations. The Coalition against Impunity condemns this new level of criminalization.

COPINH denounces Tuesday's attack against HRDs at MILPAH and MADJ (see yesterday). They link it with Tuesday's arrest of police commissioner Lorgio Oquelí Mejía Tinoco, who was the head of the human rights office at the Security Secretariat (see also yesterday). According to COPINH, this reflects well the state of human rights in Honduras and the lack of defense for HRDs.

Yesterday, there was uncertainty about Mejía Tinoco's position, some media outlets wrote that he is a sub-commissioner others wrote he is a commissioner. He was was a sub-commissioner when the purging committee investigated him and others in 2016. He and 66 others were certified by the commission and this year he was promoted to the position of a commissioner. ConexiHon published a great overview of the case against him. Defensores en Línea rightly asks "in whose hands is the security of HRDs?" And the failure to purge him led to renewed criticism of the purging commission.

El Heraldo reports that Mejía Tinoco is now also being investigated for links to drug traffickers.

The only judge that was not dismissed was Óscar Chinchilla, who was later made Attorney General by JOH and who was illegally reelected in that position last this year.

Almost a month ago, the trial in the murder case of Berta Cáceres and the attempted murder of Gustavo Castro started, but for only a few minutes. The Honduran judicial system failed to comply with the law and decide on legal challenges presented by COPINH and Berta's family in the following 72 hours. Now, with the main challenge against the sitting judges still unresolved - they are accused of being "partial, leaving defendants and defendants defenseless, violating due process" - a new trial date has been set for this morning at 9am.

The JOH regime insinuates that the migrants are pawns of the political opposition. This may be a reaction to an OpEd by Salvador Nasralla, presenting the caravan as a reaction to the failures of the JOH regime.

But also the head of the National Anti-Corruption Council (CNA), Gabriela Castellanos, tweeted that the migrants are partly motivated by the corruption reigning in Honduras. CONADEH asked the UNHCR and the Red Cross for support. The Pastoral Group on Human Mobility also asked for accompaniment and humanitarian assistance for the migrants.

When the trial had initially been reset for yesterday, US chargé d'affaires Heide Fulton and the US embassy "continue to call for free, fair, and transparent legal processes grounded in due process and respect for the rule of law" ignoring that under the current circumstances and with the open legal complaints, this would have been an impossibility.

He had been accompanying the caravan from the beginning and has been the target of a vicious attack by the media and the JOH regime falsely accusing him of having organized the caravan (see 4th- 7th link).

According to COFADEH, Fuentes has been transferred to the Institute of Migration in Guatemala City.

The Honduran National Committee for the Liberation of the Political Prisoners condemned his arrest reiterating that they do not want any more political prisoners.

The same day, COPINH emitted an alert on Twitter that the sentencing tribunal decided to leave COPINH and Berta's family without legal representation. COPINH announced further information will be published on their social media channels later on.

Interestingly, Proceso Digital has already published an article on the subject. According to them, the trial will continue this morning at 9am without the presence of COPINH's and Berta's family's lawyers...

At the same time, Libre calls for an impeachment of JOH.

Honduran feminist and women's rights organization published a letter of solidarity with the migrants and call for the constitution of a roundtable for migrating and displaced women.

The Espacio ACI, a forum consisting of 30 international NGOs with presence in Honduras, launched an urgent call for the protection of the migrants and the respect of their rights.

COPINH will hold a press conference today at 10:30am in Tegucigalpa to inform about the current situation of the trial and to present their reactions to the courts decision to exclude their legal team from the trial. The lawyer Víctor Fernández denounces the actions of the tribunal as illegal and in need of being annulled.

In front of the Supreme Court building they left a sign saying: "Today, the victims are not present, they are looking for real justice."

Amnesty International continues to cover the Berta Cáceres trial expressing its concerns that Honduras is violating the rights of Berta's family: "The Court's decision to impose representation by the Public Prosecutor's Office on the victims is a breach of due process guarantees and therefore impacts on victims' right to access to justice, truth and reparation. Victims' representation cannot be put in the hands of an institution that they have repeatedly said is responsible for violating their rights."

COPINH and Berta's family held a press conference yesterday denouncing the judicial farse and injustice in the Berta Cáceres case.

In the declaration read during the press conference, they declared their rebellion against this farce and injustice. "If the Sentencing Court presided by Esther Carolina Flores thinks that they can quiet or stop our search for justice, they are mistaken. We will not rest until all of the masterminds of the assassination of Berta Cáceres and attempted assassination of Gustavo Castro have been punished. The international community should not accept the legitimacy of this miscarriage of justice. The Honduran state will have to answer internationally for its failures. The thirst for justice is enormous, their illegal rulings will not quench it."

28 civil society organizations publicly denounce recent decisions by a Honduran trial court that limit the victims' rights to participate in the trial. The organizations "urge the Honduran judiciary to ensure full representation of the victim's family and COPINH in the trial process. We urge the Public Ministry to ensure an independent, impartial, and transparent process that addresses the intellectual as well as material authors of this terrible crime and ensures justice for Berta."

The recent months we have seen another increase in attacks against HRDs, especially surrounding extractive industry projects (see also last month's report by the Honduras Forum Switzerland). This situation caused a reaction in the US. "Senator Edward J. Markey (D-Mass.) and Representative Jan Schakowsky (IL-09) today led a letter with 50 of their Senate and House colleagues highlighting the growing threats against human rights defenders, journalists, and international human rights observers in Honduras. The lawmakers cite death threats to journalists and human rights groups, expulsions of Americans and other non-Hondurans documenting human rights violations, and intimidation campaigns against members of civil society as grave concerns around Honduras's human rights record. In their letter, the Senator Markey, Congresswoman Schakowsky, and the lawmakers call on the Trump administration to request the Honduran government immediately investigate these attacks, direct the State Department to reassess its certification of human rights conditions in Honduras, investigate threats against Americans, and publicly express concern about these attacks."

The mine in question belongs to Lenir Pérez and four 5 years ago, in Nueva Esperanza, Atlántida, he also used armed men to spread fear trying to force through a mining project of his. The latter failed after national and international accompaniment of the local people. OFRANEH highlights that the protest in Guapinol takes place in an important national park where water sources for 14 communities are located. Instead of promoting its protection and the right of the local inhabitants, the JOH regime rather sends its forces to repress while state representatives denigrate the protest as foreign sponsored.

With the violent eviction and repression by state security forces on Saturday (see 1. link and previous e-mails), the situation in Guapinol took a turn to the worse. Radio Progreso presents the local resistance and the reaction by the JOH regime as exemplary of the criminalization of social movements in Honduras. The case shows, first, "the ineffectiveness of [state] institutions to protect human rights and provide adequate responses to populations that claim their right to live

in a healthy environment, seeing protest as a mechanism to draw the attention of the authorities and achieve solutions to their demands." Second, "the existence of a policy of criminalization that seeks to deliberately distort the facts to sanction claims or the work of human rights defenders, and in this way minimize the pressure from social sectors and an informed public, which are fundamental in a democratic society." Radio Progreso then goes on to list the five main ingredients of state criminalization campaigns.

The Meso-American Initiative of Women Rights Defenders also launched an alert.

Defensores en Línea spoke with one of the local representatives, Juan López. He is one of 18 HRDs currently facing criminal charges for their peaceful resistance. In Tocoa, where Guapinol is located, there are six mining projects in total covering 350 hectares.

The Municipal Committee for the Defense of the Commons and Public Goods denounce that the central and municipal governments try to impose the mining projects by "the force of blood and fire".

The violent eviction was accompanied by a militarization of the area and a curfew at 6pm which still is in place.

Libre published a press release announcing that the nominated a commission to investigate the human rights violation taking place there. The investigation includes the local mayor of Tocoa, Adán Funes, who belongs to Libre.

CONADEH asked for a mediation after the death of two members of the Armed Forces.

The Armed Forces hold criminal groups responsible for the deaths.

They try to present themselves as the victims claiming that they only used "dissuasive weapons", but there were several wounded protestors.

"Experts say that alongside those factors, climate change in the region is exacerbating – and sometimes causing – a miasma of other problems including crop failures and poverty."

InSight Crime cites "rampant crime and violence", "broken institutions, impunity" and "corruption at the highest levels" as the main drivers.

COFADEH also published an urgent action.

CEJIL condemns the repression and violent eviction of state security forces in Guapinol. 'Marcia Aguiluz, director of CEJIL for Central America and Mexico, stressed that "the persecution the community of Guapinol faces today is part of a systematic practice in Honduras, where companies in collusion with state authorities have private security agents in order to control the territory and threaten the security of the community. This project is a new expression of the model that promotes the extraction of natural resources over the welfare of the majority."

The head of the Armed Forces, René Orlando Ponce Fonseca, tries to portray his soldiers as defenders of the people.

The disputed mayor's office in Tocoa announced a plebiscite under TSE supervision about the mining projects in the region. The local inhabitants rejected the proposal as they do not trust the TSE.

The director of Oxfam Honduras, George Redman, contradicts the official discourse presenting mining as a tool for development. "Mining generates little employment and generates little income for the State."
