Last week, two human rights defenders belonging to MADJ were attacked by the HIDROCEP company. Yesterday, the Military Police and COBRAS and TIGRES special units violently evicted the peaceful protesters against the hydroelectric project by HIDROCEP. They initially detained four community members, accusing them of usurpation. A fifth person was detained later on, after he visited his already arrested brother.

According to MADJ, they were told that their crime has been not supporting the company. After an national and international campaign, they were released in the evening.

The UN Human Rights Office in Honduras emitted a press release, lamenting the attacks against human rights defender and laying bare that the eviction won't resolve the underlying cause of the protest, the handing out of a concession which left many questions open.

The Franciscans demanded a stop to the criminalization and reparations by HIDROCEP for its environmental damage.

The Social Pastoral Office in La Ceiba denounces the role of the police and the MP in favor of the company's interests.

La Prensa, meanwhile, spurs hatred against environmental defenders by accusing them of endangering investment of \$300 million for renewable energy projects.

The Oppositional Alliance backed up Nasralla, accusing the OAS of not investigating the role of JOH and the National Party in the IHSS corruption scandal.

Furthermore, they demand that the OAS doesn't accept the elections without any significant electoral reforms beforehand.

CEM-H will launch on Wednesday, August 30, "Poléтика Honduras", a body to inform about and press for the inclusion of women specific topics in the political agendas of the presidential candidates.

Political analyst Julio Navarro criticizes the lack of real solutions presented by the political parties.

The former president of the TSE, Arístides Mejía, sees a massive voter turnout as the only way against the electoral fraud by the National Party. Meanwhile, the RNP demands further 15 million Lempiras by the Finance Secretariat to print the much needed identity cards for the elections.

The RNP estimates that there are some 250'000 new voters registered.

The Constitutional Chamber rejected an application for Amparo asking to stop the harassment of students by police and military forces.

The student movement MEU denounces that Julieta Castellanos, UNAH's dean, uses her private security forces to damage UNAH property and then accuse them of having done it.

Congress presented their proposal to solve the crisis at the UNAH: to nominate an interim-dean and to hold student elections. The dean is supposed to take control on September 26 and stay in power until March 2018. The students didn't have their wish of a transition council fulfilled, but, according to Criterio, they gave a vote of confidence to the proposal.

El Tiempo, meanwhile, presents a more skeptical view by the students, fearing that the criminalization continues and that even though they got rid of Julieta Castellanos, her cabinet still stays in place. The students announced a press conference today.

Julieta Castellanos greeted the proposal, but not without blaming once more the students for the crisis at the UNAH.

The teachers' association at UNAH, ADUNAH, denounces that UNAH authorities denied their representatives access to the session of the University Council.

The civil society coalition Observation N-26 presented its first report on the Honduran general elections. They highlighted among other things, the failure of political parties to present complete plans of government, irregular changes to the electoral process, less participation of women, missing guarantees for the participation of the LGTBI community and a growing polarization.

Indira Mendoza fears that the violence against members of the LGTBI community may even increase during the campaign.

According to UNAH's Violence Observatory, nine people dedicated to politics have been murdered so far this year.

The TSE continues to highlight the amount of observers for the coming elections, hoping that this would distract from its short-comings.

Caritas' director German Cálix believes that the TSE is one of the main problems regarding Honduran elections. Its magistrate shouldn't be party representatives, but people respecting the Honduran constitution and laws. Of the 99 filed complaints for electoral offenses, only three cases have been prosecuted.

Honduras is among the countries with the highest impunity according to the 2017 Global Impunity Index (Índice Global de Impunidad - IGI) from the Center for Studies on Impunity and Justice (Centro de Estudios sobre Impunidad y Justicia - CESIJ) and the University of the Americas Puebla (Universidad de las Américas Puebla - UDLAP).
