As Congress presented its plan to resolve the crisis at UNAH yesterday, ATIC searched the house of Mirtha Gutiérrez, a spokesperson of the student movement MEU. They excuse: investigating a crime that happened over a year ago at that address. It rather seems that this was meant as a new act of intimidation to have MEU accept the terms of Congress' proposal.

Congress' president Mauricio Oliva claims that they took up 90% of the proposal by the MEU and presents this as something historic, given that it was handed over to Congress as a petition from the public.

The problem is that the remaining 10% contain some points that could even worsen the situation at the UNAH according to the student leader Fausto Cálix.

The MEU rejected the proposal in a press release, denouncing that it is gives legitimacy to an illegally elected University Governing Board.

They called on ADUNAH, UNAH's teacher association, to meet today to discuss a joint position.

Teachers paid by the hour held a protest outside of UNAH, demanding outstanding salaries.

Meanwhile, the National Party praises itself for apparently having solved the crisis at UNAH...

ContraCorriente explains why Congress' proposal won't resolve the crisis at the UNAH and why the conflict will continue for the time being. The most obvious culprit is the criminalization of the student movement. A court in Tegucigalpa decided yesterday to officially commit for trial 19 students for the crimes of aggravated damages, i.e. for their right to protest. Furthermore, they face being expelled for 15 academic periods from the UNAH.

A further reason is the ongoing intimidation of the students, Friday's search by ATIC of a student leaders house being the most recent case.

While the homicide rate grew between 2015 and 2016, it fell in the first half of 2017 compared to the same time in 2016. According to UNAH's Violence Observatory (OV-UNAH), 2029 people were murdered in Honduras in the first six months of 2017, about 11 per day. This means a reduction of around 21%. Nevertheless, El Libertador criticizes that previously safer places have become more dangerous as two new departments, Atlántida and Comayagua, are now also part of the so-called red zones singled out by OV-UNAH. The sociologist Roque Castro emphasizes that the policies intended to improve the social conditions in the country and, therefore, counteract violence have failed and that the 70 billion Lempiras spent by the JOH administration on security haven't brought the desired result.

I previously listed some of the recommendations for electoral reforms made by the EU after the last general elections in 2013. Most of these recommendations were never implemented. ConexiHon now published a list of 22 recommendations made by the OAS in 2013. The result is the same, the National Party successfully blocked the most pertinent reforms in the last four years.

Omar Rivera calls on the political parties to join a mediating body to discuss the needed electoral reforms.

CotraCorriente's fact checker agrees with Salvador Nasralla that the Clean Politics Bill failed to led to more transparency. The newly created unit has not been able to investigate the finances of any party. Furthermore, it has failed to present proof that the National Party doesn't use state funds for its electoral propaganda.

It is more than doubtful that the newly presented "3for3" Platform will change this. It asks politicians to present their financial information of their own accord.

Something most "pre-paid" congresswo/men, as Arturo Rendón Pineda calls them, won't do.

The RNP believes that about 6 million Hondurans will be eligible to vote in the coming elections.

And the TSE boasts that it has already signed 21 agreements with bodies observing the elections.

Yesterday's events are probably best summarized by the title ConexiHon gave its article on it: "Barbarism!" A brutal repression of state security forces at the UNAH led to 26 arrests and one disappeared person. Several people were hurt by the excessive use of tear gas and force by the police. Four human rights defenders accompanying the students were attacked by the police, when they drove off from the UNAH in a car from CONADEH, spraying tear gas inside the car. Inside the car were Carlos del Cid of the Ecumenical Human Rights Observation Center (OEIDH), Tomy Morales of the Association for Democracy and Human Rights

(Asoprodemu), Hedme Castro of ACI-Participa and Ariel Díaz of the Youth for Democracy Association (AJDH). They were all detained and brought to the offices of the Police Investigation Bureau (DPI). Tomy Morales was so badly hurt by the tear gas, that she was hospitalized - not in a normal hospital, but in a military hospital. The journalist and human rights defender Darwin Steven Carías Álvarez of the CPTRT accompanied the students at the campus and was disappeared. C-Libre presented an Habeas Corpus in his favor.

C-Libre calls what happened yesterday a "hunt for the leaders and speakers of the university student movement".

The repressions started with a press release by the Honduran government announcing that an expulsion order has been given to the police to "restore order (...) based on the principle of legality and human rights" at the UNAH.

El Libertador lists 22 detained students and outstanding arrests warrants for further 9 students.

COFADEH presented Habeas Corpus in favor of the detained human rights defenders and students. In their article you can also see the attack on the CONADEH bus with the HRDs in it.

HCH TV was present at the court when they Habeas Corpus were admitted and they interviewed one of the present human rights defender.

COFADEH denounces that their human rights lawyers were not allowed to see the detained students.

ConexiHon published an article explaining what international norms say about the use of tear gas.

The Costa Rican Human Rights Association (ACODEHU) denounces the events in a press release as "state terrorism".

The human rights organization Madre Tierra wrote a public letter to Honduras government denouncing the detention of one of their student collaborators.

Amongst all this, UNAH's dean announced that next week classes at the UNAH will start again...

The attacks against Tomy Morales and Carlos del Cid are of further significance, because both of them have just accompanied a week-long human rights delegation by the Honduras Forum Switzerland which presented their findings in a press conference the same day. UNAH authorities denigrate the work of human rights defenders. In their press release (in which they misspell the name of Tomy Morales and falsely attribute her to C-Libre) they accuse both Tomy Morales and CONADEH of having tried to harbor criminal students. Radio Progreso offers an overview of the most recent cases of criminalization (Without yesterday's events at the UNAH), e.g. against OFRANEH's general coordinator Miriam Miranda, campesinos in the Bajo Aguán or indigenous Tolupan in Azacualpa, Copán.

In a press release, the UN Human Rights Office in Honduras expressed its preoccupations about the most recent cases of criminalization against human rights defenders and students. The office laments the lack of response by both the Security Secretariat and the National Police to its inquiries about the cases. Furthermore, it has identified an excessive use of force by state security forces and demands swift and impartial investigations into this.

The Honduras Forum Switzerland emitted a press release condemning Friday's repression against human rights defenders and students by state security forces.

REDEHSUR also condemns the attacks.

Criterio reports on the attack and arrest of the four human rights defenders. According to their article, the human rights defender Hedme Castro was released from custody after pressure by the US embassy. Nevertheless, the other three are still in custody and treated like criminals.

15 of the newly criminalized students already faced a judge yesterday in an initial audience.

El Pulso presents the events at the UNAH as a culmination in a limited area of what is happening on a nation-wide level: violent evictions, repression, authoritarianism and criminalization.

El Tiempo also took up the events criticizing the role of the National Police.

Defensores en Línea published the press release by the Honduran authorities which was emitted after the attacks. It speaks of upholding human rights and calls the arrested students "supposed students" and accuses the arrested human rights defenders of having physically harmed a police official.

Friday's arrested students received alternative measures to imprisonment, meaning that they have to sing in at the court on a regular basis, can't leave the country and aren't allowed to participate in protests. They had to wait over twelve hours in handcuffs and shackles at the court to have a judge hear their case.

The remaining human rights defenders attacked and arrested on Friday have been released at 2.30am on Sunday.

ACI-Participa, whose coordinator Hedme Castro was among the arrested, denounces in a press release the events and holds the JOH government responsible for it.

In the third statement by the Honduran state, they continue to defend their brutal attack on the human rights defenders and students which at that time were in a bus by the state's human rights ombudsman CONADEH. They even imply that the human rights defenders stole the bus by CONADEH. The UNAH authorities announced more repression if the students continue to protest.

Please find attached the translated statement by the UN Human Rights Office in Honduras on Friday's repression against students and human rights defenders (hat-tip to Pat).

ConexiHon reports on the time three of the four human rights defenders attacked and arrested as part of the repression in Friday spent in custody until 3am on Sunday.

Defensores en Línea spoke with two of them, Carlos Del Cid and Hedme Castro, after their release. They further report that the criminalizing trial against them and the students continues on September 18 and 21. The director of some 20 human rights organizations held a joint denouncing the attacks against human rights defenders and students on Friday. They demand among other things a thorough investigations of the events, a resignation of both the security minister and the dean of the UNAH and a stop to the criminalization. Furthermore, they denounce that the NGOs Association for a More Just Society (ASJ), Alliance for Peace and Justice (APJ) and FOPRIDEH "irregularly and irrespectively" assume the representation of human rights organizations.

The newly formed Convergence against Continuity (CCC) also emitted a press release, criticizing among other things the role of the MP: "We denounce and repudiate the behavior of the public prosecutor, which has given unequivocal signals to respond exclusively--and protect-- the particular political interests of the mafia leading Juan Orlando Hernández over its function to represent the interests of the Honduran people before the state. We repudiate the behavior of the national police who, with the repressive action of Friday, September 8, reveals the useless and false police purge, so officially publicized and hypocritically endorsed by national agencies promoted and financed by the Government of the United States"

A further statement comes from the Coalition against Impunity. COFADEH's Bertha Oliva interprets Friday's attack as a wake-up call for Honduran human rights defenders. She proposes the creation of an observation body documenting of all the acts of aggression by state bodies against human rights defenders.

The condemnation of Friday's attack by state security forces on human rights defenders and students has reached the purging committee of the police force. In a press release, they demand the suspension of the police officials and agents involved in the attack.

Human rights organization, meanwhile, reiterate that also Security Minister Julián Pacheco and UNAH's dean Julieta Castellanos have to go immediately.

CONADEH also announced to file a complaint at the MP against the police and the Security Secretariat.

Undeterred, UNAH authorities continue to criminalize the students.

Yesterday, six more students were banned from university for 5 years, totaling 25 students robbed of their right to education.

Even worse, they started a new campaign to portray the students as violent protestors. Nevertheless, this backfired when it was shown that the person breaking the glass door to an administrative building at the UNAH was a private security guard from ESPA. These guards have not only been used frequently to repress the students, but also to infiltrate them and commit such acts under their name.

In their press release, the US embassy writes that they meet with the police, human rights organization and other interested parties. UNAH authorities complain that they haven't meet with the embassy so far. Nevertheless, they still use to US' press release to present their actions as justified.
