## Berta - Gaipe; Reelection; (Re)Elections; ZEDEs; Corruption; Journalists; HRDs; National Police; Drinking Water; and Fearing the Next Generation

As announced, GAIPE presented yesterday its in-depth investigation into the murder of Bert Cáceres.

The international media coverage started already on Saturday with a piece in the New York Times. Now everybody is taking it up, from the Washington Post, to Al Jazeera, CNN and El País. All the articles highlight the fact that high-level business executives and state agents are implicated in the murder as well as the serious flaws in the government's investigation.

In Honduras, the alternative medias also picked up the report, but the main press has so far tried to silence it. Only El Tiempo, which has started covering human rights issues some time back now, dedicated a long article to it.

A very strong reaction came from US Senator Patrick Leahy, which is worth quoting at length: "This damning report corroborates what many have suspected -- that the investigation of Berta Cáceres' murder has been plagued by incompetence, attempts to stonewall and deflect blame to protect those who conceived of and paid for this plot, and a glaring lack of political will. (...) Any hope that the Honduran Government may have of continued U.S. assistance under the Alliance for Prosperity Plan will hinge, in part, on the outcome of the Cáceres case, acceptance of the legitimate role of civil society and the independent press, and top-to-bottom reform of the judicial system."

The National Anti-Corruption Council (CNA) announced that they filed a complaint against a former Nationalist public official for the embezzlement of 12 million Lempiras. The name of the official has not been revealed yet, but it concerns someone having worked for the government between 2010-2014. According to the CNA, the evidence is indisputable and they demand an immediate release of an arrest warrant. ConexiHon follows up with a third article on the shady deals taking place in the Honduran Congress (see yesterday's e-mail for part 1 and 2). ConfidencialHN detects new irregularities surrounding Alberto Solórzano, member of the Evangelical Confraternity of Honduras as well as of the purging committee. In March the same newspaper revealed that Solórzano had received 1 million Lempiras for unspecified social projects. Now they found documents showing that he got another million Lempiras by the president of Congress, Mauricio Oliva to produce a report.

Berta - Investigation, Global Day; UNAH; Journalists; National Police; (Re)Elections; National Party; MACCIH; Economy; and With the Voice of the Dead

There is continuous international coverage of the GAIPE report. US Congresswoman Jan Schakowsky emitted a press release finding unequivocal words: "The report released this week gives us clear and unequivocal evidence of how carefully orchestrated the assassination plot was and how rampant the impunity has been. It is unacceptable that, despite the mounting international and domestic pressure, the Honduran Public Ministry has dragged its feet and refused to conduct a thorough and fair investigation."

Democracy Now! aired an interview with New York Times reporter Elisabeth Malkin, who covered the GAIPE report.

InSight Crime cites two sources in Washington wondering about its impact on US funding for Honduras, but it concludes that "past experience suggests these concerns are unlikely to translate into actual changes in policy or cuts in aid funding."

Criterio concentrates on the use of PR companies paid by DESA to attack Berta and COPINH.

El Tiempo reports on a possible criminal network inside the RNP which deals in identity cards.

At the same time, the RNP started yesterday to hand out the missing identity cards for the general elections.

El Pulso shows how little interest political parties in Honduras still have for transparency. The civil society initiative "Three for Three", which asks candidates among other things to publish their tax returns, has only been taken up by a minority of candidates, most of them coming from Pinu and Libre, i.e. the Oppositional Alliance.

The TSE handed out the credentials for the ballots to the political party. Every party gets 36'000 - a fact that is heavily criticized by the political opposition. Parties which only got some 4000 votes in the last elections get nine times the amount of credentials...no wizardry needed to find out what happens with the remaining ones.

Carolina Bardales Salazar explains how the coup d'état in 2009 led to the illegal reelection bid by JOH this November and what happened in between. She also emphasizes the important role of the EU in putting pressure on the Honduran state to return to the rule of law, a role the EU so far has failed to take up.

Nevertheless, the EU electoral observation mission met with Radio Globo director David Romero yesterday and was informed about the Honduran government's persecution of alternative media outlets as well as irregularities of the JOH administration.

Honduras once more failed to live up to the standards of the U.S. Millennium Challenge Corporation (MCC) and, therefore, denying it access to its funds. Government representatives try to spin the story, saying that they have complied with 11 out of the 20 indicators. Nevertheless, in the last eight years with a Nationalist government Honduras never got access to the funds due to impunity and corruption.

Addressing Honduras' review, John Wingle, country director for Honduras and Guatemala at the MCC, concentrates mostly on economic indicators. But even those are contested by civil society actors such as FOSDEH or even the former director of the Central Bank of Honduras, Hugo Noé Pino. The head investigator at the National Anti-Corruption Council (CNA) once more felt obliged to denounce that their investigations get backlogged at the MP.

Meanwhile, the former president Pepe Lobo dares the CNA to publish the name of the public officials from his administration who is thought to have embezzled 12 million Lempiras.

Spanish authorities announced the arrest of José Santos Arias Chicas the former director of the Ciudad de Ángel housing project. He was arrested for fraud in 2014 but was able to flee from house arrest.

U.S. Senator has repeatedly called for justice in murder of Cáceres, end to impunity in Honduras

WASHINGTON – U.S. Senator Ben Cardin (D-Md.), Ranking Member of the Senate Foreign Relations Committee, released the following statement Friday on inefficiencies and negligence of the investigation into the assassination of Honduran Environmentalist Berta Cáceres:

"The deeply troubling findings of the Independent Advisory Group of Experts (GAIPE) indicate that the investigation into the assassination of Honduran environmentalist Berta Cáceres has failed to hold accountable any of the intellectual authors behind Berta's murder. The report by the Team of Experts suggests that there are investigating its efforts to conduct a thorough and transparent investigation and provide the information required by law to the Cáceres family's legal representatives."

"More than a year and a half since Ms. Cáceres' murder, I remain disappointed about the pace of and deficiencies in the investigation. While eight individuals have been arrested, none have been convicted. The report by the Team of Experts suggests that there are investigating its efforts to conduct a thorough and transparent investigation and provide the information required by law to the Cáceres family's legal representatives."

"I continue to stand in solidarity with the Cáceres family and with the hundreds of Honduran environmentalists and human rights activists who have been fighting for justice."

Five international human rights defenders denounce in an open letter their treatment by the Honduran government. They all have worked for years with Honduran human rights organizations and accompanied among others Berta Cáceres and COPINH. In 2016, one of them suffered a public smear campaign and another one was detained and deported when trying to enter Honduras. With the help of Honduran human rights organizations, they found out that all five of them have an expulsion order against them and they aren't allowed to return to Honduras for five years. But the Honduran government denies them access to their files and therefore any legal procedure to question these orders. One and a half year after starting to look into the matter, they now address the international community, asking them to pressure the Honduran government to withdraw these illegitimate expulsion order and to create an environment where national and international human rights defenders can conduct their important work.

(Re)Elections - "Results", HRDs, Irregularities, Militarization, Costs, Int. Coverage; Drug Trafficking;

Having been awake 26 hours and with still no official result published by the TSE, I have to take a rest now. Here is what happened until now:

Even before 8pm, the National Party declared JOH as the winner. He then took to the streets and first his wife and then JOH himself hold a speech claiming that he already had received congratulatory calls by other presidents. According to Radio Globo, never before in the "democratic" period of Honduras, a candidate has declared himself president without any TSE statement beforehand.

Shortly afterwards, the Opposition Alliance announced in a press conference based on 3281 vote tally sheets (out of some 18'000), Salvador Nasralla will be the winner of the elections.

And of course, the Liberal Party also celebrated. El Pulso called it the beginning of the war of numbers.

At 9pm - 2 hours later than initially announced, Honduras Culture and Politics wrote that the TSE released the first vote count with Nasralla 20'000 votes in the lead. They also wrote that a press conference for 9.15pm, which did not take place. This raised a lot of suspicion, even more as the TSE bragged before the elections that their new system will run smoothly.

While there was no message from the TSE, human rights defenders started to denounce that the Armed Forces started to increase their presence in the streets in Tegucigalpa and around the TSE.

Shortly before 10pm, the TSE announced that they won't release for the time being failing to give convincing explanations why they can't release the results of the ballots already processed. They just said, that they will release later today (i.e. Sunday in Honduras).

El Libertador voices fears that the ruling elite tries to get the needed international support in back-room dealings for the continuity of the JOH regime.

Shortly before Midnight, Radio Globo, COPINH, COFADEH and others reported that the TSE had already counted over 70% of the ballots with Nasralla coming out as the winner, but they deny announcing it officially. At 10 past midnight, the Opposition Alliance announced that they won

presidency with 45.4% of votes over 40.6% for JOH.

The president of the TSE promised that those in line would still be able to vote, but it has been announced on various occasions that this was not the case. Even though prohibited by the Electoral Law, several media outlets, such as La Prensa and La Tribuna, published exit polls by the company Ingeniería Gerencial already around 6pm, hours before the TSE published its first results.

The company "apparently is owned by Arturo Corrales, former member of Hernández government. Not a company with any track record in this kind of work."

Already in the afternoon, the TSE decommissioned 21 manipulated vote tally sheets from National Party activists.

A PINU member in the role of secretary of a ballot table had to withdraw after being harassed by the Nationalist head of the ballot table.

Eva Fernández, a former member of the National Party who now runs for the Opposition Alliance, was denied her right to vote.

Voting centers in the Kennedy neighborhood in Tegucigalpa denounced that

they lacked the seal to ratify the ballots.

Radio Progreso highlights how this behavior further raises the distrust by the public in the TSE. In its annual survey, 77.1% of respondents in 2016 said that they don't trust the institution.

COFADEH's Bertha Oliva declared that what should be a sign of hope had been turned into "days of uncertainty, insecurity and fear".

The Coalition against Impunity warns that the TSE may create the condition leading to a constitutional crisis - or rather a deepening of the constitutional crisis as the reelection bid already was unconstitutional.

FOSDEH criticizes that the high investment in the TSE is not reflected at all by their unprofessional behavior. In 2013, the electoral process cost some 1.6 billion Lempiras, now it was already 2.1 billion.

The Episcopal Conference of Honduras denounces in a press release that the TSE is generating suspicion for stalling in the publication of the electoral results.

El Libertador published a portray of the man orchestrating a lot of the uncertainty, TSE president David Matamoros Batson.

While there weren't any new results published for over 24 hours, the TSE started to upload them in pieces again yesterday. As the trend suddenly changed in favor of JOH, this raised further suspicion.

Currently, Salvador Nasralla's lead has shrunk to 1.47% or a bit more than 35'000 votes.

The TSE announced that they will be in possession of all the tallies by 8pm tonight.

Jorge Cálix, Libre congressman, told ContraCorriente that the results won't be reversed. According to him, they just upload the tallies in which JOH won first to reduce the margin and create a better bargaining position of the National Party cadre which fears being arrested for the

IHSS corruption case or deported for its involvement in drug trafficking.

In 2013, the presence of drug cartels changed the voting patterns in favor of JOH. Honduras Culture and Politics investigates how the breaking up of some cartels changed the voting patterns. There preliminary results show that JOH lost a substantial share of votes with the drug traffickers gone. Interestingly, the analysis also confirms to some extent the above-mentioned statement by Jorge Cálix:  
"While not our main goal when we started this, these three selected municipios demonstrate how variable voting is this year, from place to place. This lends support to suspicions of many that the continuing reporting of vote tallies that favor the incumbent, Juan Orlando Hernández, would be unlikely to happen if the order of counting were random. You might get one municipio going 50% for the National Party, like El Paraiso, but equally you might get vote counts with the Alianza in the lead."

(Re)Elections - TSE, Results, OAS, National Party, Opposition Alliance, US, Int. Coverage, LGBTI, SPS; HRDs; and a Letter from Mexico

A moment before wanting to send out this newsletter, I was made aware of repression taking place at INFOP.

With the results turned in the counted tallies and JOH 3000 votes in the lead, the criticism of the TSE only grows further and voices denouncing corruption and signs of fraud become more prevalent. (At the moment of wanting to send out the e-mails, I checked the TSE homepage again and it seems that new (biased) votes were uploaded to the system. JOH now leads by 22000 votes...most votes came from i) Copan, where a previous tie now became a 9000 votes lead for JOH, ii) Olancho and iii) and Yoro) Of course it did not help that the system of the TSE broke down for five hours yesterday further raising suspicions.

The TSE president David Matamoros Batson pretended everything is alright, i.e. that it won't affect the election results.

But at the same time, the TSE magistrate Marco Ramiro Lobo said that he was surprised about what is going on.

Several US congressmen have denounced the situation in Honduras in press releases and over Twitter.

The European Left/Nordic Green Left parliamentary group at the EU Parliament also published a statement of concern.

Criterio reports on a petition by US civil society organizations calling out to their government as well as the OAS to demand complete transparency in the vote counting process

The Association of International Cooperation (ACI), which is made up of 28 international NGOs with presence in Honduras, voiced its concerns about the behavior of the TSE and demands complete transparency. And of course, there is also widespread criticism from National actors of the TSE's behavior. Radio Progreso, aware of the partisanship of the institution, calls directly to the three magistrate demanding that they leave aside politics and to think about peace and stability for Honduras. The National Human Rights Board denounces the irresponsible behavior of the TSE and demands from the international community to closely observe the situation in the country. The Network of Social Communicators and HRD fro El Paraíso see in the behavior of the TSE just the reflection of the total control JOH has in Honduras. There are further statements from COPINH, COFADEH, COPPAL, ATALC but also church groups. Héctor Renán Soto Caballero published an analysis of the TSE based on the elections and its aftermath.

At the time of writing, JOH leads the presidential election with some 3000 votes with a bit less than 83% of the tallies counted. (At the moment of wanting to send out the e-mails, I checked the TSE homepage again and it seems that new (biased) votes were uploaded to the system. JOH now leads by 22'000 votes...most votes came from i) Copan, where a previous tie now became a 9000 votes lead for JOH, ii) Olancho and iii) and Yoro) As mentioned on previous days, it is widely believed that a biased approach to first count votes favoring JOH has been chosen to create uncertainty and tension. The former UNAH dean and human rights defender Juan Almendares Bonilla fears that the ground is being prepared for another coup d'état, this time against a president-elect.

The skewed approach of incorporating new votes becomes also clear when looking at the results the two opposition parties came up with. They are in possession of all the tallies and according to their calculations, the Alliance wins with the same 5% margin as announced by the TSE on Monday morning. Honduras Culture and Politics translated an analysis by Rodolfo Pastor Fasquelle on this.

Criterio published an analysis by Edmundo Orellana which further dissects the strategy of the merchant of doubts.

And Javier Suazo highlights the role of former JOH minister and still ally Arturo Corales.

The Alignment against Continuity calls out to the Honduran people to take to the streets in all parts of Honduras and defend the vote and their victory over the dictatorship.

The TSE announced that they finished scanning tallies from ten departments and only seven remain. Taking a closer look at those seven departments, we find the following: i) Colón: Nasralla has a 17'000 votes lead, ii) Gracias a Dios: a tiny department, where JOH currently leads by 1500 votes, iii) Olancho: JOH leads by 5000 votes, iv) Copán: tied, v) Cortés: Nasralla leads by almost 100'000 votes, vi) Nasralla leads by over 20'000 votes and vii) Lempira: JOH has a 14'000 vote lead. If the proportions don't change, Nasralla is the clear favorite and it is further proof of the biased vote counting by the TSE.
