Corruption; HRDs; Berta - HRDs, Commemoration; (Re)Elections - US, Repression; MADJ; Impunity Pact; MP; IACtHR; Labor Rights; and Apostle Thomas in Honduras

After having been highlighted in many reports on corruptions in the past years, the former First Lady Rosa Elena de Lobo has now been arrested. The MACCIH investigates a 12 million Lempiras withdrawal from the Office of the First Lady just days before her husband's term ended. And this is just one of several investigations against her by the MACCIH and the Special Prosecutor Unit against Impunity and Corruption (UFECIC).

After being heard by a judge, de Lobo was sent to the women's prison in Támara, Francisco Morazán.

ATIC seized her properties.

The MACCIH held a press conference yesterday informing about their investigation and the arrest.

The National Anti-Corruption Council (CNA) also highlights its role in the investigation.

They also demand that this is only the beginning of a more thorough action against the corruption networks in Honduras.

Criterio reports that de Lobo used the bank Ficohsa for the "atypical transactions".

In a third article, Criterio lists some of the usages of the stolen money.

JOH reacted with a press release promising judicial independence.

Criminologist Arabesca Sánchez sees her arrest as part of the recent high profile corruption cases in Central America.

Berta - Commemoration, Investigation, Hydroelectricity; HRDs; Femicide; Military Police; Corruption; Penitentiary System; Economy; and Honduras vs. Ecuador Part II

Honduras and the world commemorated yesterday the life of Berta Cáceres who was murdered two years ago. Among the voices calling for justice and an end to impunity were Amnesty International as well as EU-LAT network and CIDSE, which is made up of 57 European and international organizations. The UN Human Rights Office in Honduras emitted a press release highlighting the responsibility of the Honduran state to investigate. And so does the US.

The international media also covered it. El País printed a report by Berta's daughter Berta Zúniga of the day she received the phone call about her mother's murder.

The pressure by Berta's family, Honduran human rights organization and the international community has been strong for two years and as a reaction to that (or more cynically, as a way to divert the attention away from the international calls to the JOH regime criticizing its human rights record and as another argument for the reelection of the Attorney General), the MP announced yesterday out of the blue that David Castillo, President of DESA (the company behind Agua Zarca) and a former Military Intelligence Officer, was arrested for the murder of Berta. COPINH believes that the arrest is thanks to the work and pressure created by the national and international organizations and explicitly states that it is not thanks to the MP which rather tried to cover up the truth.

Nina Lakhani has already reported on the arrest for the Guardian. DESA reacts by denouncing the arrest.

A dos años del asesinato de Berta Cáceres:

OACNUDH reitera la urgencia de profundizar la investigación para el esclarecimiento de la verdad y la sanción de todos los responsables.

Tegucigalpa 2 de marzo 2018.- La Oficina del Alto Comisionado de los Derechos Humanos de las Naciones Unidas en Honduras (OACNUDH), en el marco del segundo aniversario del asesinato de la defensora de derechos humanos y ambientalista Berta Cáceres y tentativa de asesinato del ambientalista Gustavo Castro desea expresar lo siguiente:

Reiteramos la responsabilidad del Estado de investigar este caso, con la debida diligencia lo cual conlleva la obligación del Estado de realizar una investigación que sea expedita, independiente, pronta y exhaustiva, que agote la extensión de las diferentes autorías y grados de participación, permitiendo conocer la verdad de los hechos y la reparación de las víctimas y sus familiares.

El Estado además deberá garantizar el derecho de las víctimas a participar en el proceso, lo cual implica que tengan acceso y capacidad de actuar en todas las etapas e instancias de dichas investigaciones y procesos judiciales a través de la figura de acusación privada.

En este sentido, la Oficina considera importante que el ente de investigación y persecución penal pueda dar respuesta en un plazo razonable a las solicitudes presentadas por la acusación privada, incluyendo el requerimiento presentado el pasado mes de octubre sobre posibles autorías intelectuales a la luz de hallazgos encontrados en documentación compartida, mediante orden judicial. La Oficina reconoce el incremento gradual del acceso a la información en relación a las diligencias investigativas, no obstante, se siguen observando fuertes desafíos en materia de transparencia en cuanto a la falta de claridad sobre los criterios seguidos para determinar de la secretividad de la información.

La Oficina desea recordar que la limitación de este acceso debe imponerse en la medida estrictamente necesaria para garantizar la plena efectividad de la participación de la acusación privada.

Como parte de las medidas de no repetición, la Oficina considera fundamental que el Estado de Honduras en atención a las recomendaciones de los órganos de tratados y procedimientos especiales de Naciones Unidas, adopte las medidas que permitan superar las debilidades institucionales y normativas que persisten en el país para que los pueblos indígenas puedan tener un acceso efectivo a la justicia y obtener una protección judicial de sus derechos, incluyendo la protección de sus territorios y recursos naturales.

Como ya fue señalado por la Relatora Especial sobre Pueblos Indígenas, el Estado Hondureño tiene la obligación de desarrollar y fortalecer mecanismos específicos y permanentes que permitan a los pueblos indígenas presentar sus demandas y obtener una reparación por violaciones a los derechos sobre sus tierras y recursos conforme al Convenio núm. 169 de la OIT y la Declaración de las Naciones Unidas sobre los Derechos de los Pueblos Indígenas.

La Oficina reitera la obligación del Estado de establecer un marco normativo e institucional que garantice el goce de los derechos de los pueblos indígenas, siendo la consulta previa un pilar fundamental para tal fin. Igualmente importante es investigar los posibles actos de corrupción y abuso de autoridad que hayan posibilitado la adjudicación de recursos naturales en detrimento del derecho a la consulta y consentimiento libre, previo e informado.

Aparejado a esta obligación estatal, la Oficina invita a que las empresas incorporen gradualmente los Principios Rectores de Naciones Unidas sobre Empresas y Derechos Humanos, que garanticen el respeto de los derechos de los pueblos indígenas, sus tradiciones, prácticas y procedimientos de decisión, particularmente en proyectos que puedan tener una afectación a sus medios de vida y territorios.

La OACNUDH continúa expresando su apoyo a la familia de Berta Cáceres y su acompañamiento en los esfuerzos por la búsqueda de la verdad, reitera al Ministerio Público su ofrecimiento de colaboración para avanzar en el esclarecimiento del crimen e identificar las responsabilidades tanto materiales como intelectuales.

Finalmente, OACNUDH reconoce y apoya el rol fundamental de la labor de las personas defensoras de derechos humanos en una sociedad democrática, recordando al estado la obligación de tomar medidas que garanticen un entorno seguro y propicio para la no-repetición de ataques y crímenes de esta naturaleza.

The Electoral Observation Mission of the EU presented yesterday their final report. I haven't seen so far a link to the report, but Criterio reproduced its 15 recommendations. Everything you'd expect from a body not daring (anymore) to question the legality of the elections is in there, e.g. improvement of the electoral census, more neutral coverage by the main media outlets and their independence, gender equality,...All necessary steps but it does not live up to at all to the events between November 26 and today. It rather further serves to whitewash the fraud and the JOH regime.

It is, therefore, no surprise that the National Party welcomed the report accusing it to follow the line of the US.

And accordingly, the political opposition criticizes the report.

The former TSE magistrate Arístides "Tito" Mejía agrees that the recommendations do not correspond to the grave situation Honduras is living in.

According to the former chancellor under Zelaya, Milton Jiménez Puerto, the head of the EU mission, Marisa Matías, showed two faces. As a functionary she read the recommendations made by the report, but on a more personal level she also showed that she grasped the gravity of the events having taken place in Honduras.

The Urgent Action launched to call for the freedom of Edwin Espinal and other political prisoners published a very worrisome update on their situation: "On March 3rd, day #46 of his unjust incarceration, political prisoner Edwin Espinal began a hunger strike to demand that he and other prisoners be taken to see a physician. There is a flu-like virus circulating in the military-run, maximum security "La Tolva" prison. Edwin and other prisoners have been refused medical attention for several days.

There is an extreme water shortage inside the La Tolva prison where two political prisoners - Edwin Espinal and Raul Eduardo Alvarez - are imprisoned. This morning, all prisoners throughout the jail had access to water for FIVE minutes. This means that 1000 prisoners had to flush and use toilets, get and store drinking water, and shower in the five minutes that the water was available. Outside of the time that water is

available, prisoners are forced to limit bathroom use because toilets are located inside the shared, enclosed cells. Plastic bottles are not permitted inside the jail making it impossible for prisoners to adequately save drinking water for their consumption throughout the day. After the water was turned off after five minutes this morning, throughout the prison, in unison inmates began to bang on the walls and make noise in any way possible. In some areas of the prison, prison guards shot tear gas into the common areas that are shared by approximately 200 people.

The horrific and dire conditions inside Honduran prisons is of no secret to the Honduran and foreign governments. The construction of military-run maximum security prison have only worsened these conditions particularly since its so difficult for national and international human rights organizations to enter the jail. These conditions can only be described as torture."

I now have access to the final report by the Electoral Observation Mission by the EU (hat-tip to Andrea). Its summary starts like this: "The general elections of 2017, attended by parties and candidates from across the political spectrum, occurred in a context of strong polarization exacerbated by the candidacy of outgoing President Juan Orlando Hernández, following a ruling by the Supreme Court that declared the prohibition of the presidential re-election inapplicable and provoked a strong rejection of the opposition. After a campaign marked by the inequality of resources and coverage in the media in favor of the ruling party, the election day, well organized, it passed peacefully and the scrutiny went on in conditions of respect for the will of the voters, with strong presence of representatives of the main parties at the polling stations. The Supreme Court Electoral implemented a system of publication of electoral results that facilitated its verification by candidates and citizens.

The EU EOM regrets and condemns the death of at least 22 people during post-election protests and reiterates His call to the Honduran authorities to respect the right to peaceful demonstration." The report never speaks of fraud (except citing the political opposition) and now even claims that the shutdown of the server, which was followed by a unbelievable trend reversal in favor of JOH, was a purely technical problem (page 6).

Criterio published the reaction in form of a press release by Libre. The main media concentrates on a comment by the EU mission to create a special commission to follow up on their recommendations.

Olivia Zúniga makes an apt comparison between his treatment and the one of political prisoner Edwin Espinal. The former accused of being part of the operation behind the murder of Berta Cáceres and with links to the drug trafficker Rivera Maradiaga, the latter criminalized for protesting against electoral fraud. Guess who awaits trial in a "maximum security" prison...

The date of his initial audience, meanwhile, has been changed to tomorrow. CEJIL published a press release on the arrest and coming trial.

According to them, it backs up the work done by GAIPE which highlighted the collaboration between DESA and the Honduran state in criminalizing and repressing the resistance against Agua Zarca.

InSight Crime also reacts to the arrest calling it a "step in the right direction" but also highlighting that it "represents just one part of a much larger network of individuals involved in the crime who are still at large."

The UN High Commissioner for Human Rights published its report on the "[h]uman rights violations in the context of the 2017 elections in Honduras". "The analysis conducted by the OHCHR Office in Honduras reveals that the State's response to the post-electoral protests led to serious human rights violations. OHCHR found that elements of the security forces, especially the Military Police of the Public Order and the Army, used excessive force, including lethal force, to control and disperse protests, leading to the killing and wounding of protesters as well as passers-by. At the time of completing this report, on 27 January, OHCHR had registered that at least 23 people were killed in the context of the post-electoral protests, including 22 civilians and one police officer. Based on its monitoring, OHCHR considered that at least 16 of the victims were shot to death by the security forces, including two women and two children, and that at least 60 people were injured, half of them by live ammunitions." The report continues to denounce illegal mass arrests, ill-treatment of arrested people, illegal house raids and a wave of threats and intimidations against "journalists, media workers, social and political activists". It denounces the impunity as no state security forces have been charged. Reuters reported on the report citing U.N. High Commissioner for Human Rights Zeid Ra'ad al-Husseini: "The already fragile human rights situation in Honduras, which suffers from high levels of violence and insecurity, is likely to deteriorate further unless there is true accountability for human rights violations, and reforms are taken to address the deep political and social polarization in the country". ConfidentialHN published a short interview with Maria Soledad Paso, the representative of the UN Human Rights Office in Honduras. Padre Melo highlights the importance of this report in revealing the criminal role of the JOH regime. In the defensive, the Human Rights Secretary Karla Cueva told the press that they had investigated 22 cases and handed over to the MP. And just to highlight how the main press reports on this. Yesterday, the third meeting to prepare a possible dialogue took place at the UN. The next round of conversations will take place on April 5. One demand of Salvador Nasralla, which he had voiced on several occasions, was that the results of a dialogue would be binding. Apparently, he was successful.

But just moments later, a comment by Ebal Díaz, the Minister of the Presidency, raises questions again.

Nasralla's participation, i.e. the participation of his delegate, caused disappointment in Xiomara Castro accusing him of legitimizing the JOH regime.

Manuel Zelaya reminds him of the agreement signed between him, Libre and Pinu. While he agrees with the objectives of Nasralla, as Castro he does not believe Nasralla chose the right way to reach them by participating in the dialogue under the current circumstances. It seems important to highlight here that when the main media reports on the situation between Nasralla and the rest of the Opposition Alliance, it represents it as an unsurmountable dispute, while alternative media outlets show that it is rather a dispute about tactics, not the general strategic goals.

Nincy Perdomo believes that the pre-dialogue revealed three things so far. First, Salvador Nasralla and Luis Zelaya have come closer. Second, at the same time, Nasralla's and Zelaya's position diverged (the scope of which is debatable). Third, JOH has profited from this, as he disappeared to some extent from the line of fire.

Luis Zelaya presents three points that came out of the pre-dialogue. The announcement to create a commission accompanied by the UN Human Rights Office in Honduras to investigate the post-electoral human rights violations . The agreement that the results of the dialogue must be binding. The need for three mediators, as no agreement on just one was possible.

Regarding the independent commission, a comment by the Human Rights Minister Karla Cueva does not bode well. Lets check if you can spot the problem: "We adopted with all seriousness and responsibility, as a government, the task to create an independent national team."

According to Radio Globo, the Constitutional Chamber of the Supreme Court admitted an unspecified complaint by a group of lawyers against the MACCIH.

The complaint is directed against the agreement on which the MACCIH is based.

According to El Tiempo, the complaint comes from the lawyers representing the "Congresswo/men Network" highlighted for corruption. Both Libre and the Liberal Party reject the admission of the complaint.

For human rights specialist at ERIC, Joaquín Mejía Rivera, this represents just the newest attack against the MACCIH - attacks that will continue until the mission completely stops working.

The group of congresswo/men supporting the MACCIH called for an emergency meeting today.

The same day, Congress approved in an abbreviated manner a reform to the law regulating seizures of goods and properties. Many observers feared that this reform further weakens the possibility to go after corruption.

The National Party failed to condemn the renewed attack against the MACCIH...political will anyone?

Apparently yes, there is political will to stop any meaningful anti-corruption measures. The former state prosecutor Edmundo Orellana highlights that there is no legal reason to have admitted the complaint against the MACCIH, only political ones.

Three US Senators from both parties send a joint open letter to the US Deputy Secretary of State John J. Sullivan expressing their concern regarding the situation of the MACCIH in Honduras.
