Félix Cesario reports the following on yesterday's May Day protests and its following repression: "In almost 40 years of being an active part in the May Day mobilizations in Honduras, absolutely never ('jamás de los jamases') have I seen such repression filled with hate, cruelty and

brutality like I've seen this May Day: black, olive green and blue. Never." Wilfredo Méndez, director of Ciprodeh, says that with the renewed repression, the JOH regime clearly shows its lack of political will to respect recommendations by the UN and the OAS.

There are additional reports on the repression by Pasos de Animal Grande, with a focus on the tools of repression, and C-Libre.

C-Libre denounces various instances of repression against journalists, camera operators and photographers by state security forces on May Day. Since 2001, 75 journalists have been murdered, 65 of them in the last eight years. Only six cases were successfully resolved, which leaves us with an impunity rate of 92%.

UN Special Rapporteur on Freedom of Expression has published together with rights expert a joint declaration "to mark World Press Freedom Day on 3 May, [emphasizing] the essential role of independent media in democratic societies, and express grave concern about physical attacks on journalists, as well as surveillance, marginalization and squeezing out of independent outlets around the world."

MADJ published an alert yesterday as the community of Pajuiles was being surrounded by the police and TIGRES special forces threatening an eviction of their protest camp against the hydroelectric project by HIDROCEP. The Pajuiles community and four more in the region should benefit from special protection measures granted by the IACHR. Even worse, the day before, a judge denied the motions by the government and HIDROCEP to establish a permanent police presence to guarantee free movement and to evict the camp.

According to reports by Radio Progreso and Defensores en Línea, the state security forces used tear gas to disperse the inhabitants and at least one person was arrested.

Good news from Honduras: "Minutes ago, a judge ordered that 8 of 21 political prisoners will be let out of prison. The charges against them have not been dropped but they will be free while awaiting trial. They are all from the community of Pimienta. 7 are held in terrible conditions in maximum security prison, El Pozo and Lourdes, the only female political prisoner is held in Tela. Over the next few days, the 8 will be released." (hat tip to Karen)

This decision was taken after months of international pressure including international civil society delegations traveling to Honduras to find out about the situation of the political prisoners.

COFADEH denounces that its monthly public commemoration of the forcefully disappeared was harassed by the Military Police. They took pictures of the participants and intimidated them.

COFADEH, nevertheless, read its press release which denounces the renewed attacks by state security forces against Hondurans this week; be it on May First or later in the week in Pajuiles against inhabitants protesting against a hydroelectric project. All of this is happening under the eye of an international community that should be on high alert, at least since the post-electoral violence showed once more the true face of the regime to the public.

What has been feared for some time became reality yesterday, the Trump administration canceled the Temporary Protection Status (TPS) for Honduras. "Tens of thousands of Hondurans who have lived in the United States for up to two decades must prepare to leave, government officials announced Friday, a decision that effectively spells the demise of a humanitarian program that has protected nearly half a million people who had sought refuge from unstable homelands. (...) Hondurans in the program have until January 2020 to get their affairs in order and depart." The US chargé d'affaires Heide Fulton claims that this decision won't affect the US-Honduras relationship.

Manuel Zelaya proposes to cancel the contract with the US for their Palmerola airbase.

There is widespread coverage of the decision in the Honduran media landscape.

The media outlets close to the government emphasize that Hondurans have time until 2020 to get a legal status and that JOH and his wife promises to help them.

As previously announced, the Opposition Alliance took to the streets again yesterday to protest against the illegal reelection, but also the violent repression by state security forces on May Day.

As a reaction to the human rights violations of the JOH regime as part of the post-electoral violence, a call for divestment has been launched. The call entails funding for the Honduran security forces as well as investment to "to international finance institute loans to Honduras meant to support industries that are damaging the social fabric, displacing communities, and destroying the environment." The campaign further demands that the Honduran regime takes the following steps: " i) Investigate and prosecute incidents in which protesters were killed following the re-election of President Juan Orlando Hernandez; ii) Withdraw the Military Police, responsible for the majority of those killings, from crowd-control functions and immediately begin phasing them out. Created in 2013 when Juan Orlando Hernandez was head of the Honduran Congress, the Military Police were meant to be a temporary force. Instead, the force has steadily grown; and iii) Prosecute attacks on and murders of journalists, opposition leaders, and human rights activists."

Rights Action reports on yesterday's hearing in the case of the political prisoner Edwin Espinal: "[He] had his hearing today in a military controlled "court-room" on a military base (Cuartel General Las Cabanas, Tegucigalpa) and the judge took almost no time at all to deny him bail whatsoever, left alone house arrest, etc. Edwin -jailed in a military prison- was not present in the so-called "hearing". The judge only allowed a few people (officials from the UN, Canadian & US embassies) to enter the courtroom, aside from the lawyers. No human rights observers or media allowed."

ContraCorriente started a special section to report on the political prisoners. Part of this is a collection of photos of family members

showing their imprisoned loved ones.

In the first article of this section, ContraCorriente journalist Jennifer Ávila looks at the use of the term political prisoners. Some fall through the cracks because of the government's successful attempt to call some of the arrested persons gang members and human rights organization fear defending them could lead to the further criminalization and denigration of human rights organizations. "Having carefully considered the information received from the Government, civil society and other stakeholders, I regret to conclude that, despite strong efforts to establish an effective mechanism of protection, the vast majority of human rights defenders in Honduras are not able to operate in a safe and enabling environment. (...) I would like to conclude by saying that there is still a gap between international engagement and domestic implementation. I would like to express my continued commitment to provide technical support to the Honduran authorities. As we celebrate this year the 20th anniversary of the United Nations Declaration on human rights defenders, I would like to invite the Honduran government to take strong actions against impunity and for the recognition of the role that human rights defenders play here in Honduras and across the world." Forst emphasized at the end of his presentation that he will return to Honduras to help find solutions to the numerous human rights violations he was made aware of.

Probably as a product of national and international pressure, Congress' president Mauricio Oliva suddenly announced that the Article 335-B will not be part of the new Penal Code. This means it is still in place throughout this year, but not anymore once the new Penal Code comes into force. The Penal Code, whose content is treated like a state secret, is currently with JOH and should be published in La Gaceta afterwards. The way Oliva presented this decision could not have been more cynical. He called it "as a token of appreciation for the journalists on their day". The president of the Journalists Association Honduras (CPH) says that this is not a gift, but rather a correction of a past mistake. Vice-president Ricardo Álvarez said that it should have never been created in the first place.

OACNUDH expresa su satisfacción por la conclusión del Proceso Judicial por el asesinato de dos jóvenes Garífunas ocurrido en diciembre de 2015

Tegucigalpa, 25 mayo de 2018. La Oficina del Alto Comisionado de las Naciones Unidas para los Derechos Humanos (OACNUDH) en Honduras saluda gratamente la conclusión del proceso judicial relativo al esclarecimiento de los hechos del 27 de diciembre de 2015, en los cuáles fueron asesinados dos jóvenes, Yosvin Palacios y Elvis Armando García, ambos miembros del pueblo Garífuna, en el sector conocido como la Barra del Puerto de Iriona, Colón. Tras la realización del juicio oral durante ocho días en el mes de mayo del presente año, el Tribunal de Sentencia de Trujillo, Colón condenó a diez efectivos navales por el asesinato. Según el Ministerio Público, los dos jóvenes "fallecieron a raíz de múltiples disparos ocasionados por parte de los soldados del Segundo Batallón de Infantería de la Marina asignados a este sector, los que abrieron fuego en contra de la humanidad de las víctimas suponiendo erróneamente querer éstos ser encontrados en labores de narcomenudeo"¹.

El trabajo de investigación, procesamiento y sanción de este delito representa un paso muy importante por parte del Ministerio Público, y en particular de la Fiscalía de Etnias, y del poder judicial, con respecto al acceso a la justicia y la lucha contra la impunidad en casos que afectan a miembros de pueblos indígenas. La Oficina desea destacar la importancia que los procesos penales desarrollados para la investigación y la sanción de delitos cometidos contra integrantes de pueblos indígenas, garanticen la inclusión de enfoque diferenciado en relación a la pertenencia de las víctimas a pueblos indígenas, siendo para ello central contar con la participación de la Fiscalía Especial de Etnias y Patrimonio Cultural, en la conducción de las investigaciones y el desarrollo de los procesos.

Cada 25 de mayo se conmemora el Día del Periodista en Honduras, un día para celebrar los principios fundamentales de la libertad de expresión, reflexionar sobre la situación de la libertad de prensa en el país, defender los medios de comunicación de los ataques contra su independencia, y recordar a las y los periodistas que han perdido la vida en el cumplimiento de sus labores.

Las y los periodistas desempeñan un rol estratégico en el proceso de informar y sensibilizar a la sociedad sobre los derechos humanos. Este papel es un gran desafío para realizar su tarea con profunda responsabilidad social, conscientes de su capacidad de incidir en la agenda pública, al tiempo de colaborar con el desarrollo de la sociedad. Por ello, para la OACNUDH es fundamental que las y los periodistas estén informados, comprometidos y capacitados desde una perspectiva que contemple los estándares internacionales de derechos humanos.

Los ataques contra periodistas vulneran los derechos humanos de las personas y socavan la libertad de información y expresión en las sociedades. La impunidad en esos casos es generalizada, hecho que empeora una situación ya de por sí terrible. En su reciente visita al país a principios del mes de mayo, el Relator Especial sobre la situación de defensores de derechos humanos, Michel Forst, mostró su preocupación sobre la situación de la prensa hondureña; "Durante mis reuniones con periodistas y comunicadores sociales, he escuchado con preocupación sus testimonios y su experiencia de acoso, intimidación y violencia en manos del ejército y la policía nacional por filmar o cubrir protestas, en particular durante la crisis postelectoral y en relación con manifestaciones de estudiantes. Los periodistas también han compartido su experiencia de haber sido objeto de campañas de descrédito y difamación, así como de amenazas de muerte, muchos de los cuales viven en una situación financiera precaria por no beneficiarse de contratos de trabajo permanentes. Llamaron mi atención la Ley de Secretos Oficiales y cómo esta limita su acceso a la información oficial".

La libertad de expresión es esencial para la velar por la transparencia y responsabilidad de las instituciones estatales. Es por ello, que en una fecha tan significativa como hoy, y en seguimiento a una de las recomendaciones realizadas previamente por la Oficina, la OACNUDH celebra el anuncio realizado por el Presidente del Poder Legislativo de una reforma legislativa para derogar el artículo 335 B del Código Penal, un avance de alta importancia en las garantías que el Estado debe brindar sobre libertad de expresión.

Desde la OACNUDH, hacemos un llamado al Estado Hondureño para que en el marco legal nacional le garantice a las y los comunicadores el poder ejercer su labor de una manera responsable y segura, sin limitar su derecho a la libertad de expresión y el acceso a la información.

La OACNUDH reitera su apoyo a la prensa hondureña en la defensa de la libertad de expresión e insta a las autoridades nacionales, a la sociedad civil, a los medios de comunicación y a la población en general a que se comprometan a hacer todo lo posible para que las y los periodistas de todos los medios presentes en Honduras puedan ejercer su labor de forma libre y digna. Cuando se puede hablar sin riesgo, toda la población se beneficia.

The article concludes by addressing the situation in Honduras: "The situation in Honduras, however, is shaping up to be even more convoluted than that of Guatemala. It has to do with control mechanisms that US Congress has already approved, including certifications in the Alliance for Prosperity plan created during the administration of former US President Barack Obama. The plan puts conditions on aid disbursement for the advancement of anti-corruption and anti-crime efforts.

In 2017, however, the effectiveness of these certifications came into question. The US State Department approved the release of aid to Honduras, certifying that its government had been "fighting corruption and supporting human rights" in the aftermath of a severely contested election marred by fraud allegations that saw President Juan Orlando Hernández assume office for a second term.

Although legislative measures such as those recently approved have given a voice to nascent efforts to tie the hands of corrupt officials, Washington's contradictory messages raise doubts about their real effectiveness."

It is still not clear to me, if this ruling also affects the MP's anti-corruption unit UFECIC. The official challenge was launched against the MACCIH, but out of this came a challenge against UFECIC claiming that it has no legal basis.

The emotional roller-coaster regarding the anti-corruption struggle continues. On Tuesday, it was, wrongly, said, that the Supreme Court is about to declare the MACCIH partially unconstitutional. On Wednesday, the Constitutional Chamber presented its verdict that the MACCIH's legal basis is constitutional after all. Nevertheless, it was not clear what this meant for the MP's anti-corruption body UFECIC. Yesterday, the Constitutional Chamber announced that the creation of the UFECIC violates legal norms established in the Constitution and the Organic Law of the MP. According to ConfidencialHN, this is a definitive resolution with no more legal options to challenge it. CNA director Gabriela Castellanos denounces that this offers protection to the corrupt and that it shows on which side the Constitutional Chamber is. She goes on to say that the MACCIH without its MP counterpart does not make much sense.

Radio Progreso calls for the defense of the MACCIH and its functionality.

The National Party tries to divert attention from them. Its president Reinaldo Sánchez says that many commentators say one thing publicly and another thing in private. Interestingly, he does not speak out in favor of the MACCIH but rather reiterates their support for the MP.

JOH pretends all is well now.

The Supreme Court, meanwhile, claims that its ruling does not limit the work of the MACCIH nor the one of the UFECIC...

Libre congressman and member of the Parliamentary Front in Support of the MACCIH, Yahvé Sabillón, does not agree.
