At the same time, he recognizes that they came about only on the day the IACtHR delegation came to Honduras and, therefore, more international pressure will be needed.

MADJ reports of a successful legal challenge presented by them against the hydroelectric project Los Planes by HIDROCEP. The court ordered the municipality of Tela to stop the construction work on July 30.

In the beginning of this year, the Energy, Natural Resources and Mining Secretariat (MiAmbiente) nullified a request by the Environmental Committee of the Siria Valley to stop the geothermal project 12 Tribus. Since then, their situation has worsened and the committee denounces a pressure campaign by the company to have local inhabitants sell their land to them. The committee now filed an appeal for reversal of MiAmbiente's initial decision.

El Pulso denounces that the supposedly purged National Police Force still has not understood the work of journalists.

A group of Journalism university teachers denounce the attack as lack of

the respect for life and freedom of press.

Claudia Mendoza reminds the police of their motto "to serve and protect". C-Libre now denounces that a second reporter was attacked by the police while covering the same protest on Wednesday. Emilio Flores who works as a cameraman denied handing over his camera to the police and was physically attacked as a response.

Criterio reports that of the more than 255 complaints of attacks against journalists presented since 2015, more than 99% rest in impunity.

After a five-day visit, the IACRH delegation shared some preliminary findings with the public. They found that the "structural impunity and the corruption have eroded trust in public institutions". Furthermore, they expressed worries about the misalignment of power between the three pillars of state power. One evidence of this was the illegal re-election of the Attorney General, which the IACRH also questioned in their report. The IACRH reiterated their demand that the Honduran State make progress in the investigation into the post-electoral human rights violations and that they will closely observe this process. Their report ends with no less than 25 recommendations.

Honduras Daily: IACRH; Bajo Aguán; and the Unattended Push Factors of Migration

With the ending of the five-day visit to Honduras by the IACRH delegations and the recommendations made, Defensores en Línea reflects what impact they can have in a country like Honduras which goes beyond just institutional weakness, but rather suffers from "an illegal government and a broken constitution". They fear that making "democratic recommendations to a dictatorship under the tutelage of the US embassy" won't suffice.

Criterio dedicates various articles to topics especially highlighted by the IACRH, i.e. the lack of attention by the JOH regime to those forcefully displaced by violence; the nefarious impact of a military culture best represented by the militarization program for children, the Guards of the Fatherland; and how the high impunity rate in cases of femicide further spurs violence against women.

Proceso Digital published the first reaction by the JOH regime to the preliminary findings. The Presidential Minister Ebal Díaz speaks of historic and structural reasons causing problems in the country that need time to fix, cynically overlooking that it is the regime-of-the-day that ordered the state security forces to shoot into the protesting crowds during the post-electoral protests.

With the approaching of the first oral and public trial date in the case of Berta Cáceres, Giorgio Trucchi fears that the JOH regime will do anything to prevent a legal precedent.

When the IACRH delegation presented its preliminary findings last Friday, they also mentioned the case and expressed concerns regarding the lack of access to information for COPINH and Berta's family.

MADJ wrote an open letter to the IACRH in light of its recent visit to Honduras last week. They thank them for coming, emphasizing the importance of international preoccupation about the human rights situation in Honduras. "However, despite this recognition we must indicate in an honest and constructive manner that we are concerned

about absences, the generic nature and, in some cases, the unfounded and confusing assessments and recommendations issued by the IACtHR in its preliminary observations on the on-site visit to the country." Radio Progreso summarizes some of the most important recommendations by the IACtHR.

The Human Rights Secretary Karla Cueva reacted to the recommendations by spreading the responsibility to implement them as wide as possible.

One of the recommendations by the IACtHR causing confusion regards Article 184 of the criminal procedure code. It regulates for which crimes someone can be held in custody while awaiting trial. This article made headline news because officials accused of corruption in the Pandora case wanted to get rid of it and now the IACtHR recommends something similar because it violates international norms. The Article itself is rather recent and was established in 2013 when JOH was president of Congress. The article by ConfidencialHN offers an overview and the open letter by MADJ (linked to above) also offers some important comments on why this recommendation at the current time may be harmful.

Out of the blue, a higher court revoked the alternative measures to imprisonment for the former members of the Judiciary Council and ordered they preventive imprisonment last month. So far they still haven't gone to prison and their legal teams now presented new appeals with suspensive effect.

Maybe inspired by the IACHR delegation or by recent statements coming from the Liberal Party, voices grow again claiming that the dialogue is about to start. We have heard this now for months without any substantive progress.

One obstacle was that the JOH regime did not want to make the agreements coming out of the dialogue binding. Now, he suddenly announced that the results will be binding BUT at the same time, he nominated his close allies Ebal Díaz, the Presidential Secretary, and Leonel Ayala, the Governance Secretary, as the two people to approve the recommendations coming from the dialogue.

Consider, by contrast, coverage of Honduras. The country is hardly lacking in characteristics associated with a "regime." (...) According to a Factiva search, the phrase "Honduran regime" has never appeared in the Times, Journal and Post in the years following the coup, and collectively they used the

phrase "regime in Honduras" once: It appeared in a Washington Post article (3/31/16) about the assassinations of Honduran indigenous leader Berta Cáceres and other environmentalists in the region, in a quote by a professor critical of US support for Latin American dictatorships.

While Honduras's three post-coup presidents have governed a country where "impunity for human rights abuses remains the norm," according to Human Rights Watch, these leaders have almost never been described as running a "regime." A Post editorial (9/5/09) included the only appearance of "Micheletti regime" in any of the three papers. "Lobo regime" returns zero search results. The New York Times (2/16/16) has used "Hernández regime" once, but Factiva indicates that the Post and Journal never have. Searches for "regime in Tegucigalpa" or "Tegucigalpa regime" produced zero results."

The debate about the Article 184 of the Criminal Procedure Code goes into the next round (see also yesterday). The MP emitted a statement that the article does not violate constitutional nor international law ratified by Honduras. This seems to take away part of the argument build up by the defense teams officials accused of corruption. Previously, the US embassy, i.e. its chargé d'affaires Heide Fulton, tweeted that they are closely observing Congress and its attempt to reform the Article 184. They also linked to a MACCIH press release from the previous day denouncing the reform as weakening the fight against corruption

The National Anti-Corruption Council (CNA) told the press yesterday evening that the main driver to derogate or reform the article is fear by those facing corruption charges.

Congress' president Mauricio Oliva initially, i.e. before Fulton's Tweet, told the press that the reform represents a sovereign decision by Congress.

Then afterwards, both he and the National Party seemed to take a step back speaking of consulting various sectors before taking a decision.

The U.S. State Department is likely to claim that Honduras is complying; never has the State Department done otherwise. But international human rights experts and Honduras' own governmental human rights office, CONADEH, have consistently found that the work of human rights defenders and other civil society activists has been impeded in Honduras, often directly by government agents. Various international organizations have called out the U.S. government's continued certification of Honduras as a direct interference into the work of defenders and civil society activists who are facing egregious levels of violence for the work that they do."

At the final rally of the protests, Padre Melo announced a plebiscite for the coming months in all regions of Honduras to return to a constitutional order. After three months of preparation, it should take place in November and include three questions on restoring the constitutional order; the economic model of extractivism, and whether JOH should stay in power.

COFADEH together with about a dozen other human rights organizations published a statement demanding the immediate resignation of JOH, the release of the five remaining political prisoners and that all the charges are dropped against all of the criminalized protesters. They further demand justice for the 34 victims documented by COFADEH during the post-electoral repression.

The US-Canadian Honduras Solidarity Network published an call of solidarity.

CLALS has published its newest and fifth edition of the MACCIH Monitor covering the time of May 1 to July 31, 2018. "The sum total of these events is that, after passing through several weeks this spring when its relevance and even existence were in doubt, MACCIH seems to have regained its footing. It has shown a relevance with the Pandora case, indicting very senior political elites. In contrast to the initial indictments of the Legislators' Network case from December, those arrested were mostly officials of the two main traditional parties and include party leaders. (...) However, the obstacles the mission faces have not waned, as seen in the Pandora case. The announcement (after this period covered by this MACCIH Monitor) of a legislative initiative to reduce preventive detention for many serious crimes – including homicide, kidnapping, extortion, drug trafficking – in order to let officials and legislators go free while accused of corruption, shows the levels that those favoring impunity will go."
