## Honduras Daily: Berta - Trial; Transparency; Death Squads; MP; Bajo Aguán; Journalists; Right to Protest; and Streets Merchants vs. Police

Yesterday, the second day of the evidentiary hearing took place. It was supposed to be a two-day hearing, but it will continue on Monday. Omar Menjívar, who represents both Berta's family and COPINH, published a short 2-min video update on the hearing.

COPINH denounces that personnel at the Supreme Court of Justice discriminated against members of COPINH, limiting their access to the building and checking their bags while letting other people go through unchecked. COPINH denounced this to the judge on Friday, but she said that the security personnel of the Supreme Court was not her jurisdiction... COPINH published a suspicious comment by the lawyer of one of the accused regarding COPINH's demand to have members of the Atala Zablah family questioned during the trial. The members in question are in the Administrative Council of DESA and are said to have been in close contact with Sergio Rodríguez Orellana and Douglas Geovanny Bustillo. The lawyer denounced this as an attempt to have witness testifying to incriminate themselves. COPINH's rightly asks what the lawyer knows about the culpability of the family members.

Sergio Rodríguez Orellana's lawyer, meanwhile, demanded that the trial should not focus on DESA, but on the accused individuals. Rodríguez Orellana is a DESA engineer and Douglas Geovanny Bustillo the former head of DESA's private security team.

The murder of two students after having been seized by three men sporting ATIC gear, caused a heated debate on death squads. C-Libre denounces that the two students had participated in the protest march on Thursday and afterwards they were taken.

Libre published a press release writing that death squads controlled by the JOH regime murdered the two students.

Investigative journalists Wendy Funes makes the link to the murdered regional head of ATIC, Sherill Yubissa Hernández, which ATIC officials wanted to portray as a suicide but forensic medicine contradicted this version.

El Pulso links the debate about death squads to the recently declared war on the Maras and Pandillas.

ATIC's press speaker claims that they weren't real ATIC agents.

COPINH will hold a press conference today at 10am in Tegucigalpa to give an update on the evidentiary hearing and launch the campaign "DESA: Guilty" to highlight the complicity of the company in Berta's assassination. The legal team accompanying Berta's family and COPINH presented a writ of amparo against the court resolution denying members of COPINH the status of victims in the murder trial.

The court further rejected the demand to have the owners of DESA and the Atala Zablith family testify.

Human rights organizations held a rally outside the UN building in Tegucigalpa demanding an exhaustive investigation into the murder of the two students Gerson Meza and Mario Suárez. They were arrested after participating in an anti-government protest on August 31 by alleged ATIC agents and murdered shortly afterwards.

The mother of Gerson Meza said that after the arrest they were called by the tribunal to be present for their arrest. This contradicts the State's claims that they were not involved.

COIPRODEN calls out to journalists and media outlets to abstain from hate and smear campaign against the young. The two murdered students were denigrated by some media outlets as gang members.

Their murder caused a new discussion about death squads in Honduras. Oscar Miguel Marroquín argues that they have never really disappeared. And in the midst of this, students fear being persecuted as ATIC agents appeared at a high school asking for five students.

The former UNAH lecturer and Honduran writer Galel Cárdenas holds the JOH regime responsible for the situation, a regime that does not even allow dissent from poor students protesting for lower public transport fares so that they can afford to travel to university.

As a response to these recent murders, Libre demands that state security forces no longer can cover their faces.

The MP and ATIC denied sharing information with El Tiempo regarding which agency will investigate the murder of the students.

They go on to denounce the lack of investigation into the intellectual authorship by the MP and the dozens of complaints filed by Berta Cáceres before her death. The Coalition against Impunity condemns the defamation and misinformation campaign against COPINH by DESA using a private law practice.

The director of CESPAD, Gustavo Irías, provides an analysis of US interests in the fight against corruption in Honduras. This question rose to prominence once more when both the headquarters of the National and Liberal parties were searched by ATIC. "However, their [US'] current interest in national security requires them to corral and displace a sector of the traditional elite, probably the most corrupt and, therefore, the most uncomfortable one. But that does not mean facilitating the modification, nor putting at risk, the status quo prevailing in Honduras, which is functional to US interests. For that very reason, in the end it is not a simple strategy against corruption, rather there is an interest in reconfiguring the internal political forces. Hence, it was not a coincidence that the seizures [of the party headquarters] coincided on the same day and time, with the signing of the agreement to start the political dialogue between the National

Party, the Liberal Party and Salvador Nasralla." It is worth to read the his complete analysis, the gist of which is that the US is trying to build a political opposition close to their interests consisting of the Liberal Party (in the hand of Luis Zelaya and, therefore, they need to weaken his internal rival Elvin Santos) and Salvador Nasralla, while weakening Libre.

Two days later, armed men entered his apartment taking with them his computer and files about documented cases of human rights violations (see also yesterday's e-mail).

Already in recent weeks, the JOH regime announced measures to increase the participation in the official State march on September 15, e.g. by forcing students who receive scholarships to participate. But with the recent headlines of murdered students, more and more students announced not to participate. The government reacted by offering prizes for the best presentations during the marches, 21 prizes in total. The first prize is a trip for 170 students to Roatán.

At the same time, the Education Secretary, Marcial Solías, reitaretas that the participation at the alternative march (which exists since the coup d'état) is forbidden and slogans such as "Fuera JOH" will not be tolerated.

La Prensa seems to confirm this. At the same time, the article in La Prensa shows that they won't go quietly. The mining company further denigrates and criminalizes the local protesters and human rights organizations and blame them that international investors will go to other countries and 2000 people will lose their jobs.

He was covering a student protest, when two police agents attacked him without warning, spraying tear gas directly into his face. According to the protection mechanism for HRDs, he should benefit from special state protection...

With the announcement of the mining company Inversiones Los Pinares to close shop in Guapinol, a new smear and criminalization campaign started against social movements and HRDs (see also yesterday). According to FOSDEH, mining is responsible for only 0.67% of GDP and employs 0.0005% of the active labor force. Its social and environmental impact, meanwhile, are enormous.

As with many defamation campaigns before, Presidential Minister Ebal Díaz does not allow the local communities to have any agency, rather they speak of "external forces" which are behind the protest.

Probably not by accident, the same day the infamous president of AHPER, Elsia Paz, denigrates all social movements opposed to hydroelectric projects, claiming that they are violent and they cost Honduras millions of foreign investment.

The last human rights monitor by the Honduras Forum Switzerland (August) highlighted two important developments in the fight against corruption. First, an appeal to the Constitutional Chamber by Congress' president Mauricio Oliva to protect him from a corruption investigation. The chamber had accepted his request, but not in one voice, so the plenary session of the Supreme Court had to decide, which they did yesterday. The Supreme Court ordered the suspension of the investigation by UFECIC. They have to inform him now in detail about the investigation. Criterio thinks that many officials and congresswo/men investigated for corruption will demand the same treatment. Second, in one of the rare moments of hope regarding anti-corruption efforts, a higher court revoked the alternative measures to imprisonment for the former members of the Judiciary Council and ordered their preventive imprisonment in August. Nevertheless, the month ended with an ominous statement by the president of the Supreme Audit Court (TSC), Jose Juan Poneda. He declared that the process against them should rather be of administrative instead of penal nature. Yesterday, the Supreme Court decided that all the accused can leave pre-trial detention.

Since the coup d'état in 2009, there have always been two parallel marches, one by the regime, one by civil society and the opposition. State security forces repressed the popular march both in Tegucigalpa and San Pedro Sula.

In Tegucigalpa, C-Libre reports on the arrest of at least 6 protesters. C-Libre denounces that UNE-TV journalists and camerapersons were attacked by the police and soldiers covering the march and its repression.

During the celebrations of the official march, a tear gas grenade went off in the National Stadium causing chaos.

Even before the trial in the murder case of Berta Cáceres and the attempted murder of Gustavo Castro started, COPINH sent out an alert that DESA has paid protesters to seek a confrontation with them in front of the Supreme Court. The police did not intervene.

Furthermore, COPINH presented legal challenges against the judges of the trial court because "[t]he three judge panel responsible for this case has failed to guarantee our rights as victims and even the rights of the accused by allowing the Public Prosecutor to conceal information, and as a consequence, the truth, showing partiality constitutive of a crime."

Then, as the trial finally began, it was suspended again within 10 minutes. The judges failed to give a new date. This raises many problems, one is that Honduran law does not allow for pre-trial detention longer than 2.5 years without an actual trial. Four of the eight accused reach this limit by November 2.

Before the suspension was made public, InSight Crime had written that "[t]he murder trial of environmental activist Berta Cáceres in Honduras could open a small window into the nexus between criminal networks and elites, but will more likely illustrate just how difficult it is to prosecute powerful families."

COHEP just yesterday held another press conference presenting human rights organizations as the main obstacle for millions in investment in Honduras. This is just one of many press conferences and press releases on this topic in the last few weeks.

The Supreme Electoral Court (TSE) requested that the Liberal Party presents them proof of wrongdoing by the 17 congresswo/men facing expulsion (see e-mails of the last few days).
