Honduras Daily: HRDs - Impunity; Dr Trafficking - JOH; Journalists - Crminalization; Electoral Reforms; and Rich but Unuseful

The UN Special Rapporteur on the situation of human rights defenders, Michel Forst, published presented his newest report to the UN focusing on HRDs and impunity. In the case of Honduras, it highlights the lack of coordination between the protection mechanisms and investigative bodies and the general focus on material authors of crimes as seen in the case of Berta Cáceres. He concludes: "This is insufficient to combat impunity and is problematic, as it does not identify powerful groups which may be behind human rights violations. Such failure also increases mistrust of justice systems."

In today's trial, Tony Hernández' brother and sister-in-law will be present in New York.

They all claim his innocence.

El Heraldo and ConfidencialHN report that the state attorney trying the case has warned the court about the strategy by the defense to have several pieces of evidence dismissed.

Expediente Público published a two-part investigation into JOH and his links to criminal structure. The first article focuses on JOH's planes, possibly bought with drug money, and the second article focuses directly on Tony Hernández and his government accomplices.

ConfidencialHN, meanwhile, writes that the US Justice Department requested an investigation into a group of politicians and businessmen linked to Tony Hernández.

Honduras Daily: Berta - Impunity; Drug Trafficking - JOH; MACCIH; and Ten Years of Persecution

"43 months have passed since the murder of our compañera Berta Cáceres, 43 months of not giving up in this search for justice. 43 months of resisting this system that tries to hide the truth and keep murderers in impunity. 43 months of rebellion, dignity and struggle."

After months of anticipation, the trial against JOH's brother Tony Hernández started yesterday. The Pro-Honduras Network offers a live coverage of the trial, which Aquí Abajo helpfully summarized and will continue to do so for the remainder of the trial. Yesterday, the 18 jurors were selected and sworn in and the prosecutor and the defense gave their opening statements. The prosecutor - "Mentioned that Juan Antonio Hernandez and Juan Orlando Hernandez as being involved in drug trafficking" - "Mentioned that Juan Orlando Hernandez had received millions of dollars of bribes including from El Chapo, which Tony Hernandez helped deliver to his brother" - "Made a specific point to mention Juan Orlando Hernandez as the President of Honduras but also a co-conspirator to traffic drugs into the U.S. Part of the material that the Prosecutors will present is a weapon that has Juan Orlando Hernandez's name engraved on it" - "Made a clear argument that the main reason that Tony was able to operate as a drug trafficking in Honduras was because of the protection given by his brother, JOH. Tomorrow, this will be proven by one of the first witnesses".

The trial was covered widely by the national and international press focusing on the part of JOH receiving drug money. JOH tried to challenge this by alleging in a press release that the prosecutor never really said that he, JOH, received anything.

Journalist Jeff Ernst tweeted: "Either all the journalists who were present at the court are liars, or it is true that the prosecutor said that President Hernandez had received millions of dollars from drug traffickers." And then he also published excerpts of the transcript.

InSight Crime titled its coverage "The US Drug Trial Evidence That Could Topple the President of Honduras" focusing on "evidence and players in the trial that could end a presidency".

The jurors received a list with some 60 names of persons of interest for the trial. On this list is also the current Energy Secretary and, more importantly, the former head of the presidential campaign of JOH, Roberto Ordoñez.

Radio Progreso summarized what has kept JOH in power these last years, i.e. his three "oxygen valves". "The first oxygen valve, and the one with the greatest capacity to grant air, is the installation of the electoral process as a way out of the political crisis that has been dragging on since the November 2017 elections, and probably much earlier. (...) The issue here is that the dictatorship led by Juan Orlando Hernández has received a boost from the Honduran political network in his eagerness to place the electoral route as a way to resolve the crisis. (...) The second oxygen valve comes from the administration of the United States government that reached its peak in the short but symbolic encounter between Trump and Juan Orlando Hernández at one of the UN sessions in New York. There is no doubt that it was the encounter between two gangsters. (...) The third oxygen valve that keeps the dying dictatorship alive is the opposition of the social movements, with a lot of commitment at the base, and a coherent and radical discourse, but caught in the tangles

of mistrust, prominence, suspicion, and therefore easy victims of the fierce repression driven by the dictatorship."

Honduras Daily: Berta - Trial; Drug Trafficking - JOH; IACHR - HR; Tolupanes; and No Questions!

The preliminary hearing against David Castillo will continue next Thursday, October 10, at 9am in Tegucigalpa. The hearing against David Castillo was supposed to be held on September 25, but it was suspended because his defense said he could not appear, without justifiable argument. The judge decided to reschedule it. According to COPINH, the evidence that links him to the murder is clear and these actions are part of a search to delay the process against him and hide the truth.

InSight Crime concluded after the first day of trial against Tony Hernández that "prosecutors won't be afraid to also point the finger at President Hernández for his alleged role in his brother's drug conspiracy". Day two continued in this vein.

Prosecutors presented evidence "from a supposed 'drug ledger' seized last year which allegedly documents part of the cocaine dealing by" Tony Hernández. (...) The notebooks also detail payments to someone identified as "JOH," which are the initials widely associated in Honduras with Juan Orlando Hernandez, as well as his "employees." Univision requested a comment from President Hernandez regarding the ledgers but did not receive an immediate response."

There was also a testimony by the drug trafficker 'El Rojo' who told the court that he trafficked 140 tons of cocaine with Tony Hernández. Honduras Culture and Politics did the math. "140 metric tons is 140,000 kilograms of cocaine. Cocaine sells for a mean street price of \$14,500 per kilogram in San Diego, CA 140,000 kilograms at \$14,500 per kilogram is more than \$2.03 billion."

JOH allegedly received \$40'000 from El Rojo for his congressional campaign.

In a conversation with Radio Progreso, political analyst Raúl Pineda states that the main objective of the investigation by the US prosecutors is JOH and that there will be another trial, one against JOH, after the end of his presidency.

Nationalist congresswo/men, meanwhile, come to the defense of JOH.

The IACtHR published a new report on the situation of human rights in Honduras. "This report is based on observations made during the in loco visit to the country conducted from July 30 to August 3, 2018, along with other visits by the IACtHR and its Thematic Rapporteurships, in the framework of the monitoring tasks the Commission carries out to fulfil its mandate, using various mechanisms at its disposal including hearings, precautionary measures, petitions, and cases. (...) Honduras is facing critical levels of impunity and provides inadequate, insufficient assistance to victims and their families. The lack of access to justice has led to a structural impunity that perpetuates serious human rights violations—and, in some cases, encourages repeated instances of those violations. Civil society organizations told the IACtHR of the existence of what they see as "selective justice." They argue that this system acts late and fails to respond effectively to human rights violations, and also favors the interests of actors linked to public, political, and economic power. Various challenges persist that weaken independence and impartiality, including the lack of enough safeguards to ensure the independence of judge supervision mechanisms. The Supreme Court continues to exercise excessive control of the system to both appoint and remove judges."

Honduras Daily: Drug Trafficking - JOH, Lobo, El Tigre, Waldurraga; Journalists - Guapinol; MADJ - Atlántida; Migration - US; and Congratulations

The trial against Tony Hernández continued yesterday, day three of the trial took place. Aquí Abajo published a summary of day 2, which came out after my e-mail yesterday.

Yesterday, the interrogation of Víctor "El Rojo" Diaz Morales continued. According to him, JOH and Pepe Lobo received \$100'000 in 2009 for their election campaigns in response to protection of his drug trafficking business and protection from extradition.

He also mentioned further drug traffickers giving money to JOH. Alexander Ardon, Rodolfo Irías Navas, Javier Rivera and Leonardo Rivera.

One of them, Alexander Ardon, will be on the stand next Monday.

On day 3, we also found out more about Tony Hernández's middle-man, Mario José Calix Hernandez. He "is charged in three counts in a separate Superseding Indictment" and he is a "[f]ormer vice mayor of Gracias, Lempira (JOH's home town)" (...) Mario José Calix Hernandez is not only Tony Hernandez's middle-man but he is also, just like Tony Hernandez, a man connected to powerful individuals in the Honduran government".

"Edmundo Orellana [former attorney general], who spoke with Criterio.hn said that so much has been said about President Juan Hernández, it does not necessarily mean that he will be prosecuted, but what has been said, is so serious, that it would be very unlikely that the US federal justice system was not already evaluating the start of a lawsuit against him."

Criminal lawyer Ramón Barrios agrees.

And according to Orellana, Tony Hernández will most almost certainly be found guilty.

The defense, meanwhile, continues to label everything presented as lies.

Honduras Daily: Drug Trafficking - JOH, National Party, Protests, US; LGBTQ; Berta - Trial; Journalists; Armed Forces; MP; Migration - US; and a Seed of Change

The second week of trial against Tony Hernández started yesterday. Monday started with an expert testimony on Honduras by the historian Darío Euraque. Then it was time of one of the key witnesses, Alexander Ardón, the former mayor of El Paraíso, Copán and confessed drug trafficker.

Ardón describes the meeting in which 'El Chapo' Guzmán gave \$1 million to JOH's 2013 presidential campaign and he spoke of further payments to JOH, the former president Lobo and other politicians - \$2 millions in 2009, \$1.5 million in 2013. "All payments Ardón made to politicians were in exchange for protection "against prosecution and law enforcement," according to the prosecution. In fact, no investigation was ever opened against Ardon in Honduras even though his participation in drug trafficking has been widely known throughout the country since at least 2011."

Ardón also said that he bribed three Nationalist congressmen from Copán so that they would vote for JOH to become president of Congress in 2010.

Ardón also mentioned the former head of police Juan Carlos "Tigre" Bonilla, who had already been mentioned last week.

As the week before, he denied it.

Criterio spoke with the former army captain Santos Rodríguez Orellana who was discharged three years ago when he publicly denounced the links between drug trafficking and Tony Hernández.

JOH held a press conference in Honduras denying the testimony of Ardón.

Radio Progreso spoke with the former police commissioner Aldo Oliva about Ardón's testimony and his interpretation. Oliva agrees and he highlights the role of the purging committee in getting rid of police officials who came into the way of JOH and his brother.

Last but not least, Ardón also testified to have supported the National Party, i.e. Lobo and then JOH, in electoral frauds.

Day five of the trial ended with the presentation of a video and the testimony of a DEAD agent who participated in Tony Hernández' arrest in November 2018.

Aqui Abajo published the summary of Thursday's proceedings in the trial against Tony Hernández.

Yesterday, the testimony of the former extradited police officer, Geovani Rodriguez, continued and the testimony of Devis Maradiaga Rivera, one of Los Cachiros, began. The latter said that he handed over \$50'000 to Tony Hernández in 2014 to help him launder the money through the JOH regime. Maradiaga Rivera has audio and video files of the meeting. He also said that he communicated with JOH through an intermediary.

Criterio published one of the videos.

According to his testimony, he also received protection from the Nationalist congressman Oscar Najera. He also bribed the police, prosecutors, judges and politicians, including \$250'000 to JOH directly and an unspecified amount to the current Minister of Security Julián Pacheco Tinoco.

He further mentioned the former president Pepe Lobo.

Last but not least, he spoke about the alleged plan to murder JOH. "Rivera Maradiaga said he met with another major Honduran drug trafficking clan, Los Valles, where a plot to assassinate Hernández's brother, the newly elected president Juan Orlando Hernández, was discussed. Rivera Maradiaga said Los Valles wanted to kill the president because they felt betrayed after they allegedly supported his election in 2013 with large cash contributions in exchange for protection. "Once he arrived at the presidency, he no longer answered the calls," Rivera Maradiaga told the court. Later that year, Rivera Maradiaga said he was contacted by a National Party congressman, Reynaldo Ekonomo, who told him that Juan Orlando Hernández had learned about the plot and offered to help clarify the matter directly with the president in a phone call."

Radio Progreso spoke with criminologist Leticia Salomón who says that Honduras has to be seen as a drug state.

Radio Progreso is hopeful. "This serious situation that puts Honduras back in the international view should generate some positive consequences for the country that has lost all institutional capacity to attack the drug traffickers that have operated at ease in the country. The challenge is to dedicate work towards strengthening the institutional framework, but it is a task that corresponds to the citizens of Honduras who are being called to act in a responsible manner by granting their representation to the right people so they can drive the country towards better paths."

The trial against Tony Hernández continued with three more witnesses. As the defense did not present any witness and Tony Hernández did not testify, there only remain the concluding arguments which will take place tomorrow. In its great summary of day 8, Aquí Abajo highlights the following key details. "- Tony allegedly lied to the DEA/US Government when he met with them in October 2016. He lied about his relationship with drug traffickers including Leonel Maradiaga Rivera (from Los Cachiros), "Don H", "El Rojo", Mario Calix Hernandez and others. - Tony informed other drug traffickers like Chang Monroy that he could obtain and sell any type of weapon that other traffickers wanted. Tony sold weapons and ammunition to Chang Monroy who noted that the ammunition had lot numbers on them, which was odd because its an indication that they came from a government institution(s). - Tony Hernandez sold 40 M-16 guns to Chang Monroy, who then sold them to the Sinaloa cartel in Mexico. - Chang Monroy was asked why he originally lied about knowing Tony Hernandez upon his arrest. His response: "I was scared because I'm like other drug traffickers that are violent, but no other drug trafficker has a brother that's the President of a country that controls the police and the military."'"

Guilty. Tony Hernández was found guilty on all four accounts. "Former Honduran Congressman Tony Hernández Convicted In Manhattan Federal Court Of Conspiring To Import Cocaine Into The United States And Related Firearms And False-Statements Offenses".

"Hernández, 41, faces a mandatory minimum sentence of 30 years in prison and a maximum sentence of life imprisonment. He is due to be sentenced January 17."

The Honduran diaspora in New York celebrated outside the New York court.

JOH reacted on Twitter, denouncing the decision, rejecting any future action trying "to sully the name of Honduras" based on this verdict. He also presented his government as an ongoing strong ally to fight drug trafficking...

Similar statements regarding the US-Honduras relationship came from the foreign minister Lisandro Rosales.

By the time of writing this, almost all articles on the start page of El Heraldo and La Prensa relate to the trial - it gets more difficult for the allied press of the JOH regime to silence this issue.

Four US congresswo/men, Jan Schakowsky, Hank Johnson, Pramila Jayapal and Mark Pocan, issued a joint statement. "The Trump Administration must end its support of the repressive and corrupt Honduran regime of Juan Orlando Hernández. (...) The Trump Administration must immediately stop funding the corrupt Honduran police and military and stop celebrating President Hernández as a friendly ally and partner in the drug war. (...) We need to condemn the Honduran government's continued use of live bullets and poisonous tear gas to disrupt opposition protests and call for an end of its criminalization of dissent by grassroots environmental defenders - such as those from Guapinol. That is why 74 Members of Congress and counting support H.R. 1945, the Berta Cáceres Human Rights in Honduras Act, which calls for an immediate suspension of U.S. funding for Honduran security forces until their government investigates, and brings to justice, perpetrators of violence and unrest in Honduras."

Nevertheless, InSight Crime concludes an article on the conviction with: "While Tony Hernández's conviction is extraordinary, it's likely not enough to remove the shadow of narco-politics that still looms over the country's business elites and government, including the president himself. These criminal structures still stand and will continue to do so as long as the United States views the sitting president — who was named as a co-conspirator in his brother's drug conspiracy — as an ally worthy of US security assistance."

Among the political are the 7 environmental defenders of the Guapinol community who are held in the military-controlled maximum-security prison La Tolva and one in the La Ceiba Prison, and the teacher Rommel Herrera who was just transferred from La Tolva to a psychiatric hospital due to a severe mental health crisis after almost 5 months of pretrial detention under inhuman conditions." One of them, Gustavo Cáceres, "held in the prison in El Progreso despite having a medically diagnosed serious cognitive disability", will face trial the coming Monday in El Progreso.

The so-called "narcolibretas" used in the trial as proof belonged to him. In it, he mentioned JOH various times. His lawyer had denounced previous attempts against his client while in prison.

He holds the JOH regime responsible for the murder.

A video showing the extremely violent murder of López Sanabria soon made the rounds - it seems as if the prison guards knew about what was going to happen.

Prison authorities suspended the director and announced an investigation.

Honduras Daily: Drug Trafficking - JOH; Political Prisoner; OFRANEH; Students; and ASJ's Hammer

The murder of Magdaleno Meza Fúnez in the maximum security prison El Pozo continues to occupy the headlines (see yesterday). OACNUDH laments the murder of the two inmates (another inmates was murdered the same day) and highlights that both inmates had previously requested their transfer fearing for their lives.

CONADEH describes the general situation in Honduras' prisons as grave and in urgent need of attention.

Migdania Ayestas, the head of UNAH's Violence Observatory, speaks of prisons self-governed by inmates in collusion with prison authorities.

At El Pozo and La TOLVA, the Military Police have taken over control.

But critics denounce this as a show for the public. The important question is the clearly visible selective murder of a former associate of Tony Hernández.

The Vice-Minister of Security, Luis Suazo, unconvincingly tries to explain why a prison guard opened the door the inmates stormed in to murder Meza Fúnez.

At the same time, he says that the so-called "narcolibretas" by Meza Fúnez and used in the Tony Hernández case were fake - a bit too convenient...

Meza Fúnez' lawyer disputes this.

He also reiterates that the assassination was planned and that he holds the JOH regime responsible.

El Heraldo presents the second inmate seen in the video during the talk between Meza Fúnez and the director of El Pozo. It is a presumed drug trafficker from Colombia, Fermín García Isaza.

Univision published an overview in English on the recent murder of Magdaleno Meza Fúnez, a.k.a. Nery López Sanabria (see e-mails of the last two days). The two reports highlight some interesting events around López Sanabria. "Before the trial, lawyers for Lopez Sanabria say their client was visited without their prior knowledge or authorization by a Miami private investigator, Chase Lalani, who was employed by the Hernández family. Others who were approached by Lalani say he misrepresented himself as working for the U.S. government. Lalani denied misrepresenting himself during a brief conversation with Univision in New York."

The MP, meanwhile, announced that they have identified four suspects of the murder.

At the same time, the JOH regime aided by their media allies try to present López Sanabria as a troublesome inmate, as someone who actively tried to escape prison.

Regarding the lack of security in the maximum-security prisons, congressman Denis Castro Bobadilla told HonduDiario: "Maximum security can only be found in the Presidential Palace and the Central Bank of Honduras".

For human rights defender Edy Tábara, the murder of López Sanabria is a further sign of the "narco-government" ruling in Honduras.

In another case of extractivism which led to the criminalization of environmental defenders - the hydroelectric project by Hidrocep - the initial hearing of the 12 defenders was postponed for the second time.
