Honduras Daily: Berta - Trial; OFRANEH; Extractivism; Femicide; HRDs - Protection; JOH - Spain, National Party, Militarization; Penal Code; Poverty; Public Health - Dengue; Remittances; and We Don't Have no Education

After one year, the sentencing of the seven convicted material authors of the assassination Berta Cáceres took place yesterday. "[T]he four paid hitmen – Elvin Rapalo, Edilson Duarte Meza, Óscar Torres, and Henry Javier Hernández – were each given 34 years for the murder. They were also sentenced to 16 years and four months for the attempted murder of Gustavo Castro, a Mexican environmentalist who was shot in the same attack but survived by playing dead. Sergio Ramón Rodríguez, the communities and environment manager for Desa, and Douglas Geovanny Bustillo, a former Desa security chief and ex-US trained army lieutenant, were given 30 years and six months for their participation in the murder. Mariano Díaz Chávez, a US-trained special forces major who served with Bustillo, was found guilty by omission and given 30 years. (...) "From the outset, the path to justice has been painful, as our rights as victims have not been respected. These sentences are a start in breaking the impunity, but we're going to make every effort to ensure that all those responsible – the company executives and state officials identified in the trial – are prosecuted," said Bertita Zúñiga, Cáceres' second-eldest daughter."

After the sentencing, Berta's children read a statement outside the court highlighting that impunity has not ended with just the sentencing of the material authors and demanding the investigation of the Atala family and other suspected intellectual authors.

OACNUDH recognized the importance of the sentences, but also highlighted that it is only a first step.

The days was accompanied by worldwide solidarity messages demanding "Justice for Berta".

The MP, meanwhile, celebrated itself.

Cristina Alvarado from the Women's Movement for Peace denounces that in the last 15 years, over 6000 women were murdered in Honduras (almost 5000 of which in the last ten years since the coup d'état) and in 96% of the cases impunity reigns. "There is no investigation, there are barely 40 investigation agents specialized in protocols of analysis for femicide, but they also cover other types of crimes so they are spread throughout the country. Another element is judicialization, because if not done correctly, the crimes remain unpunished."

So far this year, 365 women were murdered.

But, despite losing López, the possible case against President Hernández keeps building, experts say. Several alleged co-conspirators remain at large, while other alleged major traffickers have been busted in recent weeks."

"On November 3, Prosecutor's Office for Ethnicity issued a tax injunction in relation to the La Ensenada hydroelectric plant, which the families of Marcelino Ponce's heirs have been trying to build for many years on the Cuyamel River, in the Garífuna community of Sambo Creek. It took the prosecutor's office nine years to issue the tax injunction against the former vice minister of the former Secretariat of Natural Resources (SERNA), Sr. Norman Gilberto Ochoa Henríquez, who issued the environmental license for the project within 40 days, without a prior consultation of the Sambo Creek community. (...) Although the La Ensenada hydroelectric dam was not built, the process of auctioning the Cuyamel River Basin continued its course, varying the objective. The hydroelectric plant was converted into a 70 megawatt thermoelectric plant based on bunker C, which was installed without an environmental license between two protected areas. (...) The absence in Honduras of environmental audits by the State, and the sinister handing out of licenses,

has generated disastrous results for the environment and the communities that protect them, who are processed, persecuted and even murdered."

Congress' Special Multi-Party Commission decided that the small parties won't be present at the vote-counting tables (Mesas Electorales Receptoras (MER)) anymore. In the past, they trafficked their positions at the table to larger parties, mostly the National Party, which then controlled the outcome of the table.

Some smaller parties have seen their legal status cancelled, but they appealed the decision.

Monday's sentencing of the material authors of the assassination of Berta Cáceres continues to be accompanied by international statement. Three US Congresswo/men, all supporting the Berta Cáceres Act calling for the suspension of U.S. funding to the Republic of Honduras for its police and military operations, Hank Johnson, Jan Schakowsky and Mark Pocan, issued the following statement: "While these sentences are a step in the right direction, it's only a first, small step. Although the killers who pulled the trigger on that fateful day in March 2016 may be facing a measure of justice, those who hired these hitmen and are the true architects of Berta's murder, are still free. In its ruling, the Court noted the participation of executives and directors of the DESA company in the planning and financing of her murder. Today, we recognize progress in the pursuit of justice for Berta but stand strong with her family and friends in seeking true justice. True justice includes trial and punishment of all those responsible for her murder, including the executives of the company building the dam, DESA, who were the masterminds and financiers of the plot." EU parliamentarian Miguel Urbán Crespo also calls for the investigation and prosecution of the intellectual authors and denounces the widespread impunity in Honduras.

The EU High Representative of the EU for Foreign Affairs and Security Policy Josep Borrell Fontelles welcomes Monday's sentencing.

Radio Progreso dedicates its daily column to the case. "The men who shot Berta Cáceres are identified, prosecuted and sentenced. The intellectual authors of the crime are unpunished, and are within reach of justice if it wants to act. The investigation must continue among DESA's highest shareholders. (...) As long as the power structures that killed Berta remain intact, women will continue to be threatened. Berta's path is a frontal struggle against patriarchy, and from that conviction her spirit calls for a tenacious struggle to break with the impunity that protects intellectual killers. The conviction of the material murderers is a step forward. But from the perspective of the men of power, it is a mirage. It makes us believe that justice has already been done."

Even though media coverage has decreased after the initial shock about the militarization program for children, Guardians of the Fatherland, the program continues. ContraCorriente highlights the religious aspect of the program and how it seems to be the materialization of "God and Fatherland". "In the last 20 years, Nationalist governments have promoted the incursion of the Armed Forces in the management of public security, first as a deterrent to criminality and, over the years, in tasks of attacking organized crime and preventing violence in conflictive neighborhoods. From seeing them guarding public buses, we went on to see them in tasks such as the civic and ethical formation of children. In 2010, these actions were formalized through a program called Guardians of the Fatherland, in which for 4 years they took the children from the schools to the battalions to give them civic and religious classes. From 2014 to 2019 the program has had some changes and now, through civil liaisons, Guardians of the Fatherland operates in public schools nationwide. Over 17 years, the program has covered approximately 12% of the Honduran child population. Of the civil society bodies that accompany the program most are the churches. It is worth mentioning that the Evangelical Confraternity of Honduras is one of its main partners."

(...) López never testified in the trial as he was jailed in Honduras. However, he had been in discussions with the U.S. Drug Enforcement Agency for several months prior to his murder, according to four lawyers familiar with his efforts to cooperate with the U.S. officials. Some of those lawyers now wonder aloud if his cooperation with the DEA – and high-level political connections - may have gotten him killed. (...) But, despite losing López, the possible case against President Hernández keeps building, experts say. Several alleged co-conspirators remain at large, while other alleged major traffickers have been busted in recent weeks."

US president Trump praised JOH: "President Hernández is working with the United States very closely (...) and we are winning after years and years of loosing. We are stopping drugs at a level that has never happened."

This does not square with the view of the rest of the world of the JOH regime as a narcogovernment or in the words of Alberto Arce, "Honduras is a narco-political poem".

At the same time, the US Department of State warned that "they will immediately suspend the entry visas of corrupt officials in Latin America. (...) The measure would be extended, for example, to the next of kin of the officials of Guatemala, Honduras and El Salvador, who are involved in acts of corruption."

With a handful of high-ranking officials behind bars, several former public officials on the run and an infinite number of open files without investigative advances, prosecutors and judges are entangled in the web of access to structured justice from historical corruption and the narco-state. (...) It is clear that corruption is the basis of the capitalist, fundamentalist and conservative economic model; therefore, the anti-corruption policies adopted by international agreements are only an incentive in the face of the profound political and social crisis linked to drug trafficking and the narco-state. It is one of the pillars that sustains the State and, in the particular case of Honduras, the criminal structure into which they have turned the state gear directed by not only corrupt officials but also criminals who are internationally recognized and pointed out as drug trafficking professionals. Due to the conditions of Honduras, the fight against corruption obligatorily goes through the urgent and frontal dismantling of the structure of the National Narco Party, its tentacles in each State institution, its criminal ways of operating, to clean up the current scenario of those who are the provocateurs and who sustain the various deep crises of the country in which the one caused by institutionalized corruption is only one of these. And for this, it must be clearly assumed beyond the role of international bodies, political lobbies, pacts and inter-party negotiations."

Yesterday, an important hearing on Honduras, human rights and corruption took place in Congress at the Tom Lantos Human Rights Commission in the presence of the two co-chairs Republican congressman Christopher Smith and Democratic congressman James McGovern. The whole hearing can be seen on the official homepage of the commission (see first link). There were various important things said worth highlighting. Republican congressman Smith spoke of Honduras as a "country plagued by political corruption" and he said the focus is on "the action of the administration of Juan Orlando Hernández, including up to the highest levels". On a recent IACtHR visit to Honduras, Democratic congressman

James P. McGovern said that "I think it is fair to say that the Commission would not go into a country unless there was deep deep concern about what was happening in that country". He spoke of corruption in Honduras as "pervasive, systematic, baked into the operating system".

Next to the importance of the MACCIH and the renewal of its mandate, various witness highlighted the importance work of OACNUDH in a country where human rights defenders are the targets of threats, harassment and worse. "The United States should also strongly support the office of the UN High Commissioner on Human Rights in Honduras with its current leadership which plays a crucial role in documenting the abuses and providing technical support".

Eddy Tábora, director of C-Libre, called on the reconsideration of security and military assistance by the US highlighting the use of state security forces to violently repress peaceful protests up to right out assassinating them and to intimidate and harass human rights defenders. Asked by congressman McGovern in which other cases apart from the Berta Cáceres case, the US Congress should to more, the cases of Guapinol, Reitoca, Los Prados and the situation in the Bajo Aguán and the Atlántida region, where various hydroelectric projects are imposed, were mentioned as well as the situation of the political prisoners.

McGovern also criticized the too narrow approach of the US to Central America, focused on migration and drugs and called for a more holistic approach. Much more was said and it is worthwhile to listen to the complete hearing.

The situation in Honduras grows more worrisome by the day. Shortly after the Tony Hernández trial, a key witness who wanted to collaborate with the US, the drug trafficker Nery López Sanabria a.k.a. Magdaleno Meza, was brutally murdered inside the so-called maximum-security prison El Pozo, on camera, a warning for all. His defense team then asked for protection. This week, just days after Univision covered the story of Meza again, a member of the defense team, lawyer Jose Luis Pinto, was murdered (see previous e-mails). After Meza's murder, the then director of El Pozo,

Pedro Idelfonso Armas, was suspended. He also immediately asked for protection. Now, he was murdered as well...is there any remaining doubt that someone is tying up loose ends here.

Critero reports that in June 2016 Armas was accused of aiding two inmates as the then deputy director of the Santa Rosa de Copán prison. Nevertheless, he was promoted to director of El Pozo. Maybe this past accusation helped to control him.

The JOH regime declared a state of emergency and suspended the prison authorities and further militarized the Honduran penitentiary system. They will have control for the next six months. This goes in the opposite direction of recent recommendations by the MACCIH to demilitarize the prisons.

The head of the human rights organization Casa Alianza, Guadalupe Ruelas, fears that the defenselessness of inmates will further increase and transparency further decrease.

There is widespread criticism for this decision and it is worth highlighting two things. First, especially the so-called maximum-security prisons, where the most assassinations took place this

year, were already heavily militarized under the promise that they should stop exactly what has now been happening under their control these last months. Even more, it gives the JOH regime through its allies in the Armed Forces even more control and given the recent assassinations of witnesses to the Tony Hernández case, this is especially worrisome. Second, once more, JOH ally and "civil society leader" Omar Rivera feels the urge to praise the decision to militarize the prisons...

With this logic, the prison function was militarized, which meant handing over custody and control of maximum security prisons to the military; however, to date, the military has once again proved to be incompetent."

Criminal lawyer Raúl Suazo says that Honduras is violating international standards.

The Board to Follow-Up on Sentences and Resolutions by the Inter-American Court on Human Rights comes to the same conclusion.

The US designated the Nationalist Honduran Congressman and JOH ally Oscar Ramon Najera and his son Oscar Roberto Najera Lopez due to their involvement in "public corruption related to the Honduran drug trafficking organization Los Cachiros".

"The sanctions against Najera and his son are the latest in a series of political embarrassments for the ruling National Party in Honduras (...) Najera's name has long been linked to corruption in Honduras and has also been mentioned in several recent drug trafficking cases. (...) In his closing argument, prosecutor Emil Bove described Najera as "a close friend" of Tony Hernandez "who was a part of setting all of this up so that the Honduran government could be used to protect drug traffickers." When Hernandez was arrested at Miami International Airport in November 2018, he had Najera's contact information in his phone. Photos found on the phone also showed Najera in a hot tub with Hernandez. Another photo showed Najera with Juan Orlando Hernandez."

The Honduras Solidarity Network rightly asks: "Congressman Oscar Najera & son ban from US. But what about all the other problems he has caused? Land conflicts & murder in Aguan Valley? Drug trafficking? Why does US back Honduran gov't & public prosecutor's office that doesn't hold traffickers & corrupt to account?"

COPINH highlights also his role in promoting extractive projects.

The TSC announced to investigate an investigation including into an NGO managed by the congressman.

Óscar Ramón Nájera, meanwhile, went on the attack and called the US Secretary of State, Mike Pompeo, a liar.

Fusina finally confirmed yesterday that the number of murdered inmates in the Tela prison was not three as they previously had said, but rather 18. According to ConfidencialHN, the real number could even be higher.

La Prensa reports that the murdered inmates were of low-risk and only three of them had been sentenced.

Family members had started to gather in front of the prison by yesterday morning demanding answers.

Fusina, meanwhile, claimed that they had not yet taken control of the Tela prison when the massacre took place.

Human rights defender Dina Madrid disagrees saying that the Military Police has controlled the prison for almost a year.

An intervention committee will now evaluate all employees of the National Penitentiary Institute (INP).

There have been at least three mass-killings in Honduran prisons this year with a death toll of 26 inmates.

I am a bit lost for words. A second mass killing took place in another Honduran prison in less than a week. 19 inmates were assassinated in the minimum-security prison El Porvenir, 100km northeast of the Tegucigalpa.

Fusina confirmed 18 deaths.

They also try to present themselves as the victims claiming that the "criminal escalation" impedes them from taking over the control of the Honduran prison. This, once more, ignores the fact that the Military Police has been "in control" of some prison for quite some time (see also yesterday's e-mail).

The mass-killing in the Tela prison, meanwhile, claimed its 19th victim, as one inmate died in the hospital from his wounds.

OACNUDH expressed deep. concerns.

Padre Melo warns: "Prison massacres, witness cleansing and militarization are part of the policy of extermination and official terror. And yet there are those who claim that they are just inmates killing each other. What a naive and dangerous opinion! The sad thing is that this is only just beginning". Luis Suazo, deputy Minister of Security, has his own theory. "What has happened in recent days in the prisons are systematic, orchestrated and well-planned attacks by organized crime to expose Honduras, and to draw the attention of human rights organizations"

Honduras Daily: Penitentiary System; Corruption; MACCIH; ENEE; and Black Powder and (White) Christmas

The situation in Honduras' prisons, especially the two recent massacres, caused national and international condemnation. CEJIL condemns that at least 42 inmates were murdered in the last three weeks and denounces that the State has failed to guarantee the right to live and personal integrity of inmates. They also express concern that the further militarization of the prisons seems to be the answer for the JOH regime exposing inmates to additional human rights violations.

The well-renowned human rights defender Juan Almendares Bonilla presents Honduras' prisons as "centers of death".

And Casa Alianza denounces that the massacres were planned to spur the privatization of the prisons.

Human rights organizations demand the creation of a special commission representing various sectors. "According to their proposal, the commission should make urgent recommendations on the serious situation facing the prison system as a result of more than 40 violent deaths of prisoners in recent days and due to the lack of institutional credibility emanating from public security and justice operators."

Fusina, meanwhile, restricts the food family members can bring to their loved ones for the Christmas meal.

Meanwhile, the undermining of the MACCIH continues. TSC magistrate José Juan Pineda claims that the only the MP is successful in combating corruption, not the MACCIH.

(...) The Central American nation has long been a focal point of U.S. efforts to spread its influence throughout Latin America. In 2016 and 2017 alone, the US government bestowed Honduras with almost \$400 million dollars (...) But this assistance hasn’t always helped ensure good practices. Some of the funds have gone directly to militarized police units like the Tigres, a force created in 2012 specifically to fight organized crime that has been dogged by corruption allegations involving some of the country’s most high-profile drug traffickers. The money has also been funneled into the National Police, even while former police chief Juan Carlos “El Tigre” Bonilla Valladares, among other high-ranking police officers, is alleged to have played a central role in facilitating drug trafficking and been involved in extrajudicial murders. While the United States does not hold all of the blame for the current state of Honduras, there’s no denying how destructive its continued support, financial or otherwise, has been for a large share of Hondurans.”

Laura Carlsen investigates the root causes of Honduran migration. "I went down to Honduras to ask grassroots leaders these questions. Also, to find out what's behind the rise in the popular movement over the past year and, most of all, whether it can provide a way out of the downward spiral the country has been in since the coup of 2009. I found a country facing an acute crisis on all levels—a political crisis of legitimacy that has destroyed faith in the leaders and led to violent repression of protest as the government implodes, an economic crisis with over 60% of the population living in poverty and extreme poverty, and a crisis in security as organized crime groups control urban territory, corporations take over resources, and corrupt security forces and paramilitaries routinely attack the citizenry with practically no legal consequences. There is also a deeper, more ineffable crisis: many Hondurans see no future in their own country."
