Honduras Daily: National Police; Migration; Transport Sector; Toll Booths; Corruption - IHSS; and Justice for Berta

ContraCorriente covers the failed purge of the National Police Force with a very telling image: "It is to honor and glorify the name of Christ," said Police Commissioner Leonel Saucedo on Sunday, February 9, before leaving the stage of the International Christian Center (CCI) where minutes earlier the evangelical pastor and member of the Special Commission for the Process of Purification and Transformation of the National Police, Alberto Solórzano, had led a prayer on his behalf. A week earlier, Saucedo had been promoted to the rank of Commissioner General of the National Police. Two days after the religious act in which he participated thanking God for his promotion along with the police purger, he was arrested by the Technical Agency of Criminal Investigation (ATIC), a specialized agency of the Public Prosecutor's Office, for presuming him responsible for the crime of money laundering since he could not justify approximately 16 million lempiras contained in his bank accounts." The article also highlights the complete lack of political will by the JOH regime to purge the police. Speaking about the previous Commission of the Reform of Public Security, Josué Murillo said: "When Juan Orlando saw that they were independent and were targeting the roots of the problem, he dismissed them, annulled the reform commission and formed this purging commission."

Local government representatives as well as national and international civil society organizations gathered in Santa Barbara with the aim of analyzing strategies and local mechanisms to respond to irregular migration. They highlighted the humanitarian crisis with over 100'000 Hondurans deported back to Honduras last year and stressed the need to recognize the human right to migrate. They also demanded a more decentralized government structure with the need "to design and implement a model of comprehensive care at the municipal level for this problem that includes humanitarian assistance, psycho-social care, technical-vocational training, support for entrepreneurship, employability, school reintegration, houses of refuge and protection, care for people with special abilities, all under a focus on rights and inclusion and action without harm, to ensure comprehensive and sustainable human development of people, especially our children and youth".

Honduras Daily: Berta - US; Impunity; HRDs; Corruption - IHSS; Migration - US; Transport Sector; and New Identity Cards

Honduras and the world commemorated Berta Cáceres yesterday on the fourth day of her assassination. "This crime represents the plan to try to destroy the territorial and articulating struggle for the re-foundation of Honduras, led by Berta Cáceres, and to sow fear in the hearts of those that fight for Honduras. However, their struggle has not stopped sprouting in thousands of expressions worthy of resistance by the Honduran people. It was a day after her crime that we, as COPINH, family members and organizations, set out to build justice for her, challenging the structural impunity of the country that has been complicit in the attacks on the people and their political persecution. (...) We have confirmed and fully denounce that the repressive State of Honduras, which violates human rights, does not intend to persecute the members of the Atala Zablah family; Daniel Atala Midence, Jacobo Atala Zablah, José Eduardo Atala Zablah and Pedro Atala Zablah, businessmen responsible for the crime of Berta Cáceres."

Berta Zúniga, general coordinator of COPINH and Berta's daughter, also addressed the world. "As you know, these four years have meant, in the midst of the pain of losing such an important person, an intense work of seeking justice but also of continuing to walk in Berta's footsteps."

Under the hashtag #JusticiaParaBerta, there is a worldwide demand for justice.

Organizations such as Amnesty International or CEJIL participated.

"A federal appeals court in California halted the Trump administration's "Remain in Mexico" asylum policy on Friday, removing one of the key tools the president has used to curb mass migration across the southern U.S. border. JOH and his drug trafficking ties are back in the international headlines. "Geovanny Fuentes allegedly paid at least approximately \$25,000 to Juan Orlando Hernández in exchange for protection from law enforcement and access to a cocaine laboratory strategically located near Honduras's largest port, according to a criminal complaint. Hernández ordered Fuentes to report directly to his brother, former congressman Tony Hernández, it adds."

"U.S. prosecutors said Tuesday that Honduras' president met a drug trafficker around 2013 and took \$25,000 in exchange for protecting the trafficker from law enforcement. The U.S. Attorney's Office for the Southern District of New York issued a statement referring to President Juan Orlando Hernández only as a "high-ranking Honduran official" or as "CC-4," a co-conspirator. But in court documents, it identified "CC-4" as president of Honduras and brother of former congressman Juan Antonio Hernández Alvarado, who was convicted on drug charges last year. In previous filing, U.S.

prosecutors have described "CC-4" as the winner of the 2013 presidential elections."

The Honduran press took this up as well.

Media outlets close to JOH only reported on this as an official denial was issued by the Casa Presidencial.

US Senator Patrick Leahy tweeted an important comment on the Berta Cáceres case. "Berta Cáceres lost her life for speaking out in defense of the natural resources her people depend on. Rather than defend her rights, the Honduran Government vilified her and other environmental activists. The Honduran Government pledged that all those responsible for the premeditated murder of Berta Cáceres would be brought to justice. Four years later her family, the Honduran people, and the world are still waiting for justice. Berta Cáceres was one of many Honduran environmental activists who have been harassed, threatened, and killed. There is no better illustration of impunity than the failure of justice in these cases. The Honduran Government and Congress kicked out MACCIH and enacted laws designed to shield themselves from accountability for corruption and violations of human rights. The U.S. should not support such so-called 'partners.' The Office of the Honduran Attorney General needs strong international support in investigating and prosecuting cases of corruption and violations of human rights. That Office and honest judges are the only hope for justice in Honduras. The Honduran judiciary has prevented relevant evidence from being produced in court, which has impeded the prosecution and delayed justice for Berta Cáceres and her family. An independent judiciary is fundamental to democracy."

"US authorities allege that a recently arrested drug trafficker relied on protection from Honduras President Juan Orlando Hernández and his brother Tony to manufacture hundreds of kilograms of cocaine per month, broadening the scope of the narco-politics nexus in the Central American nation. (...) The latest criminal complaint in the United States suggests that political powers in Honduras didn't just turn a blind eye to help facilitate the trafficking of Colombian cocaine shipments through the country and into the United States, but also provided cover for domestic drug production for more than a decade. In fact, the depth of corruption appears to have reached the top of the Hernández family and the president himself. (...) As head of state, President Hernández currently enjoys immunity from US prosecution. However, when he leaves office in 2022, the latest criminal complaint suggests that authorities in the United States may now be laying the groundwork for a potential future criminal prosecution against him."

This week's commemoration of Berta Cáceres inspired two more reactions from the US. Congresswoman Marcy Kaptur called on "my colleagues to support the Berta Cáceres Human Rights in Honduras Act, to suspend US funding to Honduras for police & military operations until their government investigates reports of human rights abuses".

Congressman Eliot L. Engel, Chairman of the House Committee on Foreign Affairs, met with Attorney General Óscar Chinchilla. "I emphasized with the Attorney General that four years after the killing of environmental activist Berta Cáceres, each and every mastermind of her murder must be held accountable in a court of law. As I have done over the past four years, I will continue to push for justice for Berta and her family and a Honduras free from corruption and the horrors of criminal violence."

"The correlation of political forces in Congress does not allow one to imagine that an impeachment will be initiated because one does not have the number of votes and a surprisingly indifferent attitude of the opposition to this situation". Pinu congressman David Reyes, meanwhile, commented: "There are already too many testimonies from drug dealers who are linked to the Hernandez family, both Tony and Juan Orlando. Without a doubt this puts us to shame internationally, it puts us to shame as a country, as citizens, but I am also ashamed that the citizens do not react".

Reporteros de Investigación sees the possibility of another reelection bid by JOH supported by an alliance with the Armed Forces and organized crime. "One of the high-ranking police sources, in retirement, warned that serious acts, executed by the pact between the MS [Mara Salvatrucha] and the military forces to change the voting intention, could happen near the general elections. That is why Hernandez needs military forces loyal to him, a weak or non-existent police force, and a conditioned press, all part of the same strategy, he said."

JOH's call for maintaining the Security Tax, allowing unaccountable money flows towards the Armed Forces, also goes in this direction.

And just yesterday, JOH commented on the reelection again, highlighting the need to regulate it, while pretending that everything has been decided already and a one-time reelection is possible. The National Electoral Congress, meanwhile, now proposes to consult the public about the reelection as well as the two-round presidential election.

In one video, which CPJ reviewed but has since been set to private, a Facebook user named Luis Rodríguez said that Benítez is on a list of journalists to be killed in 2020. The video had been viewed more than 50,000 times before it was set to private. (...) CPJ called the Honduran attorney general's office and Danilo Morales, the director of the protection mechanism, for comment, but no one answered the calls." Pasos de Animal Grande reports on the difficult situation of journalists in the south of Honduras. "It could be a mere coincidence, but threats, harassment, tailing by unknown men and cars without license plates, as well as the reopening of a trial, have occurred against critical journalists, in the preamble to the launch of the presidential candidacy of the President of the National Congress, Mauricio Oliva, last Sunday, March 8, 2020. Journalists Leonel García of Nacaome Valle and Leonardo Pineda of Choluteca's Channel 21 were followed by unknown men in cars with tinted glass and no plates, while Jairo López faces the reopening of a trial and the umpteenth smear campaign on social networks."

CESPAD published an analysis on the resurfaced presidential reelection debate (see last week). "In the first days of this month of March, the National Electoral Council (CNE) of Honduras, by a majority of votes, adopted the transcendental decision of the lack of "constitutional and legal origin of the reform" requested by the National Party to its statutes, regarding the regulation of the issue of reelection. This decision goes beyond the denial of this type of reform to the governing party, as it is a determination that aims to establish the illegal nature of the reelection. The current president of this collegiate body, Rixi Moncada, has expressed it very clearly "an administrative resolution was issued against the presidential reelection and we have raised it by majority, arguing that the "artículos pétreos" [articles that are set in stone] of the Constitution of the Republic can only be reformed, repealed or modified by the people through a National Constituent Assembly or a popular consultation. The decision adopted by the CNE is a clear disregard for the ruling of the Supreme Court of Justice (CSJ) that enabled the presidential reelection. Consistent with this position, the CNE has presented to the Commission on Electoral Reforms of the National Congress (CN) a set of 20 reforms, highlighting, among them: "the holding of a popular consultation to define the presidential reelection and the second round". The CNE bases the need for these reforms on the fact that "clean and transparent elections will only be possible if the required conditions are created". For some civil society organizations, the electoral reforms currently agreed upon are not substantive and are far from ensuring transparency in the next elections, especially if the second round is not included and if the issue of presidential re-election is not resolved."

On this emblematic date, we wish to draw attention to the various gender-based forms of violence that strongly affect women and girls in the country, as well as to recognize the role of the women's and feminist movement in Honduras. (...) With regard to the normative framework, it is necessary to adopt laws that allow a comprehensive approach to the phenomenon of violence against women, such as the Law on Domestic Work, the Law on Political Violence against Women, the Comprehensive Law against Violence against Women, which includes the figure of shelters for women survivors of violence. (...) MIG believes that, in view of the major challenges in this context, it is necessary to redouble efforts to investigate and prosecute cases of femicide, strengthening technical capacities and allocating budgets effectively and in accordance with the requirements of the special units for the investigation of violent deaths of women and femicide attached to the Public Prosecutor's Office and the investigative agencies. (...) No measure can be successful without addressing the underlying causes of violence against women, in particular patriarchal attitudes and stereotypes, gender inequality and without redoubling efforts to combat the multiple discrimination suffered by women belonging to indigenous peoples, Afro-Hondurans, LBTIQ and other vulnerable groups."

Since yesterday, Honduras has its first two confirmed Covid-19 cases. They are in a stable state. The Finance Minister announced a 640 million Lempiras budget to tackle the looming health crisis, 440 million of which is meant to hire more staff.

Honduras Solidarity rightly points out that already some weeks ago, the JOH regime approved extra funding for a possible corona-crisis and it is doubtful that it will be used for that purpose.

The Pan American Health Organization offered help for Honduras.

necessary to be permanently alert to the movements that this mafia in power makes, because we cannot naively trust our destiny in their hands. Having said that, we must be careful not to fall into another consequence of the mistrust we have of the regime that consists of the opposite extreme; many do not even believe that the Coronavirus or COVI-19 exists or that it is as serious as it is painted. (...) The challenge is to keep a balance between criticism and mistrust, which it is right to have in the face of the regime, without that meaning that we neglect or harm ourselves and others. And beyond that, to redefine our strategies to continue fighting the regime in the new conditions that this epidemic will bring.

COVID-19 has arrived in Honduras, so far still with only two confirmed cases (see yesterday), but it lead to widespread reactions. Flights of public officials were cancelled.

People from Europa, China, Iran and South Korea have to self-isolate if they come to Honduras for 14 days.

Public events were also cancelled.

And the National Electoral Council (CNE) asked the political parties to suspend their activities for 4 weeks.

JOH, meanwhile, asked multilateral banks for more financial support.

Some of this landscape of fear was captured in the 2019 ERIC Opinion Poll, which states that half the population feels fear when they think about the country's future. Recognizing that fear is something natural, we warn that it becomes a problem when we allow ourselves to be governed by fear, and in today's Honduras at least three types of fears can be identified: natural fears, induced fears and instrumental fears. Regarding this last daily fear, the Coronavirus came to Honduras and is creating collective hysteria that will not help in the implementation of measures to prevent the disease. (...) What is not normal is to inject more fear until it provokes collective hysteria, a task that is being fulfilled by the corporate media and the Presidential House viruses. (...) There is a close relationship between the promoters of fear and the beneficiaries of fear, as close as the relationship between the political and economic elites and organized crime, the latter being the main beneficiaries of hysteria and our confinement. The political elites instrumentalize the fear of the coronavirus so that the population forgets that we are governed by corrupt people and drug traffickers, forgets about the continuing project of JOH and his group, forgets about the daily calamities."

Even when the MACCIH was still in Honduras, there was well-deserved criticism towards the anti-corruption efforts in Honduras, especially that it did not go after the really powerful actors and that there was not follow-up after an initial, media-accompanied, accusation. One exception was the trial and successful sentencing of the former first lady, Rosa Elena Bonilla de Lobo. But it is as if someone awaited an international health crisis sucking up all the media attention to announce that....the conviction has been annulled and has to be repeated.

The director of the National Anti-Corruption Council (CNA), Gabriela Castellanos, denounced that the court "washed its hands from the corruption epidemic".

Lawyer and former Libre congressman Jari Dixon reacted: "[T]here is still doubt, uncertainty, there is still a bad taste in the mouth, they expelled the MACCIH and everything related to corruption issues is falling apart".

Pepe Lobo, meanwhile, rejoiced saying that he had always said that there were irregularities in his wife's trial.

Congress approved yesterday in record speed without consulting other sectors, e.g. the medical sector, the Special Law for Economic Acceleration and Social Protection against the Effects of the Coronavirus COVID-19, which includes the disbursement of \$420 million (10,500 million Lempiras) for the construction of 94 hospital centers and the acquisition of goods and services for the so-called Public Health Services Network. Suyapa Figueroa, president of the Medical Association of Honduras, denounced: "Congress behaves like a criminal structure and does not care about taking advantage of a situation like the coronavirus epidemic to approve diversions of public funds, to encourage the outsourcing of health services as we have already denounced." She fears that this will serve as another step to privatize public health. In one month, the JOH regime destined almost 20 billion Lempiras to the corona crisis without much oversight. As a result, their is widespread criticism. "Luis Redondo, deputy from the Innovation and Unity Party-Social Democrat (PINU) assures that this is a business to get funds, because they are going to benefit the private sector through trusts from which they will get a percentage for the management of the funds, "so this is a kind of privatization", concluded the deputy. On the other hand, Doris Gutiérrez, also a member of this same party and of the Transparency Front of the National Congress, alerted the Medical Association, the Association of Economists and labor unions of the government's intention to outsource the health system, and that with the disbursement of the 420 million dollars that the

investment in the construction of these hospitals would imply, the pension fund of the Honduran Institute of Social Security would be put at risk."

"Amidst the alarm about the coronavirus, dengue fever continues to affect the Honduran population. Some nine people have died so far this year, seven of them under 15 years of age. Most of the cases are from Francisco Morazán, two from San Pedro Sula, one from Puerto Cortés and one from El Paraíso. In epidemiological week 10, more than 10,930 cases have been reported, of which 9,510 are dengue and 883 are severe dengue. "We must not forget that we are in a dengue epidemic in which we have practically entered a plateau and we have not managed to lower the numbers of dengue cases that continue to be reported in the metropolitan region," said Roberto Cosenza, undersecretary of health. He also called for maintaining prevention measures to combat dengue.

According to the Ministry of Health, 77% of deaths from dengue hemorrhagic fever are under the age of 15. The Central District is where 92% of the cases occur. The aedes aegypti mosquito, which transmits several diseases, caused the death of more than 180 people in 2019 and more than 112,000 sick people."

"As cases of coronavirus started appearing in Central America, the U.S. government insisted on continuing deportations of Central Americans, despite concern that this could increase the spread of COVID-19. This included both deportations of people back to their own countries and deportations of Salvadorans, Hondurans, and other asylum seekers to Guatemala, which signed an "Asylum Cooperative Agreement" (ACA) or "safe third country" agreement with the United States to accept deported asylum seekers from other countries. These deportations kept happening even as the overwhelmed main shelter in Guatemala City shut its doors to new arrivals. (...) As the days passed, Northern Triangle governments started to refuse deportations. On March 10, Honduras refused to admit more flights of deported Hondurans from Mexico, although it continued to accept them via land from Mexico and via air from the United States. Then it stopped all flights when it closed its airports for a week. On March 17, the Guatemalan government stopped all flights of deportees, stating the U.S. government did not have in place adequate safeguards to screen deportees for COVID-19. Under pressure from the United States, on March 19 Guatemala began again accepting deportation flights with its own citizens, although it refused to accept deportees from other countries under the Asylum Cooperative Agreement. On March 18, El Salvador stopped accepting deportees from the United States and Mexico. It is not clear how long governments will refuse deportations if the U.S. government keeps pressure up to restart them."

"For the First Scenario to become a reality, CESPAD proposes that Honduran institutions should take on the challenge of fighting corruption, especially the Public Prosecutor's Office and the Specialized Prosecutorial Unit against Networks of Corruption (UFERCO). But for this scenario to become concrete, CESPAD analyses, at the same time, some additional requirements are further discussed in the document. In the Second Scenario, CESPAD proposes the emergence of a new citizen's movement against corruption, which manages to install a new international mission. As in the first scenario, the factors that must exist in order for this to happen are analyzed. Finally, in a Third Scenario CESPAD assesses the consolidation of the setback in the fight against corruption. In other words, the networks of corruption and impunity continue to be active, they keep the state captured and corruption and impunity grow much faster. "From the perspective of the fight against corruption and impunity, this is the least desirable scenario but unfortunately it has some probabilities and, to a large extent, will depend on the future of UFERCO, the role of the international community, civil society and the citizenry in general", says the analysis of CESPAD."

While the Trump administration now went after Venezuela's president Nicolas Maduro for drug trafficking, they still ignore the wrongdoings of JOH, who has been mentioned on several occasions in drug trafficking trials.

Jeff Ernst highlights how the charges against Maduro underscore once again the links between the Honduran state and drug trafficking. "Narcos extradited from Honduras have reported numerous cocaine shipments from the Apure region of Venezuela, where the Soles allegedly operated. Tony Hernandez used to send drugs from his lab in Colombia through Apure."

CESPAD warns that the two long-lasting pandemics from which Honduras suffers, corruption and drug trafficking, are overshadowed by the corona pandemic. At the beginning of this month, the DEA had caught Geovany Daniel Fuentes Ramírez, "(...) a prolific, powerful and murderous drug trafficker in Honduras," according to Manhattan federal prosecutor Geoffrey S. Berman. "The arrest and indictment of Fuentes Ramírez is not a minor event in Honduras, since it involves the country's highest officials and politicians in corruption and drug trafficking. The attention to the coronavirus crisis has left this and other controversial issues in the air, which seem to be disconnected but are not. And now we have a situation that somehow benefits or gives relief to these high officials and politicians mentioned in the New York courts."

There are by now 141 people in Honduras tested positive for COVID-19. 7 Hondurans have so far died from COVID-19. This is a high percentage compared to other regions, but Hondurans so far does not have a high testing capacity.

The later may change soon as the BCIE donated 150'000 testing kits to Honduras yesterday.

The epidemiologist Elsa Palou estimates that some 35'000 Hondurans will need to be hospitalized and 7000 will need intensive care which would bring the Honduran healthcare system to a collapse.

Criterio presents two underlying motivations for JOH's move to transfer the responsibility for the Honduras Solidarity program, distributing food and supplies to household, to the municipalities (see yesterday): i) to avoid the discontent of the population crying out for food and water and whose demands are mostly unmet; or ii) to politically benefit the mayors of the National Party.

Meanwhile, communities start to take things into their own hands. Defensores en Línea reports on the situation in Taragual, near Iguala, Lempira, where local inhabitants closed off the community to any outsiders. As a response, they were threatened by the police.
