The withdrawal of the Spanish company Minsait Indra from the electoral process (see yesterday) raised further concerns about the upcoming electoral cycle. "The withdrawal of Minsait Indra only confirms what several sectors have been indicating, that there are no conditions for a process whether primary or general and this is because the rules of the game remain the same as those of the coup d'état and the elections of 2010, 2013 and 2017."

Padre Melo also commented on this situation. ""This Political Pact of Impunity is the instrument that leads the current electoral process," he said, explaining that this pact has led to the definition of the two Honduras. The first is a deep humanitarian crisis (...) This is not a temporary crisis, but a structural or fundamental one, which leads to the reality of the coming years. (...) The other Honduras is the one that leads the political electoral process, "which has led us to believe that all

problems are solved at the polls, therefore, whoever is outside the electoral process is not Honduran and is a threat, so everyone to enlist, to seek elected office or support candidates," he said explaining that the two Honduras are connected by a bridge, whose keys to open the doors are held by the power group led by Juan Orlando Hernandez, so that the political pact of impunity has control of these two Honduras."

Human Rights Watch published a report on the US 'Remain in Mexico' Program. "Under the 'Remain in Mexico' program, people seeking asylum have to wait in Mexico and return periodically to the United States for immigration court hearings. Formally known as the "Migration Protection Protocols" (MPP), the program is anything but protective: it has sent people to some of Mexico's most dangerous cities and needlessly and foreseeably exposed them to considerable risk of serious harm. People interviewed for this report, including children, described rape or attempted rape and other sexual assault, abduction for ransom, extortion, armed robbery, and other crimes committed against them. In many cases, their attackers targeted them as they arrived in Mexico after their initial placement in the MPP or on their way back from court hearings, or as they left the migrant shelters where they stayed. In some cases, Mexican immigration officers or police committed these crimes."

Some 6000 Hondurans are expected to be deported this month.

InSight Crime has also picked up the newest developments in JOH's drug trafficking saga (see previous days). "With new accusations that Honduras President Juan Orlando Hernández directly brokered deals to protect traffickers in exchange for drug money, the president himself has emerged as a lynchpin in Honduras' descent into a narco-state."

Víctor Meza shared an important observation about this new development. "Many will say that this is nothing new, that we already knew it and that it is of no greater importance. They are wrong. It is true that many things are already public knowledge and are aired in detail in the gatherings of friends or in the intimacy of the bedrooms. But there are still many others that hide names and secrets, actions and excesses. And there, as they say, the devil is hidden in the details. The novelty of the new revelations leaked from the judicial corridors of New York is not only their official character but also the magnitude and dimension of their meaning. State prosecutors, that is, operators of the American judicial system, have presented official documents that involve our tenant of the Presidential House in criminal actions within the sinister plot of organized crime in general and drug trafficking in particular. Nothing less."

In Honduras, JOH (see yesterday) and the Military continue to be on the defensive.

A very interesting "defense" came from 2009 coup general Romeo Vásquez Velázquez who blames politicians for involving the Armed Forces in drug trafficking.

Meanwhile, there is also hope that one day JOH may have his day in court.

Radio Progreso published an important short article on where to go from here, i.e. the situation in Honduras and the newest revelations coming from the US. "In the spirit of seeking consensus, we launch the first ones to be debated. In order to confront the crisis of the economic model, it is urgent to: 1) promote a fiscal pact, which revises the payment of income tax to fortunes, tax exemptions and tax evasion; 2) reach a consensus on labor, employment generation, labor laws and salaries; 3) review the mining and hydroelectric concessions granted in the last decade; 4) review Coalianza concessions and management of trusts.

With regard to the institutional collapse, it is urgent to work on these five consensuses: 1) establish a new system of transparency in public management, to confront the high levels of corruption; 2) review the mechanisms for second degree elections such as magistrates and general prosecutors and appoint new authorities; 3) review the country's budgetary priorities; 4) a new proposal for the health and education system; 5) electoral reforms that facilitate participation and transparency in the process.

In environmental matters, at least four consensuses should be prioritized: 1) develop a proposal for the reconstruction of embankments and dredging of the Chamelecón, Ulúa, Aguán rivers and their

relief channels; 2) appoint a commission to resolve land conflicts in Aguán, Zacate grande and other regions of the country; 3) formulate a proposal to reactivate the country's agricultural system; 4) propose the protection of the country's rivers and aquifers.

Here is a proposal for minimum consensus, all sectors can work their own; but the most urgent consensus, and condition, is to throw Juan Orlando and his henchmen out of the Presidential House, as the key to advancing the other consensuses."

With the migrant caravans back in the headlines, Radio Progreso has an important article on their significance. "The phenomenon of the caravans is the desperate expression of a population that can no longer bear its situation of anguish and uncertainty, and that in these times has reached its extremes of hunger and unemployment with the pandemic, the passage of hurricanes Eta and Iota, plus the uncontrolled corruption of the core that is controlled by the State. All this is a pressure cooker in a country where the government has abandoned social public policies, and has replaced them with programs of the purest welfare populism, which in the end shows contempt for the humble people."

In Guatemala, where most participants of the newest caravan currently are, Sandra Cuffe reports that the army and police are " blocking the advance of thousands of Honduran migrants and asylum seekers for hours in Vado Hondo, Chiquimula. They have now opened a bottleneck to allow traffic to slowly get through".

Previous estimates of people fleeing as part of the caravan where between 3000-5000, now El Heraldo and Proceso Digital write that the Guatemalan authorities counted 9000.

The Guatemalan government also officially wrote to the JOH regime asking it "to contain the massive departure of its inhabitants".

"The basic issue is that in Honduras, as in several Latin American countries, there is no tradition in the prosecution of electoral crime. There is no history of investigating electoral crime in the country, although there have been hundreds of complaints. In some cases, for illicit association, they have been prosecuted, but as mentioned, outside the country and by initiative and interest of the US justice system. In the Honduran context, the mandate to oversee the financing of politics should be uncomfortable for the established political power, which is currently agglutinated in the governing party. In this sense, the main state entity created to oversee the financing of politics runs the risk of becoming a launderer of electoral processes with very serious transparency problems, which basically reflects one of the many weaknesses of the democratization process in the country."

"The illegally imprisoned Guapinol River defenders must be released this week by the Court of Appeals of La Ceiba who now have the case in their hands. Last Friday, Magistrates Irasema Guillén, Rubenia Galeano, Jimmy Chirinos and Garín Enoc Urquía, received the appeal against the arbitrary December 19, 2020 ruling issued by Judge Zoé Guifarro of the Court of Appeals of Tocoa, who, without legal basis, denied to substitute the preventive measure of preventive detention during a long expected hearing. The December ruling violated the Constitution, the Criminal Procedure Code and international treaties and the defenders, in remand since September 1, 2019, now depend on the judicial independence of the Appellate Court Magistrates to put an end to their arbitrary detention."

"For Jesuit priest Ismael Moreno, Director of the Team for Reflection, Research and Communication Eric-sj, and member of the Convergence against Continuity, the Guapinol case demonstrates that Honduran institutions, particularly justice, are subordinated to political and economic decisions, therefore, there is no rule of law, but the rule of the strongest."

Last Saturday, representatives of the Convergence against Continuity visited Guapinol in solidarity with their struggle and the criminalized defenders.
