"Honduras' Río Plátano Biosphere Reserve occupies a large portion of the country's eastern region. However, despite official protection and recognition as a UNESCO World Heritage Site, Río Plátano is plagued by deforestation; satellite data show the biosphere reserve lost 13% of its primary forest cover between 2002 and 2020. Deforestation shot up in 2020, nearly doubling the amount of forest loss over 2019. 2021 may be another rocky year for the biosphere reserve, with satellite data showing several "unusually high" spikes of clearing activity so far this year. Sources say deforestation in the reserve is being driven by logging, agriculture and the drug trade."

Honduras Daily: Berta - Trial; Journalists - UN; COVID-19 - Children; Elections - Opposition; Transport Sector;

After the weekend break, the trial against David Castillo continued yesterday. Karen Spring highlighted the main points of the day. " Expert witness David Alexander Amador presented data extracted from Douglas Bustillo and David Castillo's phones and outlines conversations between both men about an aborted mission and not having sufficient logistics in the weeks leading up to Berta's murder, amongst other conversations. There were also two photos extracted - one of Berta and another of her house (the site of the murder). Both were extracted from Bustillo's phone (see below). Castillo's defense complained that the messages were being taken out of context An expert in cellphone data extraction answered procedural questions about an extracted voice message dated March 31, 2016 discussing a plan to carry out a murder. COPINH publicly denounces that this evidence is linked to a case in which DPI agent Juan Carlos Cruz (who will testify later in the trial) is accused of falsifying evidence attempting to change the course of the Berta Cáceres murder investigation. This line of investigation was at the time not pursued by investigators but is being presented by the defense as part of it's strategy in this trial.

Trial was suspended at 10:37 pm and will continue tomorrow at 9:00 am with David Alexander Amador, the same witness testifying about cell phone data extraction."

Last Saturday, Victor Fernández and Carmen Haydeé López, who represent COPINH and the victim's family, as well as Laura Zúñiga Cáceres held an online talk summarizing the first week of the trial.

Honduras Daily: Berta - Trial; Garífunas; Journalists - UK; JOH; COVID-19 - Health Sector, Vaccines; National Police; Migration - US; Elections; Corruption - Inprema; and an End to the JOH Pandemic?

On day nine of the trial against David Castillo, Karen Spring highlights the following: " Data extraction expert David Alexander Amador reads Whatsapp chat messages written by and extracted from Daniel Atala's cell phone. Atala makes several racist and classist remarks against the Lenca indigenous people and the Rio Blanco community. The messages outline how Castillo's defense attorney (and DESA's lawyer) Juan Sanchez, along with others, at the direction of and reporting to Daniel Atala, used their influence to criminalize Berta Cáceres in 2013 (see messages below). Tomorrow, expert David Alexander Amador will continue testifying. The trial was suspended at 7:20 pm and will begin again tomorrow at 10 am."

Yesterday, social movements inaugurated the Campamento Feminista ¡Viva Berta! in front of the

Supreme Court to accompany the trial.

Honduras Daily: Berta - Trial; Social Movements; IMF; Iota - BCIE; COVID-19 - Health Sector, Congress; Coffee; Armed Forces; Corruption - Inprema; Elections – Reforms;

The trial against David Castillo continued yesterday after a questionable suspension the day before. As always, Karen Spring highlights the main points of the day. "After a suspicious suspension of the trial yesterday, COPINH, the Honduras Solidarity Network (HSN) and others, raised concern of a possible attempt to shut down or influence the trial at a critical moment, specifically during the examination of data extracted from a cell phone found in DESA's office and belonging to Daniel Atala. Although still unclear why the suspension occurred, the proceedings began today at 11:20 am.

More Whatsapp and text messages involving Daniel Atala, David Castillo, Jose Eduardo Atala, Carolina Castillo, and Maria Fernanda Rivera, were read in court. The messages illustrated a few themes: Racism; Daniel Atala's hatred of Berta Cáceres and COPINH; the Atala Zablah family using their influence with Ministers, judges, mayors, prosecutors, government officials from the Secretary of Natural Resources and the Environment (SERNA), former President Porfirio Lobo, amongst others, to provide security and support for the Agua Zarca project, prosecute Berta and others, as well as take action against the resistance in Rio Blanco. The messages also illustrate how bribes were paid to government officials and food was purchased for police guarding the dam site. COPINH published some of the chat transcripts (see below).

A USB memory containing data extracted from Sergio Rodriguez's cellphone was found to contain much less data (37 gbs) than what the data extraction expert noted on his written analysis (51.8 gbs) suggesting evidence manipulation or a major administrative error. The defense argues that the evidence be thrown out - claiming that prosecutors key expert witness Brenda Barahona, who still has not testified, is responsible for this "criminal act" - and the private accusers and prosecutors insist that an investigation occur. Apparently the prosecutors knew of the missing data beforehand. After a lengthy debate, the judges rule that the evidence will be examined as it had already been admitted by the court."

Padre Melo commented on the importance of the trial. "Punishing David Castillo will open a door against impunity."

Also yesterday, the Expert Mission accompanying the Berta Cáceres Cause met with CONADEH "to address follow-up strategies to ensure risk prevention and protection of human rights defenders acting as parties to the proceedings in the Case".

The problems at Inprema, the teachers' pension fund, continues. "In a meeting of deputies of the National Congress, several issues were discussed, among them a Decree which benefits the teachers' colleges, regarding the debts they have with the Instituto Nacional de Previsión del Magisterio (INPREMA). The proposal presented by Nationalist Deputy David Chávez, caused controversy, because the amnesty benefits the teachers' colleges, but not the teachers who for years have saved for their retirement. Karen Spring highlighted the following: "An examination of data extracted from Sergio Rodriguez's cell phone included several messages sent to the "Security PHAZ [Agua Zarca hydroelectric project]" Whatsapp chat group and others. The chats read in court today demonstrate the level of monitoring, intelligence gathering and actions related to security strategy and promotion, conducted by DESA's executives - Daniel Atala, Jose Eduardo Atala [Daniel Atala's father], and Pedro Atala - David Castillo, Sergio Rodriguez, paid informants, DESA's employees, and police and military in Rio Blanco. The discussions inside these chats include: Details about Berta and other COPINH leaders' whereabouts and activities in Rio Blanco and other parts of the country; divisions within the communities; visits by foreign delegations; media strategies; positions of different individuals in Rio Blanco about the project, etc. The group chats also discuss requesting and receiving security and support from the National Police including several police commissioners and the Minister of Security.

The trial was suspended at 10 pm and will continue on Monday, May 10 at 8:30 am. The same data extraction expert will continue reading messages extracted from Sergio Rodriguez's phone." COPINH denounces that the opposing lawyer Sánchez Cantillano continues to attack and criminalize Lenca communities and COPINH.

The Cáceres family attorneys requested chats that discussed: (see chats published below by COPINH)

how Pedro Atala, using his connections, and was told by Julian Pacheco, the Minister of Security, that Berta's murder was a "lio de faldas" (a passionate crime);

How DESA's executives, David Castillo and DESA's employees discussed communication strategies after Berta's murder to hide and downplay DESA's involvement in the crime

How police guaranteed exclusive information about the murder investigation to DESA's executives.

On request from the Castillo's defense, the data extraction expert read several messages from the same data extraction that discussed:

Projects carried out by DESA such as fixing the road and the soccer field in communities close to the dam site and meetings held with elected community councils (in La Estancia and Santa Fe)

Security concerns around the project including: An armed criminal gang, safety concerns by community residents; and possible vandalism and attacks by COPINH members

Monitoring and communication after the murder: Media reporting about the news of the murder including about how the principal suspect (Aureliano Molina) had been detained and that COPINH members were allegedly involved in the murder; and statements by COPINH's allies in the press about the murder.

The investigation, including that ATIC agents were destroying legal documents [it's unclear where this occurred];

The urgency of communicating with the international banks supporting the project after the murder occurred, including a phone call with the FMO, FinnFund and BCIE bank representatives on March 16, 2016.

In order to keep the trial moving forward, documents presented as evidence by the prosecutors, the private accusers, and the defense were examined and read by the court. The trial was suspended at 5:30 pm and will begin again tomorrow at 9 am."

"After ratifying documents presented as evidence, Castillo's defense asked the court secretary to read approximately 2.5 to 3 hours of chat messages between David Castillo and Berta Cáceres. The chats were extracted from Berta's phone found at the scene of the crime. The first messages were dated June 27, 2013 and the last in late February 2015, just days before Berta was killed. The chats discussed the following topics: Most were pleasantries (good morning, Merry Christmas, have a safe trip, how are you, I appreciate your friendship, etc.); about health issues including those of Castillo's and Berta's mother; discussions about automobile agencies and car rentals, discussing places and times to meet, and David commenting about information he received about Berta's whereabouts or activities in Rio Blanco and Tegucigalpa. The defense hopes to use these messages to argue that Castillo and Berta were friends. While the Cáceres family attorneys - who also asked that the messages be read - argue that they demonstrate how Castillo kept tabs on Berta, monitored her activities, and hoped to gain her trust. Below are some of these chats published by COPINH".

The International Forum for Human Rights in Honduras published a press release on the case. Meanwhile outside of the court, the Feminist Camp Viva Berta had been established some days ago. Yesterday, the police intimidated the defenders taking part. OACNUDH called on the State of Honduras to respect and guarantee the integrity of the defenders and their right a peaceful protest.

The JOH regime signed an agreement with the BCIE to finance the purchase of vaccines doses for \$2.8 million.

The Secretary of Health unconvincingly claims that by October, 81% of Hondurans will be vaccinated. So far, only 248'600 vaccine doses have arrived in Honduras (and out of this, only 6000 were purchased by the JOH regime, the rest was donated).

The COVID-19 Observatory at Unitec believes that it will take Honduras eight years to immunize its people.

After arguments were heard, the judges ruled that the visual presentation will be allowed but that the defense has the right to review it before it is examined in court. Honduras Daily: Berta - Trial; Cholera; COVID-19 - Vaccines; Elections - ID; Electricity;

After two very short days in court, Day 17 of the trial against David Castillo went on a bit longer again. Karen Spring highlights the main points of the day. "The prosecutor's expert witness Brenda Barahona began an over 400 page presentation and analysis of telecommunications (phone calls and texts) of and between the seven men convicted for involvement in Berta's murder, David Castillo, Daniel Atala, and other unidentified numbers. Through cell phone tower localization data, Barahona traced the physical locations of each person over different periods of time (24 hours before/after Berta's murder, 2015, 2016, etc) and related each to the physical locations of the other suspicious individuals. This data was presented without conclusions (so far).

The data is similar to what was presented in the previous trial against the seven convicted men but included more telecommunication and localization data about David Castillo and possibly Daniel Atala. The following was revealed:

In the 24 hours period 12:00 am on March 2, 2016 to 12:59 pm on March 3, 2016, the phone number used by David Castillo called Douglas Bustillo, Sergio Rodriguez, Jorge Avila (DESA's head of security), and Daniel Atala. Castillo exchanged four text messages from Bustillo and sent one. According to phone towers, Castillo was in Tegucigalpa around this time frame  
In the same 24 hour period, Daniel Atala communicated with David Castillo and Jorge Avila and according to phone towers, was located in Tegucigalpa.

The data seems to show that communication increased amongst the criminal group - between some more than others (for example between the lead hitman Henry Hernandez and Douglas Bustillo; and amongst some the hitman) - in the 24 hour period around the time of the murder and around February 5 and 6, 2016. Douglas Bustillo's telecommunications data seems to be the key of linking Castillo with the communication between Bustillo and the group of hitman."

Even though the JOH regime proudly claimed that 40'000 Sputnik V vaccine doses arrived in Honduras (see yesterday), the news is not as good as it seems. "The batch of 40 thousand Russian Sputnik V vaccines that arrived on Friday in Honduras, will be kept refrigerated until the second component arrives and inoculate the same number of people, reported Saturday the head of the Expanded Program of Immunization (PAI), Ida Berenice Molina. (...) In this sense, she explained that the batch of 40 thousand doses of Sputnik V that arrived yesterday to the country is of component one; this vaccine has two components, one is in the first application and component two is the one that is applied with an interval of 21 days. "We are waiting for component two to start with the inoculation and ensure that second dose in the time interval, we need to have both components," she argued."

To divert attention away from this, health minister Alba Consuelo Flores promised to sign a purchase agreement with Pfizer for 4.4 million vaccine doses.

The trial against David Castillo continued on Sunday and will take a break today. Karen Spring highlights the main point of Day 19.

"A series of conversations between Mariano Díaz Chávez, Henrry Hernandez and Douglas Bustillo were read and played in court. The conversations followed a specific timeline starting on January 4, 2016. The conversations outline discussions about planning and meeting to discuss the murder, finding the gatilleros (hitman), how much the hitman and Henrry charge to do the job, the need to do the job quickly, Mariano only wanting to help coordinate, the "higher ups" cancelling the plan, among other details.

The conversations also discussed a failed attempt to murder Berta Cáceres on February 5, 2016."

External indebtedness as the main axis of financing. 5. Reconstruction measures of an economic nature and disregard for political and social issues.

"The Center for the Study of Democracy (CESPAD), measured the degree of party loyalty, the intention to vote for the presidential candidates at this moment, as well as the weight of support of segments by age, sex (between men and women), in urban and rural areas. For this purpose, a short national opinion poll was conducted between April 26 and May 7, with a margin of error of 2.88 and a sample of 1,888 surveys." At this moment, the National Party would win with 14.9% of the votes for Tito Asfura before 11.7% for Xiomara Castro. But 51.1% still don't know who to vote for or did not answer.

The CNE informed about the official procedure to hold surveys linked to the election. "[P]olls are prohibited to pollsters, as well as surveys in social networks and websites, to those who do not have the proper authorization."

Honduras Daily: Berta - Trial; OFRANEH - SUNLA; Corruption - US, Open Chest, Pandora; COVID-19 - Vaccines, Journalists; Elections - Reforms; Prisons; and Machismo Kills

After a one-day break, the trial against David Castillo continued. Karen Spring has the highlights of the day. "Expert telecommunication witness, Brenda Barahona presents a timeline of chats and conversations between Daniel Atala, David Castillo, Douglas Bustillo, Mariano Díaz, and Henry Hernandez and less frequently mentioned actors including Jacobo Atala, Jorge Avila, and others. The timeline begins to paint a bigger picture of the coordination between all of the actors in the lead up to the failed murder attempt in February 2016 and Berta's murder in March.

Using chat messages and telephone location data, Barahona provides several observations and explanations of the relationship between Berta Cáceres and David Castillo. Some include: Castillo and Cáceres met in person on at least 4 occasions between January 10, 2015 and November 2, 2015.

Observation: "When Berta Isabel Cáceres Flores proposed meeting with David Castillo, which was not planned or not in his interests, David Castillo would be unavailable meet, claiming he was outside of Tegucigalpa and in other occasions, was ill."

Observation: "Roberto David Castillo made Berta Cáceres believe that despite their different points of view and interests, he appreciated her. This is disputed because when she tried to reason with him (defend her convictions), many times he ignored her and did not respond to her messages. Later he would write back because he hoped to obtain information about her and her activities"

Observation: "Various messages sent by David Castillo, emphasized his friendship with Berta. One can perceive his subtle form of complaining about Berta in situations like: motivating people to protest against the PHAZ [Agua Zarca hydroelectric project]; not paying attention while busy with her environmental activities or family; coordination and COPINH's accompaniment in "the Indignados marches", using this as a means to obtain information from Berta and about her own movements."

Observation: "In February 2016, Berta Cáceres showed disappointment and annoyance with David

Castillo. She began to doubt the friendship that existed between them.””

This caused a storm of international criticism of the human rights situation in the Central American country. When it became clear that DESA employees were involved in the murder, FMO withdrew from the Agua Zarca project."

Yesterday, Day 22 of the David Castillo trial took place. Karen Spring highlighted the main points of the day. "Accompanied by a technical consultant, Castillo's attorneys began questioning expert Brenda Barahona about her telecommunication analysis. They focused on calling into question the following claims: that Castillo's SIM card was used in 26 different devices; that Berta Cáceres's phone listed the last activation date as January 16, 2016 but messages and calls came into and out of the phone according to the data, up until March 2016; that Mariano Diaz went to La Ceiba in January 2016 to allegedly plan the murder but received phone calls discussing another job that could explain his presence in La Ceiba; amongst others. The defense also listed one phone number (8929-5274) that made contact with Elvin Rápalo and Edilson Duarte Meza (both convicted of the murder) on March 2 and 3, 2016 and asked why the number was not identified as suspicious and thus investigated. The defense appears to be calling the expert's work into question but it is yet to be seen how the questions relate directly to their client David Castillo." he trial will continue throughout the weekend.

The David Castillo trial saw an important day in court with Daniel Atala Midence on the stand, even though just for a short moment. "Daniel Atala Midence first appeared on zoom to testify but after objections from the prosecutors, was told by the court he had to appear in person. Once he took the stand in person, Atala Midence informed the court that he was making use of his constitutional right not to testify, arguing that he is under investigation. After the prosecutors confirmed that this is indeed correct and after several protests by the private accusers, Atala will not be required by the court to testify.

Convicted murderer and DESA's former head of security, Douglas Bustillo testified that he informed David Castillo about COPINH and Berta Cáceres's actions related to the project. Former DESA employee, Hector García Mejía described the divisions and conflicts in the Rio Blanco sector as a result of the project's arrival to the area."

Lawyer Edy Tábara still sees Atala's appearance as a great success. "[I]t is already a great political, legal and social achievement that Daniel A. invokes that he cannot "testify against himself" and that the @MP\_Honduras recognizes that he is under investigation."

And the real problem is that after three years in possession of proof against him, the MP has not presented an accusation.

Day 27 of the trial against David Castillo took place yesterday. Karen Spring has the main points of the day. " Witness Indyra María Mendoza Aguilar from the organization Cattrachas was called by the attorneys representing the Cáceres family to testify. As someone who monitored and reported to the InterAmerican Commission on Human Rights about threats against and security incidents experienced Berta Cáceres, Mendoza provided a comprehensive overview of these concerns

including meeting David Castillo, being told by Berta not to trust him, and testifying that DESA played a large role in Berta's difficult security situation in and post-2013.

The defense proposes controversial Honduran teacher Edgardo Rodríguez, as a technical consultant to question expert witness Gladys Tzul who began presenting her analysis: "Situation and Condition of Violence Experienced by Indigenous Women and Women Human Rights Defenders: The case of Berta Cáceres and the defense of the Gualcarque river"

Expert witness Tzul uses sociological theories and various chat messages presented as evidence in the case to describe gender-based violence that occurred between Castillo and Cáceres; and Castillo and DESA's mechanisms of control over Berta as an indigenous, female, human rights defender, among others. Tzul also discussed the complex means in which control over women's bodies and subjugation are necessary in order to achieve control over communal territories."

(...) This fact generated the reaction of jurist, writer and international expert on gender and human rights in Latin America Alda Facio Montejano, who published an extensive message on Facebook. "I just found out that the Judiciary of Honduras accepted as "gender expert Mr. Edgardo Rodriguez proposed by the defense of David Castillo! This is the last straw. This gentleman is not a gender expert, on the contrary, he is a macho man accused multiple times of harassment and violence against women," reads part of the message."
