The JOH regime receives even more money from the IMF. "The decisions increase total Fund support to about US\$531 million. This immediately releases US\$233 million, more than a fivefold increase in the amount originally approved by the Executive Board."

El Libertador raised the alarm writing that there is a plan to assassinate its director Jhonny José Lagos Henríquez. "The information was released Tuesday, June 2, by a source linked to the high police and military spheres of the Central American nation, who explained to journalist Lagos

Henriquez that he should "take strict measures", because he has been followed and monitored for some time now. "The people who are on the target list [black list], are tagged with a security code and two months ago his code was activated [green light, as it is known in criminal jargon] and since then you are being followed up ...," the source said, indicating that the crime against the journalist has been ordered."

There have been several cases of deported migrants from the US to Honduras, but also EL Salvador and Guatemala who tested positive for COVID-19. The Miami Herald reports on the failed response by the Trump administration to this. "The Department of Homeland Security is only testing a

sample of the detainees it is removing from the United States and using a 15-minute rapid test to determine if they have the coronavirus. The response by DHS to a Miami Herald inquiry comes as immigration advocates continue to call for an end to deportations amid surging COVID-19 infections in Latin America and the Caribbean and as the U.S. Food and Drug Administration warns about the accuracy of the test being used, called the Abbott ID NOW. Earlier this month, the FDA cautioned that early data “suggests potential inaccurate results from using the Abbott ID NOW point-of-care test to diagnose COVID-19. Specifically, the test may return false negative results.” Made by Abbott Laboratories, the test, promoted by the Trump administration, is said to provide inaccurate results that could have patients falsely believing they are not infected with the coronavirus.”

There are many reasons to criticize the new Penal Code, one of them is the fact that it reduces penalties for sexual crimes. "[T]he reduction of penalties for sexual crimes is not in keeping with the high levels of violence faced by women and ignores that it represents an offense against human dignity, as stated in the Inter-American Convention on the Prevention, Punishment and Eradication of Violence against Women. If the National Congress wanted to demonstrate its commitment to eradicating violence against women, it should establish penalties appropriate to the seriousness of the crimes. For the time being, the new Penal Code shows that such a commitment does not exist."

Javier Suazo critically reflects on IMF loans for the JOH regime (for the newest one see yesterday) and fiscal responsibility. "Within that framework, the IMF quickly approved \$143 million for Honduras to deal with the pandemic, and decided to increase the credit to \$530 million. In this regard, a new agreement with this organization is urgently needed, together with contributions from economic and social actors, and an evaluation of the scope of the Fiscal Responsibility Law in order to propose reforms to it or its repeal. The concern is that this straitjacket will remain in place after the pandemic without considering the ceilings required for public investment spending, and the incremental and sustainable amounts in the health and education budgets, as well as the incorporation of the CNA and independent social auditing for greater control of corruption and transparency in the management of state resources. Honduras cannot continue to apply economic adjustment policies when there is an absence of technical criteria for allocating resources and a clear manifestation of the population's rejection of social programs that use these resources for political-electoral purposes."

The director of the Hospital Escuela, Osmín Tovar, warned yesterday of a possible collapse of the hospital he directs.

WHO representative Piedad Huerta announced yesterday that Honduras will confront the corona pandemic with three new treatments as part of a study.

Suyapa Figueroa, president of the Honduran Medical Association, is critical about the wonder treatments MAÍZ and Catracho touted by the JOH regime. She links their promotion with a will to open up the economy (see below). "The idea that there is a magic medicine they want to use for the opening of the shops so that the population doesn't worry because Maíz exists and that Maíz can be distributed in an indiscriminate way in the whole population and that if you have at your hand these medicines don't worry."

JOH's plan to open up the economy continues to be met by criticism. "Speaking to Radio Progreso, the President of the Honduran Medical Association, Dr. Suyapa Figueroa, said that it is a serious mistake to open up the economy, because the real situation of the pandemic in Honduras is unknown because there is a considerable deficit of tests to detect Covid-19. Figueroa lamented the fact that businessmen insist on returning "to normal" when there are not even beds available in hospitals for patients with the virus. For his part, Dr. Héctor Bonilla of Social Security in San Pedro Sula, said that Honduras is not prepared to open its economy because cases are on the rise and the trend indicates that the number of positive patients will not drop in the coming weeks. The same opinion is held by the President of the Chamber of Commerce of the city of Yoro, Dr. Guadalupe Almendarez, who was interviewed by Radio Progreso and said that it is a mistake to open the economy even in his municipality Yoro."

The Organization of the Tolupan People (OPT) and the Board of the La Candelaria Tribe denounce

that "[o]n May 28, 2020, eight agents of the Investigative Police Directorate (DPI) and four of the Preventive Police arbitrarily detained José Luis Mejía and José Ricardo Bermúdez, both members of our indigenous tribe La Candelaria, one of the 31 tribes that make up the Tolupán people in Honduras". Both men are members of MADJ.

In a second case, MADJ denounces a recent attack against the Camp pf Dignity for Water and Life in Pajuiles (the third link to an article from last month offers more information on the situation there).

Lastly, MADJ denounces that the municipality of Yoro continues to disobey a court order which called for compensation for damages caused to the San Francisco Locomapa tribe.

Among those tested positive is the head of epidemiology at the Health Secretariat.

Another medical institution warns of its imminent collapse. "The president of the association of doctors of the National Cardiopulmonary Institute, Suyapa Sosa, warned this Wednesday that they are on the verge of collapse due to the lack of beds to care for patients with coronavirus, while denouncing that the Executive and Sinager have not fulfilled their promises."

The Honduran College of Microbiologists and Clinical Chemists warned that they would not report to their jobs if biosecurity measures are not guaranteed for them.

There is more criticism against the Maíz and Catracho treatment (see also yesterday).

Especially media outlets close to the JOH regime tout them as wonder drugs. When a reporter from TSiHonduras asked a doctor about them, she did not get the, positive, answer, she expected and the doctor was just cut off.

There are at least 150 auxiliary nurses in Honduras who tested positive for COVID-19. This is not surprise. "The employees of the Hospital Integrado in Tela, Atlántida, have denounced on Radio Progreso that they have to make their own nylon gowns and wash the masks to reuse them to protect themselves from Covid-19, in view of the abandonment by government authorities."

This week, it was made public that the JOH regime is thinking about reforming the extradition bill, most certainly to benefit themselves (see Thursday's e-mail). Lawyer Omar Menjivar reflects on the importance of this bill in Honduras. "In an independent and sovereign republic, with a justice system that is moderately close to the standards of the rule of law, the extradition of its nationals to another state for trial is inadmissible. However, when the rule of law has been dismantled and the institutions that make up all the links in the justice system have been placed under a single, vertical command against which there are serious and proven allegations of links to drug trafficking and in the planning, execution, direction and direct benefit of gigantic acts of public corruption, albeit with shame, we must recognize that extradition represents the only hope for justice so that the country's main drug traffickers are punished. This is clear to those who run the country, and particularly to those who hold the presidency of the Republic, since they are the main accused in U.S. courts as CC4, the head of drug trafficking in Honduras. That's why they identify extradition as their main threat, and although CC4 has always promoted himself as the promoter of the reform of Article 102 of the constitution, which allowed for extradition (which was actually an imposition by the United States, which the government of Pepe Lobo was unable to resist), now he will do whatever is necessary to inoculate it as a threat that unsettles it. (...) However, to ensure the effectiveness of the plan, man needs to remain in power, directly or through a figurehead, and to that end, I have no doubt that he will do what is necessary, including avoiding general elections, under any pretense. For him, for CC4, it is vital to remain in power."

This demand was made again yesterday by a group of national and international human rights organizations from the area of freedom of expression. "The concerns of this group of organizations lie in the inclusion of crimes against honor such as slander and libel in the criminal sphere and the provisions related to criminal responsibility for crimes committed during the exercise of the right to demonstrate that could lead to the infringement of rights such as freedom of expression, access to information, association, among others."

The Forum of Women in Political Parties reported also submitted a draft decree to reform the new Penal Code with regard to the articles containing crimes against women.

The CNA published its fourth study on the new Penal Code.

CIPRODEH presented a proposal for reforming the new Penal Code to make it compliant with the right to free assembly.

El Heraldo and ConfidencialHN published an eye witness report by a doctor on the collapsing Honduran medical system. "Heartbreaking and distressing is the audio of an internist leading the battle against covid-19 in Honduras, who for almost six minutes recounts the shortcomings she has witnessed in her shifts. (...) Listening to her words it is difficult not to cry with her in the face of the impotence experienced by the health personnel of the various hospitals authorized to treat

coronavirus patients." These are the words chosen by El Heraldo, a newspaper outlet known to be close to the JOH regime.

The director of the University Hospital, Osmin Tovar, was dismissed from his post. Tovar had reported a lack of supplies and biosecurity equipment for the doctors and nurses at the hospital. He further denounced that they had not received any resources from the funds earmarked for the coronavirus pandemic.

The emergency chief of the Honduran Institute of Social Security (IHSS), César Henríquez, warns: "[W]e are at 90 or 95 percent in the emergency unit to attend only Covid19 patients, there are many people who are admitted. We're swamped."

According to official figures, 350 doctors and 163 nurses had been infected with the corona virus by the end of May.

The head of COPECO claims that there is still capacity at Honduran hospitals. According to him, only 439 out of the 848 hospital beds are occupied. At the same time, Sinager reported in its daily update on the corona virus (see above) that 665 people are hospitalized for COVID-19 alone.

The JOH regime also claims that they have distributed over 4 million masks. Even if this were true, it is still less than one mask per every two Hondurans. Not wearing one will be fined with 120 Lempiras, which many human rights organizations have called "criminalization of poverty".

CESPAD continues to investigate the role of the MP under its Attorney General in fighting corruption or the lack thereof. "A few weeks ago, the Center for the Study of Democracy (CESPAD), maintained that two issues force us to stop and reflect on the Public Ministry. The first one is related to the lack of interest that this institution is showing to act on the allegations of corruption in the context of the Covid 19 pandemic. The second issue is related to the irrelevance that the Public Prosecutor's Office is acquiring in the face of the actions of the National Congress to protect people with power who are involved in corruption cases[1]. How much does the Attorney General's commitment to power groups weigh so that he does not fulfill his functions, what happened to the fight against crime and corruption announced in January 2020, and what happened to the conspiracies and conspirators that the Public Prosecutor's Office would face? It is important that we reflect and debate these questions in Honduran society."

For the second consecutive day, Honduras tested more than 1000 people, 1129 yesterday. As with previous increases in tests, the amount of positive cases increased accordingly. 425 new cases were detected yesterday for a total of 7360. 19 more people died, as far as I remember the highest daily increase so far, and this three days after the start of the "intelligent" reopening of the economy. So far, 290 people died to COVID-19 in Honduras.

Among the newest cases is also the president of the Supreme Court and close ally of JOH, Rolando Argueta.

Another journalist, Ariela Cáceres, got infected.

The director of the Virology Laboratory, Engels Banegas Medina, resigned from his post. Officially due to personal reasons, but his resignation raises questions. El Tiempo reports that there are rumors that Engels had to resign from his position due to threats received.

Banegas previously complained that the laboratory survived thanks to the support of external aid in the absence of a state budget. According to reports from doctors, the laboratory has reached the limit of its capacity to quickly deliver tests during Covid-19, so much so that it is estimated that there are at least 3,000 undelivered tests for the treatment of patients.

The president of the College of Microbiologists, Marco Moncada, later talked of over four thousand tests that have not been analyzed.

El Pulso published a great article on Honduras' health system, how it is organized and how it was lacking already pre-corona. And how corruption has further harmed it before and even more during the crisis.

FOSDEH continues to emphasize the role of corruption during the pandemic. "Ismael Zepeda, an economist with the Social Forum on Foreign Debt (Fosdeh), said it is regrettable that there is no accountability for the more than 100 billion lempiras approved by the legislature to combat the new coronavirus.(...) He regretted that the crisis in the health system continues to deepen, while recalling the existence of reported cases of corruption regarding the acquisition of medical machinery and supplies."

Casa Alianza, meanwhile, reassures the public that there wouldn't be any children living on the streets in Honduras without the corrupt JOH regime.

The National Anti-Corruption Council (CNA) published its fourth report on corruption during the corona crisis. The report focuses on the purchase by INVEST-H of 740 lung ventilators for \$23 million of which only 20 have arrived in the country and the rest may follow in December. They payed 880% of the purchase price in advance.

But corruption during the pandemic is much more widespread. Padre Melo tweeted: "With Social Security there was talk of seven billion looted over several years. In three months of the pandemic, 100 billion has been approved. How much has been spent on the emergency? Where's all that money? Is there any overseer to tell us? What about the MP? What about us?"

"The two cousins, Otto and Ronald Salguero, turned themselves in to US authorities and are set to appear before a court in the Southern District of New York (SDNY), according to a report by Univisión. Last December, the US Justice Department charged the two men with being part of a drug trafficking ring in Honduras and Guatemala led by Tony Hernández, the brother of current Honduras President Juan Orlando Hernández. "These

defendants conspired with the corrupt Honduran officials they bribed to facilitate the importation into the US of large quantities of cocaine for the Sinaloa Cartel," wrote US Attorney Geoffrey Berman in the indictment. A witness in the case against Tony Hernández told US prosecutors that the Salguero cousins were present at a meeting where Joaquín Guzmán Loera, alias "El Chapo" and the former leader of Mexico's Sinaloa Cartel, gave Hernández \$1 million to finance the presidential campaign of his brother Juan Orlando in 2013."

The discussion about JOH's state of health has reached the international level. "When health officials in Honduras announced this week that President Juan Orlando Hernández had been hospitalized after testing positive for the coronavirus, there were the expected outpourings of support. But skepticism — voiced by the president's political opponents as well as ordinary Hondurans — quickly followed, with some questioning whether Hernández was sick at all. Memes circulated online, including a widely shared cartoon showing Hernández in a hospital bed being coached on how to look ill. Erick Benjamins, a 26-year-old barber in the northern department of Santa Barbara, said he thinks the president is lying to divert attention from his controversial handling of the coronavirus as well as a sweeping U.S. drug trafficking investigation that has implicated Hernández and several members of his family. (...) the fact that such theories have gained so much traction underscores just how deeply divided this small Central American nation has become — and just how much legitimacy Hernández has lost. (...) Tirza Flores Lanza, an appeals court judge who has clashed with Hernández in the past, said she doesn't know whether the president has the coronavirus, and doesn't really care. But she was worried about what the rampant conspiracies said about the state of things in Honduras. "People here are utterly distrustful," she said. "We don't believe absolutely anything, especially not what comes from the government."'"

Even the president of the College of Journalists of Honduras (CPH), Dagoberto Rodríguez, questions the veracity of JOH's claims. The CPH is rather close to corporate media outlets and not known to be very critical of the JOH regime.

At the same time, a doctor at the Military Hospital informed that JOH is stable and does not need to be intubated.

"An analysis of publications in the Official Gazette, recordings, videos and minutes of the plenary sessions of the National Congress, related to the discussion and approval of the new Penal Code, shows that some deputies, in addition to violating parliamentary procedure, incurred in crimes defined in the Criminal Code as forgery of public documents and abuse of authority. Article 214 of the Constitution of the Republic stipulates that bills must be voted on after three debates on different days, except in cases of urgency, which must be approved by a simple majority of the deputies present. The new Penal Code, without taking into account its unquestionable importance and long duration, was voted on in an irresponsible and hasty manner, in a single debate and without having justified the case of emergency as required by the Constitution of the Republic. The two extensions of the *vacatio legis* of the new Penal Code that the National Congress had to approve, among other reasons, because of the lack of socialization and preparation of the necessary personnel for its application in the Judiciary, prove that the vote should have been carried out in three debates."

"The assassination of Antonio Bernardez underlines the delicate situation in the area, which for decades has been subject to acts of violence as part of the strategy of dispossession of the Garifuna territory (...) The Punta Piedra case was presented to the Inter-American human rights system in 2003 and by 2015 the Inter-American Court issued a ruling in favor of the community, which has been ignored by the state."

Later, Miriam Miranda denounced: "Forensic medicine informs us that they won't pick up body of our comrade Antonio Bernardez".

US prosecutor Geoffrey S. Berman seemed to have lost his battle against Trump (see also yesterday) and as the later fired him. On the upside, Trump was not able to force through his appointee; for the time being, Berman will be replaced by his deputy. Hopefully, this also helps the cases made against Honduran drug traffickers, among them JOH's brother Tony Hernández.

InSight Crime also wonders what the ousting of Berman means for drug trafficking cases. "Berman spearheaded the prosecution of Honduran President Juan Orlando Hernández's brother, Juan Antonio "Tony" Hernández, who was ultimately convicted of drug trafficking in October 2019.

Since then, however, Tony Hernández's sentencing has been postponed five times and is now scheduled to take place in September, more than a year after his conviction, raising questions as to how the shakeup in New York might impact those proceedings. In addition, prosecutors with the Southern District of New York have repeatedly called President Hernández a co-conspirator in his brother's drug trafficking ring, even implicating him in providing protection to a drug lab producing hundreds of kilograms of cocaine per month along a stretch of the country's Caribbean coast.

Prosecutors have also accused a number of Honduran officials with links to the president of drug trafficking, most recently former police chief Juan Carlos Bonilla Valladares, also known as "El Tigre." (...) The circle of accusations around President Hernández has generated suspicion that he could be indicted, though that is unlikely, given that the United States does not usually indict sitting or former heads of state."

The CNA published its fifth report on corruption during the corona pandemic focusing on the purchase of the mobile hospital. There have been previous articles and investigations into this, but this new report caused widespread reactions even in corporate medial outlets. The sum in question is over \$47 million for the purchase of 7 mobile hospitals.

They highlight various irregularities committed by Invest-H, from a lack of planing up to suspicious purchase conditions.

The Turkish company SDI Global LLC, which fabricates mobile hospitals, denounced that their name and business registry was misused to sell mobile hospitals to Invest-H.

The MP announced to investigate the authenticity of the documents.

Congress cited the head of Invest-H, Marco Bográn, for questioning.

Opposition politicians asked for his resignation.

He continues to claim that everything is alright and two mobile hospitals are on their way to Honduras.

All of this led even ASJ to abandon ship and leave the social auditing body of Invest-H investments.

Honduras Daily: Penal Code - FoE;; JOH - Drug Trafficking, Fake News; US; LGBTIQ+; COVID-19 - Health Sector, Corruption, HR, Prisons, Labor Rights; and an Unpaid Debt

The new Penal Code was supposed to come into force today, but then something interesting happened. Opposition politicians from Libre, Pinu and the Liberal Party called for an extraordinary session to stop the Penal Code based on article 191 of the Honduran constitution.

They installed their own board with a president, vice-presidents and two secretaries. The 70 congresswo/men present voted all for the abrogation of the new Penal Code.

According to an analysis by the Coalition against Impunity, this extraordinary session was legal and constitutional.

They also received support from the Commerce and Industry Chamber of Cortés (CCIC).

In the evening, there were reports of a militarized center of Tegucigalpa near Congress.

The pro-JOH side of Congress did not recognize the session and its results.

Nevertheless, the National Party later announced that they are in favor of prolonging once again the vacatio legis, i.e. the time until the Penal Code comes into force.

Last but not least, the Association of Public Prosecutors also spoke out against the new Penal Code, i.e. that it should not come into force in the current form.

This implies the United States would share intelligence, likely including radar tracking of possible drug flights, with a foreign government headed by an unindicted co-conspirator in a drug trafficking case under investigation by the U.S. Attorney for the Southern District of New York."

Honduras Daily: Penal Code - Journalists; COVID-19 - Health Sector, Corruption, US; Corruption - IMF, IHSS; BCIE; Lawyers; and Collective Gardening

After the extraordinary session by the political opposition on Wednesday (see yesterday and the first link below), there was a lot of uncertainty about the fate of the new Penal Code. Even though the National Party late in the evening spoke out in favor of another prolongation of the vacation legis, the Nationalist president of Congress, Mauricio Oliva, now says that the Penal Code has come into force.

Opposition lawmakers, meanwhile, have been officially accused by the legal service of Congress for abuse of authority and other alleged crimes.

El Heraldo published some of the statements of the accused politicians. "To act against opposition deputies, the Public Prosecutor's Office is open at 11:51 PM."

Still not giving up, the National Anti-Corruption Council (CNA) presented a constitutional complaint at the Supreme Court.

Yesterday evening, the presidential advisor Ebal Díaz tweeted: "In the next few hours, the

Executive Branch will send a formal communication to the National Congress asking for the complete repeal of the new Penal Code or, if necessary, for profound reforms that will be shared with all sectors".

Díaz also announced that the executive would analyze the certification of the derogation of the Penal Code by the political opposition.

Maybe taking its cue from the JOH regime, La Prensa, meanwhile, published several critical articles of the Penal Code, e.g. on deepening corruption or limiting freedom of expression. As most corporate medial outlets, La Prensa has not been very vocal before against the Penal Code. Something must have changed.

"One issue that has been ignored or poorly addressed by IMF officials who make up the missions responsible for assessing the performance of countries' economies and the results obtained from the implementation of economic stabilization and institutional reform policies is corruption. The underlying thesis is that achievements in economic stabilization, structural change and state reform may be accompanied by more corruption, either because of the appearance of businesses that provide services to the state with non-transparent contracting processes led by corrupt officials, or because development projects are executed with external funds, without any guarantee that the resources allocated will be handled with clean hands. (...) The IMF has a representative in Honduras, and they should report on allegations of corruption with funds allocated to the Covid-19 pandemic, and support the efforts of those civil society institutions that like the CNA have been struggling to report and combat acts of corruption by public officials, and not just applaud the actions of institutions like the TSC that have been questioned and politicized. We have insisted on several occasions that the applause for governments' achievements in fulfilling objectives and goals of economic stabilization and state reform are contaminated when the actions carried out are accompanied by acts of corruption, where the corrupt and the corrupt protect each other. For the time being, the IMF must pronounce itself against the enforcement of the Criminal Code, which by protecting the corrupt more, will permanently contaminate the government's achievements in economic stabilization, or put pressure on the government and legislature so that this legal aberration does not come into effect."

The executive has now officially requested that Congress derogate the new Penal Code which came into force on Thursday.

The Nationalist vice-president of Congress, Mario Pérez, said that this is not possible, the code can only be reformed.

Sociologist Pablo Carías considered the actions by the JOH regime "a strategy to confuse the Honduran population in these moments of pandemic".

The son of former president Pepe Lobo, Nationalist congressman Jorge Lobo, agrees calling it a "smoke screen".

If JOH were serious about derogating the Penal Code, why did he not veto its coming into force? ConfidencialHN sees in it a strategy to divert attention away from the most recent corruption cases.

Today is the 11th anniversary of the coup d'état in Honduras, not a one-time event, but a continuous process met with community-organized counter-coups. "Eleven years of incessant coup d'état have also been years of rebellion by Honduran communities organized in defense of their territory and natural wealth, their culture and their dignity. (...) These eleven years have also seen the rise of organizations and movements in defense of human rights, and especially the leadership of human rights defenders, who have been threatened and stigmatized most harshly by those who have deepened the dynamics of the coup d'état. (...) These eleven years have also seen the emergence of alternative communication, both at the individual level and in networks, especially community radio stations, but also digital productions, in a creative combination of traditional media and social networks. (...) These eleven years have been of migrants and of the awareness that society has taken about the defense of the rights of migrant workers, increased by the growing discrimination and racism that sustains the approval of the anti-immigrant legislation promoted by the policies of the governments of the United States, first and foremost with Barak Obama, and continued with greater scorn by the government of Donald Trump. "Neither coup d'état nor coup d'état for women", has been the symbolic expression of the irruption and strength of the feminist struggles against the patriarchal culture. (...) In these eleven years the Central and Latin American focus of our struggles has grown. This approach is the result of the awareness that our problems and conflicts do not originate only in our countries, and that many of the springs and actors that energize our problems are found outside our borders. This awareness leads to the need to articulate networks and commitments from Central and Latin American solidarity. Let new signs continue to burst forth, sowing the seeds that will now and forever drown out all the ignominious signs of the coup d'état."

The Secretary of Health recognized that the health systems in San Pedro Sula and the capital are unable to respond to the "flood of suspected coronavirus patients".

At the same time, the president of the National Association of Nurses and Auxiliary Nurses of Honduras (ANEEAH), Josué Orellana, announced the closure of several health centers, due to the spread of the coronavirus among health personnel.

The emergency chief of the Honduran Institute of Social Security (IHSS), Cesar Henríquez, also warns about the current situation in Honduras. "Henríquez said that the data currently being handled does not respond to reality at the same time he revealed that there have been no swabs for two weeks so patients are being treated without a true result if they are carriers of the virus."

The 160 mechanical ventilators bought in response to the crisis will finally be distributed.
