The police officer Jarol Rolando Perdomo Sarmiento will face trial for the murder of nursing student Keyla Martínez inside a police station.

OACNUDH has observed the hearing. "In view of the imminent resolution that will resolve the order to open the case to trial, we urge the judicial authorities to incorporate a gender perspective in their analysis, in line with Honduras' obligations regarding the right of women to live free of violence."

Importantly, he is being accused of "aggravated femicide". Previously, the court tried accuse him only for homicide. COFADEH had successfully challenged this.

In the same case, students who had protested after the murder of Keyla and were criminalized as a consequence have now seen the charges dropped against them.

With the re-start of the hearing in the Gualcarque Fraud case, COPINH demanded that all 16 initially accused will be invited to court. According to COPINH, only this would be legal as the Appeals Court clearly said that a re-start is needed nullifying every decision where COPINH had not been previously included in the process.

As expected, the Honduran Judicial System has a different understanding and started without all 16 people on the bench. COPINH filled a complaint.

The hearing was then suspended until late in the evening when the court decided to reject the complaint by COPINH.

The MP arrested the former captain of the Armed Forces Santos Rodríguez Orellana together with his wife and his mother-in-law on drug trafficking charges.

They also conducted several raids of houses and businesses linked to the arrest.

He was an outspoke critique of JOH and had raised concern about corruption in the Armed Forces and their link to drug trafficking. He himself was discharged from the Armed Forces in 2014 after their unit had seized a helicopter linked to JOH's convicted drug trafficking brother Tony Hernández.

In 2014, he was one of the first to link Tony to drug trafficking.

He is also running as a presidential candidate in this year's general elections, so there are voices denouncing his arrest as political persecution.

According to the, problematic, Electoral Law, Santos can still run as a candidate; the law only prohibits this if they is a sentence, a circumstance benefiting a lot of candidates accused of corruption, among the the Nationalist presidential candidate Nasry Asfura who faces several corruption charges.

OACNUDH published an important press release regarding the recent changes to several laws in order to further criminalize protest and the work of civil society in general (see previous e-mails).

"The Office in Honduras of the United Nations High Commissioner for Human Rights (OHCHR) expresses its deep concern over the entry into force of the reforms to the Criminal Code, the Code of Criminal Procedure and the Special Anti-Money Laundering Law, which contravene the human rights obligations of the Honduran State, restrict civic space and limit the capacity to conduct effective investigations in corruption cases. (...) The urgency and lack of transparency in the approval of these reforms prevented a citizen debate representative of the diversity of the country and the groups and communities affected by them. The fact that the reforms to the Penal Code extend the application of the crime of usurpation to public spaces, seriously aggravate its penalties and turn it into a crime of continuous flagrancy would result in illegitimate restrictions to the right to participate in public affairs, freedom of association, freedom of peaceful assembly, freedom of expression and the right to defend human rights. (...) For their part, the reforms to the Code of

Criminal Procedure enable preventive and immediate evictions without judicial control. (...) "We are concerned that the entry into force of these reforms will aggravate the situation of conflict over access to land, particularly for peasant groups and indigenous peoples. Both our Office and international human rights mechanisms have recommended that Honduras address the structural causes of conflicts over land and territories and avoid the use of criminal law as a response to this conflict," added the Representative. "The work of civil society organizations that carry out social audits and denounce corruption, and in general, of all those that defend human rights, is fundamental for the promotion and guarantee of human rights, the development of the country and the full functioning of the rule of law," said the Representative. Furthermore, OHCHR notes with concern the negative impact of these reforms on the investigative capacities of the Public Prosecutor's Office in corruption cases. The reforms related to bank secrecy and the functions of the Financial Intelligence Unit (FIU) in the Special Law on Money Laundering restrict access to financial information needed in the investigation of corruption and organized crime cases."

Tim Rieser, an aide to Senator Patrick Leahy who has worked for decades on foreign policy, recalled that Hernández visited Washington and invited him to meet at the Willard InterContinental, a Beaux-Arts hotel near the White House. "He told me how much he loved human rights—he actually used the term 'love,' " Rieser said. "J.O.H. is a polished politician. He calls you by your first name and tells people in Washington what they want to hear. With me, it was about human rights. With others, it's about capturing drug traffickers." (...) Cresencio Arcos, a former U.S. Ambassador to Honduras, described the transactional nature of American officials' relationship with the government there: "The most important thing to our people is their access to the élites. It's not important whether they've committed human-rights abuses, or even if they're drug traffickers. J.O.H. is an evil scoundrel, and he outsmarted us because he figured out that by supporting us on drug interdiction and migrants he could blackmail us into going along with him." n January, 2021, a few days after Kamala Harris was sworn in as Vice-President, she was briefed about the allegations against President Hernández. An official who was present said that Harris, a former prosecutor, had an immediate response: "Let's go get him now." (A White House official said that the Vice-President's team has never heard her say anything like this.) The attendees informed Harris that the U.S. government had a long-standing unwritten policy against indicting sitting heads of state though the official added that he personally would like to "cut him off at the knees." A senior Biden official told me that the Administration intended to work around Hernández, by engaging with other levels of the Honduran government, and would avoid sending officials to visit while he remained in office. Much of this awkward work will fall to Ricardo Zúniga, the newly appointed special envoy for the Northern Triangle—as Honduras, Guatemala, and El Salvador are called. On several trips this year, Zúniga has refrained from stopping in Honduras. Instead, he has held Zoom meetings with leaders in civic society and in the private sector. (...) Roberta Jacobson, who worked for decades as a U.S. diplomat specializing in Latin America, called the Northern Triangle "a poisoned chalice." Harris and Zúniga need reliable partners, but the United States' willingness to encourage despots has left the region largely in the hands of corrupt autocrats. As Jacobson said, "Who is there to trust?""

Therefore, experts predict that without an Electoral Procedural Law in the 2021 election process, history will simply repeat itself."

Sources involved in the work of the Maccih confirmed to Contracorriente that there were suspicions about Hall's work, one of them (who we cannot identify in order to protect them) assured that thanks to her links within the mission, Hall had the capacity to direct which cases were selected, and if in the beginning small cases were selected, it was partly her responsibility. (...) "She was very insistent on continuing with the small cases, and as she was supposedly the expert on the situation in Honduras we trusted her point of view, but when we began to realize that there were other cases that really had substance we asked ourselves why this behavior was happening. We began to do searches and we realized that she has a certain family relationship with Roberto Michelletti Bain, the coup leader in 2009, and finally it was established that her links with the government were extremely strong", the anonymous source assures Contracorriente".

Hall, meanwhile, questioned about her recent position not to allow the inscription of the candidate by the opposition alliance in San Pedro Sula (see last week), says that she is not being pressured by anyone.

"Even though from our view this may not look like the most sophisticated thing, somebody, somewhere, some group took the time to plan this and to coordinate this. The actors are very determined to make this type of influence.""

These are funds that were taken with the argument of providing aid to the most vulnerable sectors, but that, being issued in the context of an election campaign, generates suspicion. Citizens are asking themselves: is this money linked to the electoral competition and what role do international lending institutions play in this context? The loans were justified under the category of "emergencies" due to the Covid19 pandemic, and to tropical storms Eta and Iota, and were approved by a National Congress made up, in great majority, by deputies of the National Party, which has been in government for 12 years. There are five loans: two granted by the Central American Bank for Economic Integration (CABEI), two by the Inter-American Development Bank (IDB), and one by the World Bank (WB). These loans, in addition to indebting the country, call into question the use of this money, a few weeks before the 2021 general elections are to be held in this Central American Country."

In the past, there was an active market for the credentials of the members of the polling stations, i.e. the National Party bought them from all the minor parties to control the count of the votes. This time, the CNE announced that the political parties should give them the complete name of their representatives so not to give out blank credentials. But so far, only Libre and the National Party have done so.

According to Libre magistrate Rixi Moncada, they hope to counteract this by making the vote count public prohibiting to close down the polling stations.

As the great majority of candidates have not presented a report on their financial situation (see previous e-mail), the commissioner of the Clean Politics Unit (UPL), Javier Franco, warned that they would face a penalty of at least 50 minimum salaries.

The problems with the accreditations resurfaced (see also vesterday). "An army of more than 182 thousand people will be in charge next November 28 of operating the Voting Boards (JRV), the electoral bodies responsible for the scrutiny and transmission of results of the general elections. Formerly known as Electoral Receiving Tables (MER), the JRVs are the gateway to the exercise of suffrage but also to fraud, a constant concern in the electoral process taking place in Honduras. Hence, the new Electoral Law, approved last May, included a series of provisions, among them the implementation of an Electoral Results Transmission System (TREP) and the use of fingerprint readers. The new legislation also included reforms related to the integration of the JRVs, considered as the main weakness within the electoral system. One of them mandates political parties, fourteen in this electoral process, to deliver to the CNE a list with the names of their representatives in the JRVs, with the purpose of putting an end to the delivery of blank credentials that allowed the trafficking of these accreditations. The mandate is that "credentials were not going to be handed out, but that the list was going to appear in the electoral suitcase and there at the moment of integrating the table the identification (of the representatives of the political parties) was going to be with the identity cards", explained to Expediente Público the former president of the extinct Supreme Electoral Tribunal (TSE) and one of the drafters of the new Electoral Law, Augusto Aguilar. For Aguilar "there is some irregularity" in the fact that credentials will now be handed out, despite the fact that article 251 of the Electoral Law, related to the accreditation of the JRV members, states that they must present themselves at the voting center with their National Identification Document (DNI)."

COHEP is concerned that the staff at the polling stations won't be equipped to handle the equipment.

The legal representative of the cement company explained that the accusation is that Rosenthal transferred funds from Cementos del Norte to other companies in 2015, while he was president of the Board of Directors of the cement company."

In the case of Nasry Asfura, it goes even further. " The Network of Pastors and Evangelical Leaders of Honduras (REPLIEH), the Lucas Foundation for Health and the Latin American Theological Fellowship of Honduras (FTL-Honduras), representing an independent evangelical sector, point out that the Evangelical Confraternity has acted with abuse of authority by signing an agreement with the presidential candidate of the National Party, Nasry Asfura. In a public letter sent to the Evangelical Confraternity they point out that the agreement covers issues such as abortion, family and geopolitical issues that have become topics of manipulation by the party campaign agendas before the elections of November 28."

In this equation, the State must recover its stabilizing role, not as a distributor of 7 thousand pesos in elections. Scoundrels! (...) We see each other on the 28th, we meet on the 28th, we continue together on the 28th and we meet immediately afterwards to continue. The struggle is permanent. The people always win, united never defeated."

The difference between the census that served as the basis for the 2017 and 2021 elections is almost 700 thousand voters. "That could open a big door to the next electoral fraud," he said."

Another important corruption case, Pandora, is about to be completely undermined as its key witness, Fernando Josué Suárez Ramírez, apparently left the protected witness program by the MP. "For his part, defense attorney Omar Menjívar responded that he had just been notified by prosecutor Luis Javier Santos of his client's determination. "It could be that they have applied what they call "escape law", or that he really escaped knowing that he could be killed", reacted the legal professional. Menjívar pointed out that the Public Prosecutor's Office refused to grant a benefit to his client after he collaborated with the State Prosecutor's Office, exposing himself to risks. "It is a strange situation, because in the first place Fernando Suarez never had that intention, at least that he let us know or we would have allowed him to have such an intention", he declared. Suarez's lawyer asserted that two situations could have occurred: the first one is that the "Fugitive Law" will be applied to him because he handled very sensitive information. Menjívar condemned that the State prosecutor did not want to use the information provided by Luis Suárez and did not grant him any benefit such as the reduction of the sentence and the removal of his relatives from the criminal process. He confirmed that his client spent around three years under the custody of the Public Prosecutor's Office in the witness protection unit."

In the meantime, he heads the nation's electoral fraud machine that will try to install his successor. Dana Frank, a former professor of history at the University of California, Santa Cruz, and a leading expert on Honduras, told me, "The U.S. created a monster, and now they don't know what to do with him. They've lost control of their own monster." Further complicating the U.S. response, Honduras hosts a major American military base at Soto Cano, where between 500 and 1,500 American service personnel are stationed." (...) Frank said, "What I fear is that once again mainstream U.S. media reports will describe 'clashes after a disputed election'-when the truth should be 'Hernández's security forces opened fire on peaceful pro-democracy demonstrators." Frank predicted that the State Department will hope for "a plausible enough result" that the U.S. can try to sell internationally. She called American policy since the 2009 coup "sickening and heartbreaking," and asked, "Why are the Honduran people not allowed to have democracy and free and fair elections?" If the State Department does try to endorse a fraud, however, it might run into big trouble from an unusual quarter. The U.S. Attorney's Office for the Southern District of New York, which put Hernández's brother in prison for life, is so far regarded by everyone who follows Honduras as incorruptible. Until now, the U.S. Attorney's Office has observed the unwritten

American policy not to indict a sitting president. But Hernández leaves office in late January. If he's charged, will he be extradited? Will Honduran courts, which are packed with his allies, agree to let him be put on a plane and flown to stand trial in the U.S.? Or, if he remains the de facto ruler of Honduras, how many more Hondurans will flee north, having lost all hope in their country's future?"

Meanwhile, Assistant Secretary for Western Hemisphere Affairs, Brian A. Nichols, continues his visit to Honduras where he met yesterday with the CNE as well as the Minister of Security and the Head of the Armed Forces.

"UN High Commissioner for Human Rights Michelle Bachelet on Tuesday expressed her deep concern about political violence in Honduras, which has already claimed 29 lives, and called on the authorities to ensure an environment conducive to holding peaceful, transparent and genuine elections. Since primary elections were called in September 2020, the UN Human Rights Office in Honduras has recorded 63 cases of political violence, including 29 killings, 14 attacks, 12 instances of aggressive behaviour, as well as seven people directly threatened and one kidnapped. Some political figures have also widely used hate speech as a political tool, including against people defending women's sexual and reproductive rights, leading in some cases to discrimination and violence. "Hate speech has no place in a democracy," the High Commissioner stressed. The UN Human Rights Chief called for prompt, thorough, impartial and effective investigations into all acts of political violence, with a view to holding those responsible accountable. Bachelet also raised her concerns regarding shrinking civic space in the country, with members of civil society and human rights defenders regularly harassed, persecuted and attacked. So far this year, the Office in Honduras has recorded 240 attacks against human rights defenders and journalists. (...) The UN Human Rights Chief stressed the importance of all those involved in the electoral process adopting measures to avoid a repeat of the events in 2017, when serious human rights violations were committed in the context of post-election protests."

UN Resident Coordinator in Honduras, Alice H. Shackelford tweeted: "A solo 6 días, un fuerte apoyo por elecciones libres, justa, transparente y pacíficas en Honduras! Por un voto informado, sin intimidación y violencia!No dejar a nadie atrás!"

have to overcome her own baggage from the past. She first became a household name in 2005 when her husband, Manuel "Mel" Zelaya, won the presidency for the center-right Liberal party. After he took office, Zelaya shifted to the left and allied himself with governments that had come to power as part of Latin America's "pink tide" – including Venezuela's late socialist leader Hugo Chávez. Such associations prompted the country's conservative political and economic elite to oust Zelaya in a 2009 military-backed coup. In the ensuing political crisis, Castro led the largest protest movement in the nation's recent history. "She did it bravely, with talent, she never let her speeches be guided by feelings or emotions, she was always very rational," said Edmundo Orellana, who served in Zelaya's cabinet. "From then on, Honduras identified her as a political figure with her own personality. Very different from Mel's political personality," he added."

The OAS observation mission has a central role to play in this regard and we hope it will engage closely with civil society groups across the political spectrum, urge patience among the population in waiting for the election results, continue to condemn acts of violence, and work with credible voices to mitigate tensions."

(...) Over the past four years, emigration from Honduras has far surpassed any previous presidential term in the country's history. A migration model compiled by the Strauss Center at the University of Texas at Austin estimates that around 450,000 Hondurans permanently left for Mexico or the United States during that period. Tens of thousands more emigrated to other parts of the world, including Spain. Studies on diaspora voting and the political preferences of emigrants suggest that such a mass exodus could produce an electoral disadvantage for the Honduran opposition. "From the migrants' perspective, typically there is an anti-official tendency, anti-incumbent tendency from the period of migration, so if people are leaving the country, they will often times blame the incumbent party, at least implicitly, for the conditions under which they left," said Michael Paarlberg, an associate professor at VCU who studies diaspora politics. Although Hondurans have enjoyed the legal right to vote abroad since 2001, access is more limited than at any time since. Honduran emigrants – 99 percent of whom will not be able to vote – are estimated to favor the opposition by as much as a two to one margin."

"Audios are circulating in which neighbors in Nicaragua bordering the department of Choluteca are given instructions to vote for the National Party and are offered money in exchange for voting for the National Party. For its part, the Network of Human Rights Defenders of the South (REDEHSUR), denounces that several buses with Nicaraguans have entered the country, obtaining cloned identity cards."

"Several people who are on duty this weekend have denounced that their employers have informed them that they will not be allowed to go to vote tomorrow, Sunday, November 28. (...) Therefore, employees of private companies, such as the maquila sector, denounce that they will not be able to go to vote, which is a human right contemplated in the Constitution of the Republic, in Article 40 numeral 3."

His vote wasn't decided because of a candidate he likes or the party's proposals, but rather because of a promise that he'd receive a direct-cash transfer, called a bonus, in December if he votes for the ruling National Party – and they win. "Otherwise, I wouldn't even vote," he said. Across the country, National Party politicians and activists have feverishly been doling out cash and promises of future payments totaling well over a hundred million dollars in what critics say is a desperate attempt to swing the election in its favor. (...) Four years after a disputed election that was decided by roughly 50,000 votes, hundreds of thousands of households have been targeted by the campaign in the three months leading up to the November 28 vote. (...) To obtain the bonuses in Ojojona, residents must fill out an application that is then delivered to National Party activists. Univision obtained one of the applications and the political implications are clear. People are asked questions that include how many votes are in their household, what their designated voting center is, whether or not they have obtained the new identity card needed to vote in this election, and perhaps most telling of all, what they think of the party's mayoral candidate Aguilar."

Honduras Daily: Elections - Results, Election Day, National Party, Journalists, Polls, Observation; Corruption – Asfura;

Hondurans went in higher numbers (participation is currently estimated at 68.35%) than feared to the polls yesterday. A change is in the air. But some words of caution are also warranted. As in 2017, the opposition has a lead in the presidential race and we all know what happened back then. So, the international community has to stay vigilant. But unlike 2017, the lead of opposition candidate Xiomara Castro is significantly higher. At the time of writing (01:05am local time), with 46.5% of votes counted, she leads with 53.55% over Nasry Asfura's 33.87%. Close attention to the further development is additionally needed because the congressional races are especially important this time around, as the new Congress will elect both the new Attorney General as well as new Supreme Court judges. Last but not least, lets not forget that the current Congress in a meeting without the attendance of the opposition, prolonged the current session to January (instead of ending at the end of October), which means that in the case of an opposition win, the old Congress could try to undermine the new government with new laws.

Promises by the Armed Forces that they had distributed the electoral equipment to all polling stations turned out to be false as voting was supposed to start yesterday morning. There were various reports by electoral observers that equipment was missing and voting delayed, up to several hours.

Some observers denounced not being granted access to the voting centers.

Additionally, the website of the census, where Hondurans were meant to see where to vote, was down for various hours yesterday. The CNE later claimed in a press release that their website had suffered an attack.

There were also innumerable reports of further vote-buying by the National Party.

At around 12pm, something new happened, the National Party held a press conference more or less declaring itself the winner hours before any official vote count even started.

The head of the EU observation mission expressed concern about this.

According to the Libre magistrate at the CNE, some 60'000 people tried to vote a second time.

In the evening, there were still long lines before various polling stations. According to the Electoral Law, the CNE should prolong the time for voting. While Libre magistrate Rixi Moncada asked centers to attend to people in voting line, her Nationalist counterpart Kevin Aguirre publicly said to close centers at 5 pm.

Elections - Results, Xiomara, Int. Coverage, Cities, Congress, CNE, Journalists, Observation; COVID-19; and a Historic Election

After being constantly updated, the CNE site has remained the same since 6:55am yesterday. At first sight, this may lead to fear a repeat of 2017, but this time, Xiomara's lead is not 5 points as Nasralla's was in 2017, but 20 points. Additionally, she also leads in the departments of Lempira, La Paz and Intibucá, infamous for turning the 2017 elections.

She has been recognized as the winner by the Liberal Party, whose front runner Yani Rosenthal conceded to her, as well as the business lobby COHEP.

The corporate press in Honduras also recognized her victory, El Heraldo writes about a "irreversible and resounding triumph".

The National Party has not officially recognized its defeat but one of their principal strategists did just that.

Libre magistrate at the CNE, Rixi Moncada, later explained "that the results page has not stopped the counting of votes but only stopped transmitting the preliminary results because the final scrutiny phase has already begun, once the figures are confirmed the portal will be reactivated. In a press release, the highest electoral body informed that tomorrow the scrutiny of the tally sheets that were not disclosed with the TREP system will begin, once the 54,879 documents are reviewed and validated, it will be disclosed in an uninterrupted manner".

The newest projections for Congress gives the opposition a majority. Apart from Libre and Saviour of Honduras Party (PSH), the Liberal Party is split between a wing having supported Yani Rosenthal and another supporting the opposition alliance. The later are estimated to have won at least 10 seats. Combined with between 52 and 55 for Libre and 12 to 15 for PSH, this makes at least 74 out of 128 seats. At the same time, it is important to stress that many important reforms will need an absolute majority.

Future vice-president Salvador Nasralla denounced "irregularities in the registration of votes at the level of deputies in several departments, and has called on candidates to be alert and observers to pronounce themselves on the situation".

CNE's Rixi Moncada rejects the accusations.
