"Members of the Expert Observation Mission in the Berta Cáceres Case express their deep concern about the delay of justice in the case of the renowned Lenca leader Berta Cáceres in Honduras. A ruling declaring the criminal responsibility of Roberto David Castillo Mejia as co-perpetrator of the murder was issued on July 5, but the First Chamber of the Sentencing Court has not yet issued the sentence, further delaying the rights of the victims - including her family, the Civic Council of Popular and Indigenous Organizations of Honduras (COPINH) and Honduran society - to truth, justice and reparation."

Meanwhile in Valencia, a garden has been inaugurated in honor of Berta.

The proposed reforms to the Amnesty Law seems no less controversial than the initial law because it opens up the possibility for monetary compensation. The stated aim of the reform is to have a clear definition of political crimes and political persecution. "On his side, lawyer Edy Tábora, who is also a human rights defender, said that the spirit of the amnesty is based on a constitutional mechanism to put an end to many processes used to criminalize people who fought for democracy. However, he pointed out that the decree has two axes: the first one has not been objected because it solves the criminal situation of social fighters, but there is another axis that includes crimes related to public administration. Tábora recommended the judges to verify if the crimes of the amnesty applicants are contemplated in the political facts."

The start of the Americas Summit brought about a lot of announcements by the US government.

"Vice President Kamala Harris today announced more than \$1.9 billion in new private sector commitments to create economic opportunity in northern Central America, more than doubling the value of initial private sector investments in response to her Call to Action."

"Today, Vice President Kamala Harris announced the Central American Service Corps (CASC). The CASC initiative was developed by public, private, and philanthropic partners in response to the Vice President's Call to Action for northern Central America. CASC—a \$50 million initiative, which will be administered by the U.S. Agency for International Development (USAID)—will provide young people in El Salvador, Guatemala, and Honduras with paid community service opportunities, mentorship, and a path to future employment."

"U.S. Department of State, U.S. Agency for International Development (USAID), and the Partnership for Central America (PCA), come together to announce programs supporting women's economic empowerment in northern Central America and the broader Western Hemisphere".

These announcements were critically accompanied, among others by US representatives Chuy García, Jan Schakowsky and Delia Ramirez. "The U.S. must acknowledge its role in the root causes of migration from Central America & be honest about the role our foreign policy has played in destabilizing the region. I joined Rep. @JanSchakowsky & @RepDeliaRamirez to advocate for anti-imperialist foreign policy."

Honduras Now also reacted: "\$1.9 billion in US aid to "northern triangle" countries, announced U.S. VP Kamala Harris. This means more US-funded NGOs promoting & pushing the state department line in the name of "civil society" like @asjhn1 has done since the coup".

As victims of this crime, we, her family, members of Copinh and the Lenca people will continue demanding justice from the Honduran state." (...) During last year's 49-day trial, Daniel Atala Midence, Desa's financial manager, was summoned to give evidence due to his role in running operations with Castillo – which included authorising payments to informants used to monitor Cáceres. But Atala Midence was excused at the last minute after state prosecutors revealed that he was under investigation for the murder. No further information has been released but upon sentencing Castillo, the court ordered that the case files be kept under wraps as the investigation remains open."

The IACtHR called on the State of Honduras to continue investigating the murder of Honduras to bring to justice everyone behind the crime.

How much that is need was just made clear again by an important new article by Jared Olson. "A trove of Dutch and U.S. legal and financial documents shared with The Intercept reveal, for the first time, the flow of international funding in the days leading up to March 2, 2016, when a hit squad broke into Cáceres's house and killed her. The bank provided the documents to two Dutch human rights lawyers, Wout Albers and Ron Rosenhart Rodriguez, who have spent the past two years representing Cáceres's family and COPINH, the organization she co-founded, in a civil lawsuit that seeks to hold FMO accountable for its role in the Agua Zarca project. (The suit was first filed in the Netherlands in 2018; Albers and Rosenhart came on in 2020.) In at least four instances, according to the records, the bank released funding to a company affiliated with Castillo and Atala that did not match the stated payee, routing the money through an offshore account with Deutsche Bank in New York City. (...) It was Atala who directed the \$1.7 million payment to the concrete company Concretos del Caribe S.A., or CONCASA, though another firm was listed as the intended recipient, the documents reveal. Hours after the loan landed, Castillo, in WhatsApp communications released

by the Honduran public prosecutor and previously reported on by The Intercept, texted the head of the hit squad that payment was coming, because “the loan [we] requested is available.” It is not known whether Castillo was referring to the loan proceeds sent to CONCASA. Less than 48 hours later, Berta Cáceres was dead.”
