The perpetrators are State institutions and unknown persons, according to a survey conducted by UNHCR, UN Women, TROCAIRE and the National Commissioner for Human Rights (CONADEH), through five civil society organizations, according to a survey conducted by these agencies through the ProDefensoras Honduras project."

"Even today, when it no longer has the support of former President JOH, because he is in prison in New York, the current CSJ continues to be the bottleneck for the current administration to solve problems that require its assistance and, even worse, it has enough power to invalidate government initiatives. Finally, both the current CSJ

and the Public Prosecutor's Office, both elected during the narco-dictator's term of office, have served to perpetuate the state of impunity in which the Honduran justice system finds itself due to their ineffectiveness and partiality. (...) The new magistrates cannot repeat the shameful role played by their current counterparts. They must have not only a great professional capacity, given by great knowledge, experience and ability to perform, but also have a great ethical stature, love for their country, vocation of service and attitude to be transparent in all their actions. I am sure there are Honduran men and women who meet these requirements."

Honduras Daily: Corruption - CICIH, US; Tegucigalpa - Water; Supreme Court; and Children Taking Over Congress

COHEP joined the debate about the powers of an eventual CICIH. Their legal advisor Rafael Jerez stated that the MP must preserve the exercise of public criminal prosecution respecting the constitution. This aligns with recent statements by the Xiomara administration. Additionally, Jerez said that a CICIH must work as an "adhesive prosecutor" which would mean a reform to the new Penal Code, something that is already in the works.

Another obstacle for the CICIH is the legislative decree 116-2019, which needs to be repealed. "However, this controversial decree, which, among other things, allows deputies, municipal corporations, public and decentralized institutions, and NGOs to receive funds from the Executive Branch, violating the independence of powers and hindering the Public Prosecutor's Office to carry out requirements against these entities, has not been scheduled for repeal in the National Congress."

In pursuing these goals, the two sides could consider a consultative process for the appointment of high-level national and international staff, while agreeing that the commission would have the power to carry out independent probes. At the same time, they could curb the risk of excessive discretionary powers – either for international officials or national politicians – by establishing clear rules of case selection, grounded in the public harm caused by the crime in question."

"The celebrations were again characterized by the parades of people from the LGBTIQ+ community, who were booed and whistled at their entrance to the National Stadium "Chelato Uclés", in a clear demonstration of disrespect and intolerance by society."

Honduras Now linked to additional information by Sandra Cuffe about history of the CNA pertinent to the current Fonac-CNA-discussion (see last two days). "The CNA explicitly presents itself as a civil society group. "We're not the government." It's not quite that clear-cut. The CNA was created by a law (07-2005) that gives it access to officials & mandates working with the gov't to implement a national anti-corruption strategy. The CNA is run by representatives from 12 groups. The main organization of the country's business and economic elite is among them, as are top evangelical and catholic reps, and a mish-mash of workers' and other groups, some with a long history of working with the state. The Honduran Council of Private Enterprise (COHEP) is part of the CNA. COHEP is the leading private sector organization in the country. It has dozens of member groups representing every kind of interest: maquilas, private security, banks, media, mining, energy, you name it. The CNA is so full of powerful business and political interests that it's almost hard to think of an institution worse positioned to do any kind of impartial investigation into corruption networks in #Honduras. Treat any uncritical news about it with, well, a whole salt mine." This was from 2018. Honduras Now adds that the CNA started to be more critical of the JOH regime, but only very late and when several U.S.-funded media and organizations began turning against the dictatorship.

Yesterday we saw also a confrontation between the head of Fonac and former JOH ally Omar Rivera and Secretary of the President Rudolfo Pastor. "From Fonac you fulfilled a role in which you collaborated with the previous regime (...) you were collaborating with a regime that by then was authoritarian and corrupt, whose criminal links were already known and widespread. You were collaborating with a narco-dictatorship".

But as yesterday, it is worrisome to report that the CNA present itself as a victim of the new administration choosing historically-loaded words. CNA director Gabriela Castellanos speaks of a "planned coup d'état against the fight against corruption".
