Drug trafficker Juan Ramón Matta Waldurraga was extradited from Colombia to Honduras. He had been imprisoned for two years in the US for drug trafficking, then went to Colombia, where he was imprisoned again in 2019. In Honduras, he is accused of money laundering.

A judge sent his case to trial with the initial hearing taking place already next week.

Honduras Now reports on the judge assigned to the case. "Claudio Aguilar, the judge assigned to Ramón Matta's case is probably just as much or more of a criminal than Matta. Aguilar has several complaints filed against him (that the Attorney General doesn't move or investigate). Aguilar & his father were very pro-dictatorship".

CEPR reports on the contradictory role of the US when it comes to the ZEDEs in Honduras.

"Xiomara Castro, the president of Honduras, won a major victory for democracy earlier this year when Congress repealed the country's Zonas de Empleo y Desarrollo Económico law (ZEDE, or

“Economic Development and Employment Zones” in English). The legislation enabled the creation of special governance zones, which have “functional and administrative autonomy” from the national government. The zones allowed investors to create their own governance systems, regulations, and courts, providing room for experimentation with privatized government to create a “legal environment adequate … to be competitive at the international level.” This policy was highly controversial, earning the opposition of Honduran labor unions, campesinos, Indigenous organizations, and even the nation’s largest business groups. As described by the US State Department, the zones “were broadly unpopular, including with much of the private sector, and viewed as a vector for corruption.” When President Castro proposed abolishing the policy, the Honduran legislature repealed it unanimously. The Biden administration has argued that corruption is one of the largest barriers to development in Central America. The Biden administration’s “U.S. Strategy for Addressing the Root Causes of Migration in Central America” promises to “[p]rioritize an anticorruption agenda” But when this goal conflicts with others, like promoting US investment, which is more important? A recent report from the State Department criticizing President Castro for eliminating the ZEDE law suggests that private interests take priority over public transparency and accountability.”

The back and forth between Mel Zelaya and Salvador Nasralla took a turn to the worst. In an official interview, Mel declared that he considered the alliance between Nasralla's party PSH and Libre broken by Nasralla by his verbal attacks on president Xiomara.

Nasralla reacts by giving the last word to president Xiomara saying that she would have the final decision to break the alliance.

Similar words from PSH congresswoman Ligia Ramos.

President Xiomara has not reacted so far, but she retweeted the statement by her husband.

CESPAD published an analysis on the governance crisis. "The above elements, as a whole, have determined a fragile institutional framework to address urgent problems such as health, education and infrastructure. Even so, relevant demands of the majority of the electorate have been satisfactorily met, such as the repeal of the ZEDE Law. And some strategic problems have begun to be addressed, such as the process aimed at recovering the Electric Energy Company as a public company and public good, but progress has been slow. However, strategic issues such as agrarian, environmental, indigenous peoples' and women's reproductive rights are still not on the national agenda. And we are still awaiting effective advances in the installation of the CICIH ("international mechanism" against corruption), the repeal of the impunity pacts in the National Congress, the adhesion to the Escazú Agreement, and the approval of the Optional Protocol to the Convention on the Elimination of all forms of Discrimination against Women (CEDAW). In spite of all the above, this government continues to represent a great historical opportunity to promote the substantive reforms required by the country to face the serious problem of lack of development, poverty, inequalities and exclusions that affect the great majority of the population. A fact in favor is the high degree of legitimacy that President Castro still has (according to CID GALLUP, 65% positive approval in September). However, it is striking that while the right-wing opposition is regrouping to oppose substantive reforms or to hinder the government's management in general, the civic-democratic space for dialogue, agreement building and formulation of a new generation of public policies in favor of the interests of social organizations and civil society, which were the core of the resistance to the narco-dictatorship, continues to be closed from the government."

Media outlets seem anxious to have president Xiomara react to the statements made by her husband but she has officially still not pronounced herself. Nevertheless, Proceso Digital and others claim that her retweet makes the rupture official. Xiomara is currently in Rome to participate at the FAO and in the Vatican to meet the Pope.

Doris Gutiérrez, designated president for the alliance, representing Pinu-SD, also commented on the situation. She assured that the popular will must prevail because it is sacred. She further stressed that they were elected to govern and work on the problems of Honduras.

The PSH held its general assembly this weekend reelection Rafael Nasralla as its president.

"[Libre] Congressman Jari Dixon Herrera pointed out that although there is a rupture in the ruling party, he hopes that there will be consensus in the next bills. "A pity the rupture of the alliance with the comrades of the Salvador Party of Honduras (PSH), but one thing is theory and another thing is practice, now this does not mean that we cannot continue dialoguing and working on the issues that unite us", he expressed."

COFADEH's Bertha Oliva sees the current situation less rosy and speaks of a pre-coup d'état situation.

First, the whole process of building a civilian National Police began in the wrong way, because when the Organic Law of the National Police of 1998 was approved, it only proceeded to remove the Police from the structures of the Armed Forces (FFAA), changing their uniforms. However, there was no change in the police culture, which still continues to be, first of all, militarized. Secondly, there have been positive changes such as a new police curriculum, in the sense of raising the requirements for those who want to enter this

institution to change the curriculum through the police technical institute, which has a focus on community policing and respect for human rights. But the problem is that this is only the public curriculum, but evidently there is a hidden, secret curriculum, we could see it with the death of these aspiring police officers when they were subjected to cruel, inhuman and degrading treatment, practices that are not in any curriculum for police training, being part of the hidden impositions, in which they are taught to be practically soldiers in war and that the culture of militarization is maintained. In conjunction with the perspective detailed above, it must be taken into account that it is useless to change police education when these police officers, trained in a certain way, face a hierarchical, militarized, corrupt, uneducated institutionality, linked to organized crime."

CESPAD offers an important overview of the state of affairs regarding the ZEDEs. "The repeal of the law that kept the Employment and Economic Development Zones (ZEDE) project in force culminated a full cycle of information, advocacy and citizen mobilization. However, more than 5 months after its elimination, the demands of the companies that continue to position the issue and, currently, the voices of U.S. congressmen and officials, seek to legitimize a narrative and actions that go against the will of the people."

One important open question regarding the ZEDEs remains, will Honduras be brought to court for the repeal of the law. According to deputy foreign minister Gerardo Torres, this has so far not been the case but the threats are there.

CESPAD explains what the rupture of the Libre-PSH alliance could mean for the selection of the Supreme Court elections. "Facing the election of the CSJ, with the current fragmentation of forces and political polarization, the only way out is the dialogue and negotiation among all political parties present in the legislature, which allows to agree on quotas of representation in the highest court of justice, ensuring the inter-party construction of a qualified majority, avoiding the outbreak of a new institutional crisis. However, the big question that this raises is how in these circumstances it could be guaranteed that the election of a CSJ represents a change and/or substantive progress with respect to the current failed judiciary.

In this context, three points would be crucial to advance towards that necessary change:

The first, that the Nominating Board complies faithfully with the Special Law and that it selects in a transparent manner and based on merit, suitability and honesty, the list of candidates and candidates for magistrates.

Second, that the National Congress respect the results of the Nominating Board and that, based on the proposed candidates, the members of the highest court of justice be elected.

And, the third, that in the plenary of the legislature, the candidates who have reached the highest scores in the evaluation of the Nominating Board are elected.

Finally, beyond the election of the CSJ, if LIBRE (as a government) aspires to carry out and/or advance in the ambitious reforms proposed in the Bicentennial Program, it must necessarily advance towards the construction in the legislature of a simple inter-party majority with an agreed agenda, that is to say, dialogued, discussed and agreed upon by different political forces. This must be complemented with the effective opening of the civic-democratic space to ensure dialogue and the construction of agreements with the social movement and civil society. In this way, it will be possible to lay the firm foundations for the reconstruction and transformation of the limited and excluding Honduran democracy."

US ambassador Laura F. Dogu made headlines yesterday with, either badly- or rather well-chosen words. She criticized the Honduran government for creating a bad investment climate. By themselves, the comments could be just that, but given that this was a follow-up to a letter by two US Senators in support of the ZEDEs and in a week where the Xiomara administration has been under attack, even with threats of a coup lingering (see yesterday), people are alert.

Political leader Gilberto Rios does not mince words: "Here, let's not fool ourselves, we know who is behind the whole strategy [to question govt & Congress], it's Laura Dogu, the US Ambassador, who is the John Dimitri Negroponte 2.0 from the 80s, in order to try and maintain US hegemony in Central America."

Foreign Minister Enrique Reina reacted from Argentina, which he currently visits. "We are surprised because we believe that there are words expressed by the ambassador that concern us since we have had more than 30 meetings with the US authorities at all levels, we believe that the situation is complex because we have expressed the situation that the country is going through and President Castro is trying to make us competitive. It seems to us that the ambassador's statements complicate our relationship because they do not see clearly the situation of the country and we see that beyond defending their interests and their companies they must understand when we take measures that are to clean up and put right the rule of law".

Reina also announced to meet with the ambassador on Monday.

"The Secretary of the Presidency, Rodolfo Pastor, expressed that as government officials they have the responsibility to keep the compass and not be distracted by all those who want to destabilize the country. He reiterated "we cannot allow ourselves to be distracted by all those who want to destabilize the project", for which he asked the government team to have clarity on what the people entrusted them with."

However, for various sectors, the purpose of Decree 116-2019, is to shield or block criminal action to officials on the fraudulent management of public money."

"With this action, it intends to advance its investments in the region, despite not having assumed its responsibility and not having made reparations to the victims of the violence it financed. (...) In addition, the FMO bank, together with its partners BCIE (Central American Bank for Economic Integration) and FinnFund, committed serious financial crimes that allowed the diversion of a substantial part of its funds, which financed the acts of violence by David Castillo and the Atala Zablah family. Through this mechanism of diversion of funds, a payment of 1.2 million dollars was made directly to David Castillo 3 days before the assassination of Berta Cáceres."
