Libre congresswoman Xiomara Hortencia Zelaya presented a constitutional reform to support the installation of the CICIH.

CESPAD outlines the minimal conditions that are needed for the CICIH. "The first is the repeal of the impunity pacts, among them Decrees 116-2019, 57-2020 and 93-2021, with which "it is practically impossible to prosecute corrupt ex-officials and officials", said Irías. The second condition has to do with institutional adjustments within the Public Prosecutor's Office, "starting from the fact that this international mission comes to support this instance in charge of criminal action", continued the interviewee. And the third condition, which for Irías could be the most relevant, is that the Supreme Court of Justice to be elected on January 25, 2023, for the next seven years, has a legitimacy of origin, this means that the National Congress selects the suitable magistrates from among the candidates presented by the Nominating Board and that this entity, at the same time, makes a selection based on what is established by international standards."

These efforts appear to be aimed at undermining the new government and its policy agenda."

Zelaya Castro reacted to this on Twitter. "Being an adhesive complainant is a possibility not excluded with my proposal, but it does not give any independence to the CICIH, rather it subjects it

to the State Prosecutor's Office; on the other hand my proposal for Constitutional reform, does give total and absolute independence to the CICIH."

Honduras Daily: Garífunas; Ahuas Massacre; Judicial Power; Drug Trafficking; CABEI; and Fighting with Giants

In the early mornings of Monday, OFRANEH's Miriam Miranda warned about an imminent eviction of the Punta Gorda community, the first Garífuna community founded 225 years ago.

Shortly afterwards, the National Police started with the eviction.

The police detained six Garífuna, among them the local OFRANEH coordinator Melissa Martinez.

"In response, Ministry of Human Rights published a communique holding the courthouse in Roatan responsible for not fulfilling the human rights guarantees & minimal standards & asking that they be freed. Also calling on the police to follow human rights standards & avoid violence".

President Xiomara tweeted: "I have requested a report of the violent eviction ordered by the court. I was not informed prior to the eviction. The Garífuna are demanding justice for their ancestral lands. This should go to trial, not to an eviction that criminalizes rights. I demand immediate freedom and respect for human rights."

OACNUDH condemned the violence and the arrest of the six Garífuna.

Libre leader Gilberto Ríos said that they will this time around prevent a new corrupt and criminal Supreme Court.

Out of the over 180 candidates, 56 need to correct inconsistencies in the documentation they had presented.

The six Garífunas defenders from Punta Gorda, Roatán, were released with precautionary measures (see yesterday).

OACNUDH condemned their ongoing criminalization. The precautionary measures prohibit them from going back to their ancestral lands.

The Xiomara administration announced the creation of a commission to investigate how it came to the events in Punta Gorda.

On Monday, President Xiomara said she had not been informed about the planned eviction. Padre Melo reacts to this. "After accepting not having received information on the eviction of Garífunas in Punta Gorda, with all due respect, we suggest that the president assume the responsibility of making timely removals in order to have competent officials and effectively perform their duties."

Criterio published two important articles on the ongoing criminalization of indigenous peoples in Honduras and the lack of policies for the defense of ancestral territories.
