"Although it is outside the process of selection of magistrates, the appeal filed by lawyer Luis Miguel Lara Hernandez, keeps the residents of Tocoa uneasy. This is because Lara Hernandez was the private lawyer of the Emco Holding Group, in charge of criminalizing seven of the eight defenders of Guapinol, who remained in preventive detention for more than 900 days, most of which was under isolation from the outside world due to the covid pandemic. (...) The lawyer Luis Miguel Lara Hernandez is one of the list of applicants who failed the legal knowledge exam with a score of 74%, when he should have passed with 75%. Curiously, the lawyer linked to Inversiones Los Pinares and Grupo Emco Holding obtained his exequatur two months before the beginning of the application period."

Jeff Ernst reports for the Guardian on the hopes of women's rights organizations in Honduras for the Xiomara administration and their disappointments. ""I believe that at some point [Castro] will possibly fulfil some of the things, but the reality is that 20% of her term has already passed, and at least in terms of reproductive rights we do not see any substantive change in women's lives up to now." The Guardian spoke with 10 activists in Honduras, nearly all of whom expressed a similar sentiment. Their main grievance was the failure to fulfil a campaign promise to legalise emergency contraceptives without restrictions."

Radio Progreso continues to critically cover the plans by the Xiomara administration to fight extortion. "For public security analyst Mirna Flores, the "Integral Plan for the Treatment of Extortion and Related Crimes" is a reactive and hasty measure because, in addition to limiting freedoms, "it is stigmatizing poverty". Flores adds that extortion is not only a problem of gangs: "I find an infinity of actors that do not live in those neighborhoods, they live in the middle class sectors, on the other hand, those who are going to be invaded with military forces and National Police are the most vulnerable neighborhoods that should be attended with social policies"."

The Xiomara administration, meanwhile, announced a curfew (from 6pm onward) for 30 days starting on Tuesday in various parts of Honduras.

"The National Front of Popular Resistance, FNRP, denounced through a public statement this December 5, 2022, that the journalist and human rights defender Alba Lopez, suffered a criminal attempt on her life on December 3, 2022, and demands that the entities in charge conduct an investigation into the facts. López is a member of this space in the Central District and in the department of Francisco Morazán of the FNRP and was run over by an unknown vehicle that fled, and according to social networks she suffered blows to her face for which she had to undergo surgery at the Hospital Escuela of the capital, where she is still in the process of recovery."

"The Special Prosecutor's Office for the Protection of Ethnic Groups and Cultural Heritage (FEP-ETNIAS/PC) recently conducted an inspection in Cayos Cochinos to investigate alleged environmental damage. Specifically in the smaller cay, prosecutors and investigators accompanied by leaders of the indigenous peoples of Nueva Armenia and Sambo Creek, went to the cays to inspect the environmental damage that has allegedly been caused. The investigations are carried out as a result of a complaint filed by the Black Fraternal Organization of Honduras (OFRANEH) before this Special Prosecutor's Office, where they denounced that they observed smoke screens in

the vicinity of the smaller key. The archipelago called Cayos Cochinos was declared a Natural Marine Monument in 2013."

Today, the state of exception was implemented in 162 neighborhoods in Tegucigalpa and San Pedro Sula.

"Security Minister Ramón Antonio Sabillón argued that the state of emergency is aimed at suspending the rights of members of criminal groups, not those of honest people who are dedicated to working and doing good (...) He asked not to compare the measures taken by Honduras with what is currently happening in El Salvador, where President Nayib Bukele has declared "war" on the maras and gangs. "The objectives are similar, but there are some differences, especially because of the legal system there," he reinforced."

The Ministry of Security further claims that the residents of the affected neighborhoods will not require a safe-conduct for free circulation.

At the same time, there is also more reporting on how the state of exception is criminalizing poverty.

The fight against insecurity must involve dismantling the finances of criminal groups that pass through the national banks, as well as their links with landowners and power groups, as well as with the State security forces themselves."

"The phased approach to the implementation of this process obliges Honduran institutions to commit to a reform agenda. In the final Memorandum, the commitments are the following:

Reforms to the regulatory framework governing the crime of illicit enrichment and money laundering.

Abrogation of Decree 116-2019 that limits the functions of the Public Prosecutor's Office.

Amendments to the normative regulations of the National Banking and Insurance Commission, and others that allow the lifting of secrecy concerning the situation of money laundering and trusts.

The approval of the necessary instruments for the establishment of the figure of effective collaboration and those instruments that are necessary for the independent exercise of the public criminal action.

These reforms are key in the efforts to dismantle the model of macro corruption inherited from the previous regime, and the National Congress is the political center of gravity to ensure these actions, to the extent that these reforms are a responsibility of the legislative branch. This situation poses the enormous challenge for the governing party to deploy the maximum political talent to build the necessary correlations of forces to make this agenda of changes in the national legislation effective. (...) In the various instruments exchanged between the UN and the Castro administration, civil society organizations and social movements have been largely absent, as there has been no mention of their role in this process."

Regarding money laundering, there could be some progress soon. "The president commissioner of the National Banking and Insurance Commission (CNBS), Marcio Sierra, said Monday that money laundering occurs in all countries of the world, but that they are trying to combat it, that is why they are reviewing the reforms to the Money Laundering Law that "protects former officials who have fled the country"."
